Their Excellencies the Lords Justices in Council.

HEREAS it hath been represented to their Excellencies the Lords Justices at this Board, That Colin Campbell of Glenure, who had , been appointed by the Court of Exchequer in that Part of Great Britain called Scotland, to be the Factor or Steward upon the Estate of Charles Steuart of Ardshiell, lately attainted ; of High Treason, but fled from Justice beyond the Seas, having received Directions from the said Court, to remove all the Tenants belonging to the said Charles Steuart, (some of them his near Relations, and all of whom had been in the late Rebellion) from the Possessions they had obtained of him before the Attainder—The said Colin Campbell did, upon Thursday the 14th of this Instant May, proceed to execute the Decrees of the said Court, taking with him a Messenger, (being the proper Officer for that Service) as also a Nephew of his own, and his Servant; and in the Way as they passed through a Wood on the Farm of Lattermore, in Duror in Argyllshire, Part of the said forfeited Estate from which the Tenants were to be removed, the said Colin Campbell was, from behind a Bush, shot dead on the Spot.—And whereas it is highly necessary that the Person or Persons who committed or were concerned in the said cruel and detestable Murder, in Violation of the Peace, and Defiance of the Laws of this Realm, should be brought to speedy and exemplary Punishment—It is hereby ordered by their Excellencies the Lords Justices, with the Advice of his Majesty's Privy Council, that all Magistrates and other Civil Officers whatsoever, and all other his Majesty's Subjects, do make strict and diligent Search and Enquiry after the Person or Persons concerned in the said Murder, and the Authors, Actors and Abettors thereof; and that they do apprehend and feize, or cause to be apprehended and seized, the said Offenders, that they may be punish'd with the utmost Rigour of the Law. --- And for the Encouragement of all Persons to be diligent and

A T the Council Chamber Whichall, the 28th industrious in their Endeavours to make such Discovery, and for the better and more effectual bringing the Offenders to Justice, it is hereby further ordered, That if any Person or Persons concerned therein, except the Person who actually flot the said Colin Campbell, shall discover any other Person or Persons concerned in the said Fact, so as the Person or Persons thus discovered may be apprehended and convicted thereof, such Discoverer or Discoverers shall receive his Majesty's most gracious Pardon.—And it is hereby likewise further ordered, That any Person or Persons, who shall discover and apprehend, or cause to be discovered and apprehended, any of the Persons concerned in the said heinous Offence, so as he or they be convicted thereof, shall have and receive, for every such Person so convicted, the Sum of One Hundred Pounds, to be paid by the Receiver-General for Scotland, according to Directions to be given for that Purpose by the Right Honourable the Lords Commissioners of his Majesty's Treasury, who are hereby directed to give such Orders accordingly.—And all his Majesty's loving Subjects are hereby required to use their utmost Endeavours, in their several Stations and Places, to find out, discover, and apprehend the Offenders as aforesaid, upon Pain of his Majesty's highest Displeafure,

Naples, May 19. On Saturday last the young Prince, of whom the Queen our Sovereign was lately delivered, was publickly baptized by the Pope's Nuncio in the Chapel Royal, and was named Gabriel-Antoine-Pascal; most of the principal Nobility, the Foreign Ministers, and a Deputation from the Magistrates' of this City, being present at the Ceremony; At Night there were Illuminations throughout the City, and a triple Discharge was made of the Cannon of the The four Galliots which have been equipping for some Time in this Port, by the King's special Directions, put to Sea on Friday last, two for the Coast of Sicily, and two for that of Calabria, in order to cruize on the Barbary Pyrates. Two Gallies are likewise put to Sea, in order to cruize off Porto Ferrajo and Portolongone, to protect our Commerce. The Ruins of the ancient City of Heraclea are almost continually

continually producing fomething valuable; and, [amongst other Things, several curious Marble Urns, of exquisite Workmanship, have lately been discovered.

Leghorn, May 20. It is reported by the Master of a French Ship arrived here a few Days ago from Barbary, that the eldest Son of the Dey of Tunis had revolted against his Father; and, after defeating a Body of between 5 and 6000 of his Troops, had obliged him to take Shelter in the Castle of Barde.

Warsaw, May 22. A few Davs ago a General Officer arrived here from Dresden, in order to review the Saxon Troops quartered in this Kingdom. We are assured that M. Ruczinsky, Palatin of Czersko, has been almost unanimously elected President of the Tribunal of Radom. We learn from Lucko, in Upper Volhinia, that on the 10th Instant a Fire broke out in that Town; which burnt with such Violence, that the greatest fart of it was reduced to Ashes before the

Flames could be extinguished.

Stockholm, May 26. Their Majesties and the young Royal Family are expected at their Palace in this City from Ulrichsdahl towards the End of next Week; and 'tis thought the Diet will break up the Week after, when his Majesty will set out on a Tour to several Provinces in this Kingdom. We learn from Norkoping, that a large Magazine of Merchandize in that City was broke open in the Night between the 22d and 23d Instant, and every Thing valuable carried away; and though the strictest Search has been made after the Effects and the Robbers, nothing as yet could be discovered.

Copenhagen, May 30. The King, who set out Yesterday Morning from Friedensbourg, atsended by several of the Nobility, reached Nestwed last Night, where he proposes to review this Afternoon several Squadrons of Horse which have been for some Time in Garrison in that Neighbourhood. To-morrow his Majesty goes to Bregentwedt, the Seat of Count Molcke, where he proposes staying four or five Days.

Berlin, May 31. We learn from Sonnenbourg, that a few Days ago the magnificent Edifice in that Town, possessed by the Knights of the Order of St. John of Jerusalem, was accidentally set on Fire, and almost entirely reduced

to Ashes.

Brussels, June 5. The Commissaries appointed to regulate the Barrier and Tariff, meet now regularly to do Business. On Wednesday last they met for the fifth Time; and, after some Hours spent in Deliberations, they all proceeded to the House of the Dutch Commissaries, where they were elegantly entertained at Dinner, With several other Persons of Distinction.

Hague, June 8. This Morning Count Finochietti, Envoy Extraordinary from the King of the Two Sicilies, had an Audience of the President of the Assembly of the States General, and notified in Form to their High Mightinesses, the Birth of the Prince of whom her Sicilian Majesty was fafely delivered on the 11th of last Month.
