Naples, June 1.

N Tuesday last, being St. Ferdinand's Day, whose Name his Majesty's Brother the King of Spain bears, there was a very grand Appearance of the Nobility and Gentry at Court on that Occasion. The Queen, and the young Prince of whom the was lately delivered, are both extremely well. The Building of the Palace of Caferta goes on very fast, there being upwards of 500 Workmen daily employed. Last Wednelday we had a most violent Storm of Wind; it blew excessive Hard for several Hours, and 'tis computed the Damages it has done along the Coasts of this Kingdom only, amounts to upwards of 100000 Sequins. The Fruits of the Earth have greatly suffered on this Occasion.

Rome, June 5. As the necessary Funds for repairing the Port of Anzio are now provided, that great Work will foon go on again with Vigour. The Chavalier Cappello, the Venetian Ambassador at this Court, lies so extremely ill, that there are very little Hopes of his Recovery.

Modena, June 7. The Duke our Sovereign, and-all his Serene Family, set out on Tuesday last from Reggio, where they had been during the whole Time of the Fair, for their Palace at Rivalta, and propose staying there till the Month of August. His Serene Highness has received an Account of a Treaty's being signed, the 29th of April last, between the Imperial Ministers, and those of Spain, for establishing the Peace of Italy, and we wait with Impatience to know on what Terms his Highness will accede to it. We learn by our last Letters from Venice, that the Doge of that Republick is very much indifposed.

Vienna, June 10. We are assured, that the Troops appointed to form the Camp at Neu-Atadt, are to be all assembled by the Middle of next Month, and that Count Dawn is to have the Command of them. Her Imperial Majesty has established a Commission for enquiring into and redressing Abuses in the Application of the Charities that have been given from Time to Time for the Support and Maintenance of Reli-

gious Foundations.

Copenhagen, June 13. The King has appointed M. Hanch, Colonel of the Regiment of Falster, and one of his Majesty's Aids de Camp, to review the Troops in Norway, and he is actordingly fet out thither for that Purpose. The three Gallies lately built at the New Holm, put to Sea Yesterday, but their Destination is not publickly known. The East India Company have received Advice, that one of their Ships, named the Queen, commanded by Captain Arkeley, arrived at St. Hellena on the 10th of

March last, and sailed from thence for Europe on the 19th, so that an Account of her Arrival

is daily expected.

Dresden, June 14. Count Keyserling, who has resided here for some Years in Quality of Envoy Extraordinary from the Empress of Russia, is soon to take his Leave of this Court, and to fet out for Vienna, being appointed to reside at that Court as Ambassador from the Court of Russia.

Prague, June 14. Count Brown, Commander in Chief of the Imperial Forces in this Kingdom, arrived here on Sunday Night last

from Vienna.

Franckfort, June 15. The Protestants of this City, who have hitherto in vain sollicited for Leave to build themselves a Church, have caused a Memorial on that Subject, drawn up in very strong Terms, to be sent to each of the Protestant Princes of the Empire, and seem to think they shall at Length obtain their Request, through the powerful Intercession of those Princes.

Cologn, June 19. The States of this Electorate, who have been for some Time assembled, separated on Saturday last. The Waters of the Rhine have lately swelled so very much, that we daily expected they would have overflown their Banks in several Places, but happily for us they are greatly abated within these two or three Days past, and no Interruption has happened thereby to the Navigation of that River.
