Warsaw, June 12.

AJOR General Count Rex, whom the King has appointed to review set out from hence on Monday last late King of Sweden had been invested. for Cracow and Sambor, in order to review the Regiments of the Princes Charles and Albert, that are in Garrison in those two Places. The last Advices we received from the Frontiers of the Ukraine say, that notwithstanding all the Precautions that have been taken to prevent the Incursions of the Heyducks, a large Body of them have lately plundered a Village in the District of Winnitzka, after having massacred a great Number of the Inhabitants.

Inspruck, June 13. General Count Maguire, Governor of Clagenfurt in Carinthia, who arrived here a few Days ago, sets out To-morrow to visit Kuffstein, and other fortified Places in this Principality; after which, in Conformity to his Orders, he is to review all the Troops in the Garrisons of Bregentz, Fribourg, Brisgaw

and Philipsbourg.

Vienna, June 14. The Return of the Court to Schonbrun from Laxembourg, is fixed for the 23d Instant. 'Tis said a Camp will be formed this Summer in the Neighhourhood of Pest in Hungary, but as yet the Regiments for that Service are not named, neither is the General who is to command it. The Archduke Joseph, who has been for some Days indisposed, is now perfectify recovered, and is gone to join their Imperial Majesties at Laxembourg.

Modena, June 15. They write from Genoa, that the Marquess Grimaldi is elected Doge of that Republick, in the Room of M. Lomellino,

who resigned that Employment.

Stockholm, June 16. Yesterday the Ceremony of closing the Diet of the States of this Kingdom, was performed with the usual Formalities. The King has, upon the Separation of the Diet, made several Military Promotions, and filled up some vacant Employments. 'Tis said his Majesty will set out in a few Days for Finland, in order to review the Troops, and examine into the Strength of the Fortifications in that Province.

Copenhagen, June 17. The Count de Lieven, who arrived here a few Days ago from Stockholm, had Yesterday a private Audience of the King, and delivered to his Majesty the Ensigns the Saxon Troops in this Kingdom, of the Order of the Elephant, with which the

> Dresden, June 20. During the King's Stay at Fraustadt, his Majesty disposed of several considerable Benefices and Employments which were become vacant in Poland, amongst which, M. Dembowsky, Bishop of Plock, was translated to the Bishoprick of Cujavia, and the Bishop of Chelm to that of Plock; and M. Wezyck, Grand Prevost of the Chapter of the Cathedral Church of Gnesne, was appointed Bishop of Chelm. The Abbey of Wochock was given to M. Zalusky, Referendary of the Crown; and that of Wogrowieck to M. Bayer, President of the Tribunal of Lublin. Count Poniatowsky was appointed Castellan of Cracow; and M. Rudziensky, Castellan of Czersck, was appointed Palatin of Mazure, in the room of Count Poniatowsky. Prince Lubomirsky was appointed Palatin of Lublin; and the Post of Great General of the Crown Army was conferred on Count Branicky, Palatin of Cracow.

> Berlin, June 20. The King, who went the Beginning of last Week to Stettin, to review the Troops assembled in the Neighbourhood of that Place, returned to Potzdam on Sunday, from whence his Majesty proposes setting out again on Saturday for Charlottenhourg, with all the Royal Family, in order to receive the Princess of Hosse-Cassel, whose Marriage with Prince Henry his Majesty's Brother, remains fixed for Sunday next.

Dusseldorp, June 22. The latter End of last Week, a great Number of German Families, bound for Nova Scotia, where they are going to reside, sailed down the Rhine in Barks, in order to go on Board the Ships provided for them.

Versailles, June 23. On Friday last the King went to take the Diversion of Hunting in the Forest of Rambouillet. The next Day his Majesty dined at Trianon, and went in the Afternoon to Choisy, from whence his Majesty returned hither on Monday Evening; and the next Day he admitted Count Kaunitz Rittberg, Ambassador from their Imperial Majesties, to a private Audience. The Duke of Deux Ponts, who has been here some Time under the Name of Count Sponheim, took Leave of their Majesties and the Royal Family on Friday Morning last, and the next Day set out on his Return Home. The Queen, who has been for fome Days past indisposed with a Cold, is now perfectly recovered, and went Yesterday to dine with the Dutchess of Penthievre at Putteaux. They write from Madrid, that the King has conferred on the Counts Bagnos and Aguilar the Title of Grandees of Spain; and that his Majesty has named Don Manuel Murillo d'Argaiz to the vacant Bishoprick of Segovia, and ap--pointed Don Juan de Parados to be Governor of Oran.

Hague, June 27. The States of Holland and Westfrizeland are to assemble on the 12th of next Month. The Baron de Wassenaer, Ambassador from this Court to that of Spain, proposes to set out from hence in a few Days for Madrid.
