**G O D Save the KING.**

*Naples, June 6.* On the 28th past died of an Apoplectick Fit the Marquess Roti, President of the King's Chamber; to which Post his Majesty, on the 1st Instant, appointed M. Belle, Counsellor of the Chamber of Commerce. On the 3d Instant anchored at this Port from Apuglia, a Convoy of Ten Transport Vessels, loaden with Provisions for this Capital, escorted by the King's Xebecks as far as Cape Spartivento, who brought the agreeable News, that by the Vigilance of the King's Ships of War, the Gallies, and other armed Vessels, the Barbary Pirates are withdrawn from the Coasts of the Two Sicilies.

*Alicant, June 8.* Several Men of War are lately arrived here, in order to cruize on the Corsairs of Barbary. We have received Advice, that the Propositions made by the States General of the United Provinces to the Emperor of Morocco, for the Ransom of Capt. Steenis and his Crew, who have been for several Months detained Prisoners at Tetuan, have been accepted, and that, in Consequence thereof, they were all preparing to embark for their own Country.

*Rome, June 10.* Last Week the Chevalier Capello, the Venetian Ambassador to the Pope, was taken dangerously ill of a malignant Fever; on Notice whereof, the Pope sent his own Physician to visit and attend him; and, by the last Accounts, there were some Hopes of his Recovery.

*Florence, June 12.* The French Ministers and Consuls have had repeated Advices from divers Parts, that the Tripolines had broke the Peace with their Court, which has alarmed the Subjects of that Nation, their Trade to the Levant being thereby exposed to much Danger. Several French Barks bound thither, returned to Leghorn a few Days ago; others, that were advanced on their Voyage, having received the same Advices at Sea, returned back, and few, or none, will venture, for the present, to sail for those Parts. It is said, that four or six French Ships of War from Toulon are cruizing to protect their Trade, and the French, in these Parts, suppose that more Ships will be put to Sea to keep the Tripolines in Awe till their Court takes some more vigorous Measures on this Occasion. We have not received any farther Advices relating to the Insurrection at Tunis, except that the Bey's Son had dispatched a Vessel with Letters for Leghorn; but that the Bey having had Notice thereof, caused three Barks to be sent after it, which overtook the said Vessel, out of which they seized the Letters, and carried them back to the Bey.

*Petersbourg, June 13.* Her Imperial Majesty has lately granted some new Privileges to the Cossacks of Malorosch: These People are very numerous, and very proper to be employed in warlike Expeditions. Baron Greiffenheim, the Swedish Envoy, has taken his Leave of the Empress, and of the Great Duke and Great Dutchess, and proposes setting out from hence in a few Days, being appointed by his Swedish Majesty

Majesty to assist as his Minister at the General Diet of the Empire.

*Vienna, June 17.* On Thursday last their Imperial Majesties, accompanied by the young Archdutchesses, and the Princess Charlotte of Lorraine, went to dine with Prince Trautson, Archbishop of this City, at his Seat at Neudorff, and returned to Laxembourg at Night. The Regiment of Horse of Birckenfeld, which made Part of this Garrison, has received Orders to hold itself in Readiness to depart for Bohemia towards the End of the Month, and is to be replaced by that of Luchesi. A few Days ago a large Quantity of Muskets and Bayonets were sent from hence for Bohemia and Moravia, for the Use of the Troops quartered in those Countries. Her Imperial Majesty has allotted certain Districts in Hungary to those of her Subjects in Upper Austria, who have declared themselves Protestants, where they will have Leave to establish themselves, and enjoy the free Exercise of their Religion.

*Copenhagen, June 20.* The Lords and Ladies of the Court, who were appointed to go to Brunswick, in order to wait on the Princess, future Spouse to his Danish Majesty, set out from hence on Saturday last. 'Tis said the Marriage will certainly be performed there by Proxy on Saturday next; and that her Serene Highness will set out from thence a few Days after for this Court.

*Franckfort, June 25.* By Letters from Stuttgart, and some other Places of Wirtemberg, we are informed, that the violent Storms of Hail they have lately had in those Parts, has greatly damaged the Corn and Vines. And from Swabia we learn, that a prodigious Flight of Locusts had lately settled in the Neighbourhood of Arbon, a small Town in the Bishoprick of Constance, which had done an infinite deal of Mischief to the Fields and Gardens, they being almost left bare.

*Hague, June 29.* A Deputation from the Province of Utricht arrived here on Tuesday Night last. Yesterday they were admitted to an Audience of her Royal Highness the Princess Governante, and to Day they had a long Conference with the Deputies of the Council of State.
