Petersbourg, June 17.

E are informed by our last Letters from Moscow, that by the late great Fire which happened in that City, full Two Thirds of it is destroyed. By the Lists which have been sent hither it is confirmed, that upwards of 5000 Houses were burnt to the Ground; and though the greatest Number of these Houses were indeed only built with Wood, and many of them only Hutts and Cabins, yet there are also a great many Stone, and Brick Houses, as well as Manufactures of great Value, which have met with the same Fate. By good Fortune, this Disaster happened in a Part of the Town a little remote from the Court, otherwise it must have prevented the Empress's intended Journey to Moscow.

Genoa, June 17. We learn by our last Letters from Cadiz, that they are equipping in that Port the four Men of War which arrived there lately from the Havanna, in order to their efcorting, to a certain Distance, two Register Ships that are preparing to fail for Vera Cruz. By several Letters received here from the Romagna we are informed, that on the 5th Instant a most violent Shock of an Earthquake was felt at Riccia, and in some other Places of that Neighbourhood, but that happily it went off without doing any considerable Damage.

Warsaw, June 20. 'Tis expected the Dietines will shortly assemble in the different Palatinates of this Kingdom, in order to proceed to the Election of Nuncios or Deputies to the general Diet which is to be held at Grodno in the Dutchy of Lithuania towards the End of August next. Count Branicky, Great General of the Crown Army, who went to wait on the King at Fraustadt, and, after his Majesty's Return from thence to Dresden, went to spend some Days at his Seat in the Neighbourhood of Lissa, arrived here on Friday last.

Vienna, June 24. The Empress continues to advance happily in her Pregnancy.

Monday last their Imperial Majesties, accom-panied by the Princess Charlotte of Lorrain, dined with Prince Lichtenstein at his Seat at Obergussing; on Wednesday they took the Diversion of Hunting in the Neighbourhood of Laxembourg; and on Thursday they returned to Schonbrun, from whence her Imperial Májelty does not propose going out any more till after she is brought to Bed. Count Keyserling, who is on the Road hither, in order to replace Count Bestuchest, in Quality of Ambassador from the Empress of Russia to this Court, is

now daily expected.

Berlin, June 27. On Saturday last the Court went to Charlottenbourg, to receive the Princess of Hesse Cassel, who arrived there with all her Retinue about Seven o'Clock that Evening, and was most affectionately received by the King, who afterwards presented her to the two Queens and all the Royal Family; and the next Day, being appointed for her Marriage with Prince Henry, the whole Court repaired to the Chapel Royal, where M. Sack, his Majesty's first Chaplain, gave, with great Solemnity, the nuptial Benediction; after which their Majesties, and the new married Couple, received. the Compliments of the rest of the Royal Family, and all the Nobility. The Feasts and Rejoycings on this Occasion are to last some Days, during which there will be repeated Discharges of the Cannon; and the grand Firework that has been for some Time preparing, will be play'd off.

Hambourg, June 28. By Letters from Stockholm of the 20th Instant we learn, that their Swedish Majesties were gone to the Country Seat of Count Sparr, which lays upon the Borders of the Baltick, not far from the Place where his Majesty intends to embark for Finland; and that the Queen was, after his Majesty's Departure for that Province, to return to Drottningholm. Count Tessin was likewise gone to his Estate lately given him by his Swedish Majesty, in or-On | der to pass there the Summer Season; and ano-

ther

ther Senator has taken upon himself the Function Room of M. Humalda, on whom her Royal of Governor to the young Prince Royal. The Marquess de Grimaldi, Minister Plenipotentiary of the King of Spain, arrived here from Stockholm two Days agos and intends to continue, his Route To-morrow for Hanover. The Bishop of Lubeck, who has been here some Weeks with his Mother the Dutchess Dowager of Holstein, set out from hence on Monday last for Eutin, in order, as 'tis said, to avoid the Ceremonies which he was to observe upon the Occasion of the Arrival of the Princess of t Wolfembuttel, future Queen of Denmark, who passed through this City (the Gates having been kept open for that Purpose} with all her Attendants, this Night between Ten and Eleven o'Clock for Altona, and was faluted by the 'Tis faid her Cannon from the Ramparts. Majesty will remain at Altona for two Days, in order sto self herself from the Fatigue of her Journey; the Magistrates of which City have erected a triumphal Arch, with proper Emblems; and there will be Illuminations each Night on that Occasion. A Deputation from the Senate of this City of Hambourg, will be fent Tomorrow to Altona, to compliment her Majesty upon her Arrival.

Dusselderp, June 30. We learn from Cologne, that on Monday Night last they had as violent a Storm of Rain and Hail, accompanied with Thunder and Lightning, as has been remembered for some Years past; and that the Vines, and other Fruits of the Earth, have suffered greatly by it for five or fix Leagues round that City. According to our last Letters from Munich, the Elector of Bavaria, who is confined to his Apartment in the Castle of Lichtenbourg, with the Meastes, was, to all Appearance, when those Letters came from thence, out of Danger, and 'twas hoped would be able

to go Abroad again in a few Days.

Hague, July 4. The States of Holland and Westfrizeland are to assemble on Wednesday the 12th Instant. Count Dehn, the Danish Envoy Extraordinary at this Court, has been in Conference with the Lords of the Regency, and communicated to them the King his Master's Marriage with the Princess of Brunswick Wolfembuttel. The Field Marshal Duke of Brunswick Wolfembuttel is perfectly recovered from his late Indisposition, and proposes setting out shortly for Guelderland, from whence he will proceed to bis Government of Bois-le-due, in order to stay some Time. M. Straaten has, at the Recommendation of her Royal Highness the Princess Governante, had a considerable Employment conferred on him in the College of the Admiralty of Amsterdam. M. Boullenger has taken the usual Oaths before the Council of States in order to qualify himself for Major of the Regiment of Horse of Orange Frise, in the

Highness has been pleased to confer the Rank of Lieutenant-Colonel of that Regiment. We are assured, that the Princess Governante and the young Family, intend shortly paying a Visit to her Mother-in-law the Princess Dowager of Orange at Dieren, and that her Royal Highness proposes staying there some Days.
