*ABSTRACT of several Acts of Parliament, now in Force, which were made for preventing His Majesty's Subjects from Trading to the East-Indies, under Foreign Commissions; and from being interested or concerned in any Foreign East-India Company to be erected.*

**B**Y the following Acts of Parliament now in Force, and which were made, for preventing His Majesty's Subjects from Trading to the East-Indies under Foreign Commissions; and from being interested, or concerned, in any Foreign East-India Company, to be erected; it is enacted as follows, *viz.*

*5th Geo. I. Cap. 21.]* By an Act passed in the 5th Year of His late Majesty King George the First, all His Majesty's Subjects, except those Licensed by the East-India Company, are prohibited from going to the East-Indies. — And to the End such Offenders may be brought to Justice, the East-India Company are empowered to arrest, and seize, such Offenders in the East-Indies, and to send them to England, there to answer for the said Offence; And every British Subject, who shall procure, solicit for, obtain, or act under, any Commission, Authority, or Pass, from any Foreign Prince, or State, to sail, or go, or trade, in, or to the East-Indies, incurs, and forfeits, for every such Offence, 500*l.*

*7th Geo. I. Cap. 21.]* By another Act passed in the 7th Year of His late Majesty King George the First, every Subject of His Majesty, who shall go to, or shall Trade, or Adventure into, or from, the East-Indies, (contrary to the Laws in being,) and shall be convicted thereof, in any of His Majesty's Courts of Record at Westminster, is to pay, and suffer such Fine, and Imprisonment, as the Court shall think fit.

And all the Goods, and Merchandize, that shall be bartered or traffick'd for, in the East-Indies or purchased there, by any such Offenders, or that shall be found in his Custody, or in the Custody of any other Person, by his Order, or Procurement, are declared to be forfeited, with double the Value thereof.

*9th Geo. I. Cap. 26.]* By an Act passed in the 9th Year of His late Majesty King George the First, all His Majesty's Subjects are prohibited from subscribing, contributing to, encouraging, or promoting, the raising, establishing, or carrying on, any Foreign Company, from, and after, the 24th Day of June, 1723, to be raised, formed, or erected, for Trading to the East-Indies, and from being interested in, or intitled to, any Share in the Stock, or Capital, of such Foreign Company, under Forfeiture of all his, her, or their Interest, in the Capital, Principal, Stock, or Actions, of any such Foreign Company, together with Treble the Value thereof.

And the Attorney-General is empowered to exhibit Bills of Complaint in the Court of Chancery, or Court of Exchequer, against such Offenders, for the Discovery of such Offence; which Discovery such Offenders are obliged to make on the Attorney-General's waving in such Bill, the said Forfeiture of the Treble Value, and insisting only on the Single Value thereof; And in such Case, the Single Value is to be decreed to be paid by such Offender.

And that every Subject of His Majesty accepting of any Trust, or knowing of any Interest, Share, Part, Proportion, or Concern, which any other of His Majesty's Subjects shall have, or be intitled to, in any such Foreign Company; and who shall not, within Six Months, next after the Accepting such Trust, or coming to the Knowledge of such Interest, Share, Proportion, or Concern, as aforesaid, truly discover the same in Writing to the East-India Company, or their Court of Directors, shall forfeit Treble the Value of the Interest so accepted in Trust, or so known and not discovered, as aforesaid; and any Person making such Discovery, is intitled to a Moiety of the Forfeiture.

And all His Majesty's Subjects, (other than such as are lawfully authorized thereunto,) going to, or found in the East-Indies, are declared guilty of a High Crime, and Misdemeanor, and are made liable to Corporal Punishment, Imprisonment, or Fine; for the same, at the Discretion of such of His Majesty's Courts of Record at Westminster, where the Prosecution for such Offence shall be commenced.

And every Person so offending may be seized, and brought to England, and committed to Goal there, by any one of His Majesty's Justices of the Peace, until sufficient Security be given by Natural-born Subjects or Denizens, to appear in the Court, where such Prosecution shall be commenced, to answer the same, and not depart without Leave of the Court.

*3d Geo. II. Cap. 14.]* By an Act passed in the 3d Year of His present Majesty, it is Enacted, That if any of His Majesty's Subjects (other than the East-India Company, and those licensed by them) shall directly, or indirectly, go to, trade, or adventure into, or from, the East-Indies, every such Offender shall incur the Forfeiture, and Loss, of all the Ships, and Vessels, employed in such Voyage, Trade, or Adventure; and also all the Goods laden thereupon, or that were sent to, acquired, traded, or adventured, within the East-Indies, and all the Proceed, and Effects, of the same, and Double the Value thereof.

*Lisbon, July 31.* The King, who a few Days ago was very much indisposed at Belem, is now perfectly recovered. This Morning his Majesty came to his Palace in this City, accompanied by Don Pedro and Don Emanuel, and having given Audience to some Foreign Ministers, returned in the Evening to Belem, where he proposes staying till the End of next Month. The three Men of War that convoyed the Fleet

bound for Mozambique to a certain Distance, and afterwards went on a Cruize against the Corsairs of Barbary, are all returned into Port, without having met with any of those Pyrates. They continue, by the King's express Orders, to raise Recruits in the different Provinces of this Kingdom, in which, by the Lists that have been lately sent to Court, they have been very successful; and 'tis said, that after the old Regiments are all compleat, some new ones are to be formed.

*Cadix, Aug. 8.* The Notre Dame des Remedés, and the Sainte Barbe, both belonging to our Company trading to the Carraccas, are safely arrived in this Port, with very considerable Cargoes; and the Aimable Marie, another of that Company's Ships, is daily expected. A few Days ago the St. Francois Xavier, and the Notre Dame du Pilier, two Advice Ships, put to Sea from hence, the first for Carthagená, and the second for La Vera Cruz.

*Naples, Aug. 8.* The Commerce of this Kingdom has met with no Interruption from the Corsairs of Barbary for this Month past, entirely owing to the prudent Measures that have been lately taken in stationing our armed Xebecs, which are now almost all out a cruising against those Pyrates. The King intends going the End of this Week to Caserta, in order to view the new Palace that is erecting there by his Orders. The Duke de Miranda Caraccioli, Lieutenant General of his Majesty's Armies, died on Friday last in this City; at which the Dutchess his Spouse was so greatly affected, that she immediately retired to the Convent of our Lady of Secours, in order to spend the Remainder of her Days.

*Parma, Aug. 15.* Every Thing is now ready for the Dutchess's Departure for France, and 'tis said she proposes setting out for that Kingdom on the 29th or 30th Instant. They write from Milan, that the large Gang of Robbers, who have lately formed themselves into a Body in that Dutchy, continue to do an infinite deal of Mischief; and though great Rewards have been offered by that Government for apprehending them, none have as yet been discovered.

*Rome, Aug. 16.* The Pope has sent pressing Orders to M. Durini, his Nuncio at the Court of France, to use his best Endeavours to reconcile the Differences that at present subsist between the Clergy and Parliaments of that Kingdom. The Pope has consented to empower the Superiors of the Dominicans, Jesuits and Capuchins, who are employed in Missions to the East-Indies, to administer the Sacrament of Confirmation, in Quality of Apostolical Vicars, which Power was heretofore confined only to Bishops.

*Warsaw, Aug. 16.* We are informed by our last Advices from the Frontiers of the Ukraine, that a large Party of the Cossack Heyducks had lately forced a Pass which was defended by a Body of Russian Troops; and that, being flushed with the Success of that Enterprize, they had afterwards made an IncurSION upon the Polish Territories, where, falling in with a Detachment of the Crown Army, they were totally defeated, a great Number of them having been killed, and the rest put to Flight. By Letters received this Post from Lithuania we are informed, that a terrible Fire had lately broke out in the Town of Olyka, belonging to the Great General of that Dutchy, which burnt with such Violence, that upwards of one hundred Houses were soon reduced to Ashes.

*Fribourg, Aug. 19.* General Maguire, who is appointed by her Imperial Majesty to review

the Troops quartered in Tyrol and Carinthia, arrived here on Monday last from Inspruck; the next Day he reviewed his own Regiment here in Garrison, and Yesterday Morning he set out to visit the Fortifications of Philipsbourg.

*Prague, Aug. 19.* On Wednesday Night last we received the agreeable News of the happy Delivery of the Empress Queen our most gracious Sovereign, on which Occasion Te-deum will be sung To-morrow in the Cathedral Church of this City. The Regiment of Foot of Francis Lorrain is arrived here, in order to strengthen the Garrison of this Place. By Today's Letters from the Camp of Colin we are informed, that for two or three Days past, the Weather having set in fair, the Troops have performed their daily Exercise.

*Berlin, Aug. 25.* On Monday last the King came here from Potzdam, and having given some Audiences, his Majesty went to Montbijou, and dined with the Queen Mother, and in the Evening returned to Potzdam. Advice is received at Court, that the young Prince Frederick-George of Holstein Gottorp, died lately at Reisenbourg in Prussia, from whence his Corps is to be carried to Eutin, in order to be deposited with those of his Ancestors.

*Brussels, Aug. 28.* The Marquess de Botta Adorno, who went on Wednesday last to Ostend, in order to view the Works that are carrying on in repairing the Sluice which was lately broke down by the Sea at Fort Schlick, arrived here last Night, and this Morning set out for Ter-Vuren, in order to acquaint his Serene Highness our Governor General with the Measures he has taken for having the same effectually repaired with all possible Diligence.

*Hague, Aug. 31.* The Duke of Brunswick Wolfembuttel, who has been for some Time past at Count Bentinck's Seat at Doorewaart, intends to set out from thence next Week for his Government of Bois-le-Duc. We hear from Brussels, that the Conferences for settling the Barrier and Tariff, which had been suspended for some Days, were renewed again Yesterday, when the eighth Conference was held, the Result of which is kept secret.
