ABSTRACT of several Acts of Parliament, now in Force, which were made for preventing His Majesty's Subjects from Trading to the East-Indies, under Foreign Commissions; and from being interested or concerned in any Foreign East-India Company to be erected.

Y the following Acts of Parliament now in Force, and which were made, for preventing His Majesty's Subjects from Trading to the East-Indies under Foreign Commissions; and from being interested, or concerned, in any Foreign East-India Company, to be erected; it is enacted as follows, viz.

5th Geo. I. Cap. 21.] By an Act passed in the 5th Year of His late Majesty King George the First, all His Majesty's Subjects, except those Licensed by the East-India Company, are prohibited from going to the East-Indies. ---And to the End such Offenders may be brought to Justice, the East-India Company are empowered to arrest, and seize, such Offenders in the East-Indies, and to send them to England, there to answer for the said Offence; And every British Subject, who shall procure, sollicit for, obtain, or act under, any Commission, Authority, or Pass, from any Foreign Prince, or State, to fail, or go, or trade, in, or to the East-Indies, incurs, and forfeits, for every such Offence, 500%.

7th Geo. I. Cap. 21.] By another Act passed in the 7th Year of His late Majesty King George the First, every Subject of His Majesty, who shall go to, or shall Trade, or Adventure into, or from, the East-Indies, (contrary to the Laws in being,) and shall be convicted thereof, in any of His Majesty's Courts of Record at Westminster, is to pay, and suffer such Fine, and Imprisonment, as the Court shall think sit.

And all the Goods, and Merchandize, that shall be bartered or traffick'd for, in the East-Indies or purchased there, by any such Offenders, or that shall be found in his Custody, or in the Custody of any other Person, by his Order, or Procurement, are declared to be forfeited, with double the Value thereof.

9th Geo. I. Cap. 26.] By an Act passed in the 9th Year of His late Majesty King George the First, all His Majesty's Subjects are prohibited from subscribing, contributing to, encouraging, or promoting, the raising, establishing, or carrying on, any Foreign Company, from, and after, the 24th Day of June, 1723, to be raised, formed, or erected, for Trading to the East-Indies, and from being interested in, or intitled to, any Share in the Stock, or Ca-

pital, of such Foreign Company, under Forfeiture of all his, her, or their Interest, in the Capital, Principal, Stock, or Actions, of any such Foreign Company, together with Treble the Value thereof.

And the Attorney-General is empowered to exhibit Bills of Complaint in the Court of Chancery, or Court of Exchequer, against such Offenders, for the Discovery of such Offenders are obliged to which Discovery such Offenders are obliged to make on the Attorney-General's waving in such Bill, the said Forseiture of the Treble Value, and insisting only on the Single Value thereof; And in such Case, the Single Value is to be decreed to be paid by such Offender.

And that every Subject of His Majesty accepting of any Trust, or knowing of any Interest, Share, Part, Proportion, or Concern, which any other of His Majesty's Subjects shall have, or be intitled to, in any fuch Foreign Company; and who shall not, within Six Months, next after the Accepting such Trust, or coming to the Knowledge of such Interest, Share, Proportion, or Concern, as aforesaid, truly discover the same in Writing to the East-India Company, or their Court of Directors. shall forfeit Treble the Value of the Interest so accepted in Trust, or so known and not discovered, as aforesaid; and any Person making fuch Discovery, is intitled to a Moiety of the Forfeiture.

And all His Majesty's Subjects, (other than such as are lawfully authorized thereunto,) going to, or found in the East-Indies, are declared guilty of a High Crime, and Misdemeanor, and are made liable to Corporal Punishment, Imprisonment; or Fine, for the same, at the Discretion of such of His Majesty's Courts of Record at Westminster, where the Prosecution for such Offence shall be commenced.

And every Person so offending may be seized, and brought to England, and committed to Goal there, by any one of His Majesty's Justices of the Peace, until sufficient Security be given by Natural-born Subjects or Denizens, to appear in the Court, where such Prosecution shall be commenced, to answer the same, and not depart without Leave of the Court.

3d Geo. II. Cap. 14.] By an Act passed in the 3d Year of His present Majesty, it is Enacted, That if any of His Majesty's Subjects (other than the East-India Company, and those licensed by them) shall directly, or indirectly, go to, trade, or adventure into, or from, the East-Indies, every such Offender shall incur the Forseiture, and Loss, of all the Ships, and Vessels, employed in such Voyage, Trade, or Adventure; and also all the Goods laden thereupon, or that were sent to, acquired, traded, or adventured, within the East-Indies, and all the Proceed, and Effects, of the same, and Double the Value thereof.

Tripoly, Aug. 2. On Sunday last, the 30th of July, about Nine o'Clock at Night, we were alarmed with the Report of a Musket, which in this Place is the undoubted Signal of Rebellion; and, after passing the Night in great Unealiness, we found next Morning that the Rais, or Captains of our Cruizers, attended with about 400 of their Countrymen (Albanesi,) and headed by the Vice Admiral, had taken up Arms, with Intent to cut off the Bashaw, the Shag, the Captain of the Port, and some other great People who were obnoxious to them. They began their Operations in a Coffee-House where they usually met in the Evening, (as is the Custom of these People in the Moon of Ramadan) by placing the Vice Admiral on a Carpet, kissing his Hand, and swearing Allegiance to him, as Bashaw; after which he detached three Parties from his Main Body, the first to the Coffee-House, where he knew the Shag or Lord Mayor, and the Prime Minister, &c. were, who instantly assassinated the Prime Minister, together with Sidi Stancoli, first Scrivan to the Bashaw, Sidi Benatriman, a considerable Merchant, and an under Scrivan; the fecond seized the Arms that were in the Guard Room, as the Town Guard were then taking their Rounds; and the third attacked the Captain of the Port, who by his Office is obliged to sleep in a Lodge adjoining to the Marine Gate: Here however they were most valiantly repulsed, and met a Reward due to their Insolence; the Captain of the Port, with only four Attendants, bravely defending himself against their Efforts to burst open the Gates; and, after he had killed fix of them, they thought proper to Retreat. In the mean Time that the different Parties were thus employed, the Vice Admiral, and the rest of the Rebels, went to all the different Barracks, or Funducks, where the Levant Turks (Soldiers) are quartered, and strenuously follicited them to joyn him; but as neither his magnificent Promises, nor his artful Persuasions, had the least Effect upon them, and having Information at the same Time that the Bashaw was alarmed, and had fent a confiderable Body against them, they plainly perceived that their Case was desperate, and began to set about making their Retreat; in order to which, they got Possession of a Castle situate at the N. W. End of the Town, and which commanded the Marine, as well as the Beshaw's Castle, from which latter the Bashaw kept playing all the great Guns they could bring to bear, while their Commanders were Scaling the Walls to escape by Sca.

As nigh as we can learn, about 200 of them, with the Vice Admiral, got off in Boats, and feized upon an English Ship loaden with Salt, bound for Venice, with five Men on board, whom they fent on Shore, as foon as they thought themselves out of Danger; they also feized a Row Boat that was ready to go out upon a Cruize.

Advice of this has been sent by the Bashaw's Order to Malta, to induce the Grand Master to send some Ships after them, which it is hoped he will do, otherwise we may expect to have very tragical Accounts of their Barbarity to all who shall be so unhappy as to fall in their Way, particularly the French, against whom they have long swore the most cruel Revenge; and the late Renewal of Peace has, if possible, increased their Hatred to that Nation. We have great Reason to believe that they intend to proceed

to Durazzo their own Country, whenever they can get Provisions and Ammunition; for when they departed from hence, they had no more Powder than what each Man had about him for his Small Arms, and no Shot for Great Guns were on Board; so that they are at present destitute of almost every Necessary, either for Support or Defence. We imagine they will keep in the Channel of Malta, in order to way-lay and plunder what Ships they fall in with, and by that Means get a Supply.

Rome, Sept. 2. The Pope has disposed of an Abbey of about the yearly Value of 2000 Crowns, vacant in the Novarois by the Death of the late Cardinal Spinola, in Favour of a Nephew of M. Millo, the Apostolical Datary. On Saturday last Cardinal Caraffa set out for Tivoli, by the Advice of his Physicians, for the Benefit of his Health. The Duke de Palombara, Governor of the Castle of St. Angelo, died here Yesterday in a very advanced Age, and will be fucceeded in that Employment by the Chevalier de Bussy, Commander of the Pope's Gallies.

Florence, Sept. 2. We are informed by Letters received this Post from Leghorn, that the Troubles are again renewed in the Island of Corsica, where several Skirmishes have already happened between the Genoese and the Malecontents, wherein the former have for the most

Part had the Advantage.

Genoa, Sept. 9. On the 3d Instant arrived the Dutchess of Parma: Her Highness was saluted with 42 Pieces of Cannon, and, in the Afternoon, was complimented on the Behalf of this Government by fix Gentlemen and fix Ladies; a grand Ball was given on the Occafion the next Night, where she staid about an Hour, and from thence went on Board the French Gallies, which arrived here some Days before, and departed directly for Antibes. On Tuesday last six French Men of War arrived at Porto Spezia from Tripoli and Tunis, and Yesterday they past in Sight of this Port, in their Way to Toulon.

Copenhagen, Sept. 12. A Royal Edict has been lately published here, forbidding, till farther Order, the Exportation of Planks, Boards, or any Kind of Timber, from that Part of Norway called Nordland. This is a District of very great Extent, lying between Drontheim and Lapland, uncultivated, and almost uninhabited. It formerly produced Plenty of Firs, but it has afforded but little Timber of late, which has occasioned the present Edict to favour and recover the Woods in those Parts. The Order of the Elephant, which Baron Juel is gone with to the King of Sweden, is in Return for the Seraphin Order which Count Lieven lately brought to the King of Denmark...

Gohrde, Sept. 13. The King, God be praised, is in perfect Health. Several Regiments of Horse and Foot have passed in Review before his Majesty for three Mornings successively. They all made the finest Appearance imaginable, and performed their Exercises entirely to his Ma-

jesty's Satisfaction.

Brussels, Sept. 18. The Deputies of Alost, who have been some Time solliciting for Leave to dig a new Canal from their Town to Dendermond, have at Length obtained the Consent of this Court to begin that Work. Last Saturday the Marquess de Botta reviewed a large Body of Recruits, who are just arrived here from Germany, to compleat the Regiment of Cuirassiers of Benthem.

Hague, Sept. 21. This Morning arrived a Courier from Dieren, by whom we learn, that no Time is as yet fixed for her Royal Highness the Princess Governante's Return to this Place. The Barons Boetzelaer and Burmania, who went some Time ago to settle the Taxes and visit the Fortifications and Magazines in the District of the Meuse, returned here from thence a few Days ago.
