Their Excellencies the Lords Justices in Council.

Their Excellencies the Lords Justices in Council were this Day pleased to order, that the Parliament which stands prorogued to Tuesday the 31st of this Instant October, should be further prorogued to Thursday the 11th Day of January next.

Whitehall, October 28.

We have received an Account from Lisbon, that on the 19th of September last, the Pernambucco Fleet, with 18 Merchant Ships and one Man of War of 50 Guns, arrived at that Port: A Lieutenant and eight French Mariners came as Passengers, on Board this Fleet, being the only Persons who had been saved out of a French East India Ship of 60 Guns and 350 Men, which left Port L'Orient in April last, and was bound to Pondicherry; but having unhappily taken Fire about 100 Leagues from the Coast of Brazil, the whole Crew perished, except these nine Men, who escaped in a small Boat. There were several Passengers of Distinction on Board, particularly M. de la Touche, who commanded at the Siege of Pondicherry, and there were likewise Magnificent Presents for the Nabobs and chief People of that Country, and about three Millions of Livres in Specie, and 600 Barrels of Powder.

ABSTRACT of several Acts of Parliament, now in Force, which were made for preventing His Majesty's Subjects from Trading to the East-Indies, under Foreign Commissions; and from being interested or concerned in any Foreign East-India Company to be erected.

Y the following Acts of Parliament now in Force, and which were made, for preventing His Majesty's Subjects from Trading to the East-Indies under: Foreign Commissions; and from being interelted, or concerned, in any Foreign East-India Company, to be erected; it is enacted as follows, viz.

5th Geo. I. Cap. 21. By an Act passed in the 5th Year of His late Majesty King George; the First, all His Majesty's Subjects, except those Licensed by the East-India Company, are prohibited from going to the East-Indies. — And to the End such Offenders may be brought; to Justice, the East-India Company are empowered to arrest, and seize, such Offenders in the East-Indies, and to send them to England, there to answer for the said Offence; And every British Subject, who shall procure, sollitt for, obtain, or act under, any Commission,

AT the Gouncil Chamber Whitehall, the Authority, or Pass, from any Foreign Prince, or State, to sail, or go, or trade, in, or to the East-Indies, incurs, and forfeits, for every such Offence, 500%.

> 7th Geo. I. Cap. 21.] By another Act passed in the 7th Year of His late Majesty King George the First, every Subject of His Majesty, who shall go to, or shall Trade, or Adventure into, or from, the East-Indies, (contrary to the Laws in being,) and shall be convicted thereof, in any of His Majesty's Courts of Record at Westminster, is to pay, and suffer such Fine, and Imprisonment, as the Court shall think fit.

> And all the Goods, and Merchandize, that shall be bartered or traffick'd for, in the East-Indies or purchased there, by any such Offenders, or that shall be found in his Custody, or in the Custody of any other Person, by his Ora der, or Procurement, are declared to be forfeited, with double the Value thereof.

> 9th Geo. I. Cap. 26.] By an Act passed in the 9th Year of His late Majesty King George the First, all His Majesty's Subjects are prohibited from subscribing, contributing to, encouraging, or promoting, the raising, establishing, or carrying on, any Foreign Company, from, and after, the 24th Day of June, 1723, to be raised, formed, or erected, for Trading to the East-Indies, and from being interested in, or intitled to, any Share in the Stock, or Capital, of such Foreign Company, under Forfeiture of all his, her, or their Interest, in the Capital, Principal, Stock, or Actions, of any fuch Foreign Company, together with Treble the Value thereof.

> And the Attorney-General is empowered to exhibit Bills of Complaint in the Court of Chancery, or Court of Exchequer, against such Offenders, for the Discovery of such Offence; which Discovery such Offenders are obliged to make on the Attorney-General's waving in such Bill, the said Forseiture of the Treble Value, and insisting only on the Single Value thereof; And in such Case, the Single Value is to be decreed to be paid by such Offender.

And that every Subject of His Majesty accepting of any Trust, or knowing of any Interest, Share, Part, Proportion, or Concern which any other of His Majesty's Subjects shall have, or be intitled to, in any fuch Foreign ? Company; and who shall not, within Sixe Months, next after the Accepting such Tru or coming to the Knowledge of such Interes. Share, Proportion, or Concern, as aforesaid truly discover the same in Writing to the East-India Company, or their Court of Directors, ICA shall forfeit Treble the Value of the Interest so accepted in Trust, or so known and not discovered, as aforesaid; and any Person making such Discovery, is intitled to a Moiety of the Forseiture.

And

And all His Majesty's Subjects, (other than fuch as are lawfully authorized thereunto,) going to, or found in the East-Indies, are declared guilty of a High Crime, and Missdemeanor, and are made liable to Corporal Punishment, Imprisonment, or Fine, for the same, at the Discretion of such of His Majesty's Courts of Record at Westminster, where the Prosecution for such Offence shall be commenced.

And every Person so offending may be seized, and brought to England; and committed to Goal there, by any one of His Majesty's Justices of the Peace, until sufficient Security be given by Natural-born Subjects or Denizens, to appear in the Court, where such Prosecution shall be commenced, to answer the same, and not depart without Leave of the Court.

3d Geo. II. Cap. 14.] By an Act passed in the 3d Year of His present Majesty, it is Enacted, That if any of His Majesty's Subjects (other than the East-India Company, and those licensed by them) shall directly, or indirectly, go to, trade, or adventure into, or from, the East-Indies, every such Offender shall incur the Forfeiture, and Loss, of all the Ships, and Vessels, employed in such Voyage, Trade, or Adventure; and also all the Goods laden thereupon, or that were fent to, acquired, traded, or adventured, within the East-Indies, and all the Proceed, and Effects, of the fame, and Double the Value thereof.

Lisbon, Sept. 20. The King has conferred the Dignity of a Count of this Kingdom on Don Sebastian de Caravalho, Secretary of State for Foreign Affairs, by the Title of Count Deyras. A few Days ago some Domesticks belonging to Count Aubigny, the new French Ambassador to this Court, arrived here with great Part of his Equipage, and the Count himself is expected some Time next Month. We are informed by our last Letters from Spain, that four Men of War, and ten armed Chebecks, were sailed from Carthagena, to cruize on the Barbary Pyrates, who have lately appeared in great Numbers on the Coast of Andalusia.

Naples, Sept. 26. The Court is still at Portici, where there was a grand Appearance of the Nobility and Gentry on Saturday last, to compliment his Majesty, it being the Anniversary of his Brother the King of Spain's Birth-Day. Their Majesties intended Journey to Caserta is put off for the present. The Chevalier Majo, who is appointed to take Care of the Affairs of this Court at that of Vienna, in the Room of Prince Campo Reale, waits only for his last Instructions, in order to set out for that Court.

Petersbourg, Sept. 29. Her Imperial Majesty having informed the Senate of her Intention to fet out for Moscow the Beginning of December next, they have accordingly given Orders for getting every Thing ready against that Time for her Departure. Lieutenant General Brown, and M. Biberstein, Director General of the Posts in Lithuania, are both created Knights of the Order of St. Alexander Newsky. We learn by Letters from Moscow, that a Fire had lately broke out in that Part of the Town called Nova-Basmanowna, which had burnt down many Houses and Warehouses. The same Letters add, that the Houses burnt down by the late great Fires, were for the most Part rebuilt,

Rome, Sept. 3Q. The Pope has caused an Ordonnance to be published, forbidding, under fevere Penalties, the fending of Corn out of the Ecclesiastical State, on Account of the Shortness of our Crops this Year in many Places

Florence, Sept. 30. Count Richecourt, Prefident of the Council of this Regency, having received Orders to repair to Vienna, propoles to set out for that Place the Beginning of next Week. There is now no more Talk of reinforcing the Garrisons of this Country, or those of Lombardy; on the Contrary, 'tis said, that some Regiments of Horse, that are becom useless here by the late Treaty of Madrid, for securing the Tranquility of Italy, will soon be ordered to march from hence into Germany.

Stockholm, Oct. 6. On Monday Morning last the King came here from Drotningholm and affisted at the Deliberations of the Senate: and in the Afternoon his Majesty returned to Drotningholm. General Count Mark, Commander of the Swedish Troops in Finland, is arrived here from thence; and 'tis faid the 8000 Men, who went from hence some Time ago to work at the Fortifications in that Province, will foon be ordered Home. The Convention lately concluded with the Crown of Denmark, for fettling the Limits in Norway, is made publick, and appears entirely calculated to strengthen the present good Understanding between the two Courts.

Dresden, Oct. 10. According to our last Advices from Poland, their Majesties, accompanied by the Princes Xavier and Charles, atrived at Grodno on the 30th of last Months The same Advices add, that the Day after their Arrival, the General Diet of the Kingdom was opened with the usual Ceremonies; when Count Masalsky, Son to the Castellan of Wilna, was

unanimously elected Marshal.

Capenhagen, Oct. 14. Last Night ended the Publick Rejoycings here, which have been kept three Days successively, for the Reception of the Queen of Denmark. The Particulars whereof, which were as usual on such Occasions, are as follow: On the 11th Instant, the Day appointed for the Entry, her Danish Majesty, accompanied in her Coach by the Princess Charlotte, set out from Fridericksberg between Two and Three in the Afternoon, preceded by a great Number of fine Equipages, as well as Gentlemen on Horseback, and escorted by the Guards. In this Manner her Ma-, jesty proceeded hither, very slowly, and arrived at the Palace of Christiansburg about Six o'Clock, where the was received by the King. In the Streets, thro' which the Procession passed, there were several Triumphal Arches erected; the Houses on each Side being painted and adorned with Variety of Devices, and the Cannon of the Ramparts keeping a continual Fire from the Time her Majesty's Coach appeared within the Walls, till she alighted out of it at the Palace. There a magnificent Supper concluded the Evening, and each of the Guells received a large Silver Medal upon the Subject of the Day. On the 12th in the Forencon, two new built Ships were launched, one of Seventy Guns, called Juliana Maria, in Honour of the Queen, and the other of Forty, called Moen, at which both their Danish Majesties assisted. This Ceremony being over, they returned to Court, where there was an elegant Dinner at several Tables. In the Asternoon & Danish Comedy, with an Italian Intermezzo,

was performed in the publick Theatre at the King's Expence; and in the Evening there was a magnificent Supper again at Court, followed by a Balk. On the 13th the Court gave an elegant Dinner, as before; in the Afternoon a French Comedy, and at Night a Supper and a Ball. The Town House, and all the Houses about the Palace, as well as several others, were finely illuminated in the Evenings of each of the three Days. The University likewise bore a considerable Part in this Festivity, by Speeches, Verses, and conferring of Degrees; and the Citizens, besides the Parade of their Militia, and other publick Demonstrations, had private Entertainments in their respective Houses.

Duschy, and those of Juliers, have opened their Assembly this Morning. We learn from Cologn, that a Fire broke out on Thursday last at a Wine Merchant's in that City, which burnt with great Violence, and reduced that, and se-

veral other Houses, entirely to Ashes.

Brussels, Oct. 17. M. Bellanger, Counsellor of the Domains and Finances of her Imperial Majesty in the Low Countries, is named to be one of the Council of State. M. Dupuy, who went some Time ago to Namur, to take an exact Account of the Revenues of the Clergy in that Province, is daily expected to return here from thence. The Government has ordered the Duty that used to be paid for the bringing of French Gold and Silver Lace into this Country, to be considerably diminished.

Hague, Oct. 19. Her Royal Highness the Princess Governante has been pleased to appoint M. van Eck, Major of the Town of Arnheim, to be Commandant of that Place. Yesterday died M. Roelands, Principal of the Chamber of Finances, and he is already succeeded in that Employment by M. Bassecourt. We are informed by Letters from Hanover, that his Britannick Majesty intends to set out from thence for England on the 8th of next Month.
