ABSTRACT of several Acts of Parliament, now in Force, which were made for preventing His Majesty's Subjects from Trading to the East-Indies, under Foreign Commissions; and from being interested or concerned in any Foreign East-India Company to be erected.

Y the following Acts of Parliament now in Force, and which were made, for preventing His Majesty's Subjects from Trading to the East-Indies under Foreign Commissions; and from being interested, or concerned, in any Foreign East-India Company, to be erected; it is enacted as follows, viz.

hth Geo. I. Cap. 21. By an Act passed in the 5th Year of His late Majesty King George the First, all His Majesty's Subjects, except those Licensed by the East-India Company, are prohibited from going to the East-Indies. -And to the End such Offenders may be brought to Justice, the East-India Company are empowered to arrest, and seize, such Offenders in the East-Indies, and to send them to England, there to answer for the said Offence; And every British Subject, who shall procure, sollicit for, obtain, or act under, any Commission, Authority, or Pass, from any Foreign Prince, or State, to fail, or go, or trade, in, or to the East-Indies, incurs, and forfeits, for every such Offence, 500%.

in the 7th Year of His. late Majesty King George the First, every Subject of His Majesty, who shall go to, or shall Trade, or Adventure into, or from, the East-Indies, (contrary to the Laws in being,) and shall be convicted thereof, in any of His Majesty's Courts of Record at Westminster, is to pay, and suffer such Fine, and Imprisonment, as the Court shall think sit.

And all the Goods, and Merchandize, that shall be bartered or traffick'd for, in the East-Indies or purchased there, by any such Offenters, or that shall be found in his Custody, or

oth Geo. I. Cap. 26.] By an Act passed in the 9th Year of His late Majesty King George the First, all His Majesty's Subjects are prohibited from subscribing, contributing to, encouraging, or promoting, the raising, establishing, or carrying on, any Foreign Company; from, and after, the 24th Day of June, 1723, to be raised, formed, or erected, for Trading to the East-Indies, and from being interested in, or intitled to, any Share in the Stock, or Capital, of such Foreign Company, under Forseiture of all his, her, or their Interest, in the Capital, Principal, Stock, or Actions, of any such Foreign Company, together with Treble the Value thereof.

And the Attorney-General is empowered to exhibit Bills of Complaint in the Court of Chancery, or Court of Exchequer, against such Offenders, for the Discovery of such Offence; which Discovery such Offenders are obliged to make on the Attorney-General's waving in such Bill, the said Forseiture of the Treble Value, and insisting only on the Single Value thereof; And in such Case, the Single Value is to be decreed to be paid by such Offender.

And that every Subject of His Majesty accepting of any Trust, or knowing of any Interest, Share, Part, Proportion, or Concern, which any other of His Majesty's Subjects shall have, or be intitled to, in any such Foreign Company; and who shall not, within Six Months, next after the Accepting such Trust, or coming to the Knowledge of fuch Interest, Share, Proportion, or Concern, as aforesaid, truly discover the same in Writing to the East-India Company, or their Court of Directors, shall forfeit Treble the Value of the Interest so accepted in Trust, or so known and not discovered, as aforesaid; and any Person making such Discovery, is intitled to a Moiety of the Forseiture.

And all His Majesty's Subjects, (other than such as are lawfully authorized thereunto,) going to, or found in the East-Indies, are declared guilty of a High Crime, and Misdemeanor, and

are made ligble to Corporal Punishment, Imprisonment, or Fine, for the same, at the Discretion of such of His Majesty's Courts of Record at Westminster, where the Prosecution for

such Offence shall be commenced.

And every Person so offending may be seized, and brought to England, and committed to Goal there, by any one of His Majesty's Justices of the Peace, until sufficient Security be given by Natural-born Subjects or Denizens, to appear in the Court, where such Profecution shall be commenced, to answer the same, and not depart without Leave of the Court.

3d Geo. II. Cap. 14.] By an Act passed in the 3d Year of His present Majesty, it is Enacted, That if any of His Majesty's Subjects other than the East-India Company, and those licensed by them) shall directly, or indirectly, go to, trade, or adventure into, or from, the East-Indies, every such Offender shall incur the Forfeiture, and Loss, of all the Ships, and Vessels, employed in such Voyage, Trade, or Adventure; and also all the Goods laden thereupon, or that were sent to, acquired, traded, or adventured, within the East-Indies, and all the Proceed, and Effects, of the same, and Double the Value thereof.

Constantinople, Sept. 16. The Confusion we were in some Time since at this Court, is now at an End, and every Thing seems in the utmost Tranquility. The Plague, which lately began to manifest itself in this City, is so far abated, that the Foreign Ministers, who on that Account retired into the Country, are daily returning here. We learn from the Frontiers of Persia, that the Affairs of that Country still continue in the utmost Confusion, Fortune sometimes favouring one Party, and sometimes the other.

Naples, Ost. 3. Last Week anchored in this Port the King's Frigates la Reine and Notre Dame de la Conception, on their Return from a Cruize on the Coast of Sicily. On the 29th past Prince Esterhasi, Ambassador from their Imperial Majesties, had his Audience of Leave of the King, and was presented with his Majesty's Picture set with Diamonds. The Six fine Marble Statues, that were lately found in the Neighbourhood of Piscina, are brought here and fixed up in the Royal Gallery at the Palace.

Rome, October 7. Some Copper Mines having lately been discovered in the Mountains of the Marche of Ancona, the Pope has granted an exclusive Privilege to M. Bianchini for working

the fame.

Florence, Oct. 8. On the 22d past died here the Marquess Riccardi, Master of the Great Wardrobe, of a malignant Fever; and on the 26th died here likewise, his eldest Son, of the same Distemper. This Government, notwithstanding the Assurances that all Suspicions and Alarms were removed, which the Magistrates of Health at Genoa were under on the Report that a Vessel was arrived at Marseilles from the Le-

vant, with the Plague on board, has directed the Magistrate of Health at Leghorne, to subject all Vessels from the Coast of Provence to a Quarantine of ten Days; and has sent privately a Perfon to Genoa and Marseilles, to make secret Enquiries into that Affair, in order to take farther Precautions if necessary, which Steps have greatly displeased both the French and Genoese. On the 4th Instant the Emperor's Name-day was celebrated here with the usual Solemnity; on which Occasion the Foreign Ministers, the Nobility, and Military Officers appeared in their rich Habits; and in the Evening the usual Fireworks and the Cannon of the Castles were fired; and Liberty was granted for Masking at the Theatre in the Evening for a Fortnight. On Friday Morning last Count Richecourt set out for Vienna.

Vienna, Oct. 11. Their Imperial Majesties having given Yesterday Morning some private Audiences, and signed several Dispatches, set out afterwards with the Princess Charlotte of Lorrain, and a numerous Retinue, to take the Diversion of Hunting in the Neighbourhood of Wolkerstorff. Her Imperial Majesty has disposed of the late Baron Ghilany's Regiment, in Favour of General Haddick. Prince Esterhasi, Ambassador from this Court to that of the King of the Two Sicilies, having received his Letters of Revocation, is shortly expected here from Naples; and 'tis said will be replaced by the Marquess Doria, a Genoese Nobleman lately entred into their Imperial Majesties Service.

Hanover, Oct. 17. The King enjoys perfect Health, and proposes setting out for England on the 8th of next Month. We learn by Letters from divers Places in the Bishopricks of Munster and Paderborn, that the Distemper amongst the horned Cattle is broke out again, and great

Numbers of them die daily of it.

Berlin, Oct. 18. On Thursday last the Queen-Mother, and the Princess Amelia, came from the Palace of Montbijou to reside here for the Winter. The same Day an Express arrived here from Wolfembuttle with the agreeable News, that the Dutchess of Brunswick, the King's Sister, was happily delivered of a Prince. We are assured, that a Plan, for making the River Ucker navigable, has been laid before the King and approved, and that the same will be immediately carried into Execution.

Bergen-op-Zoom, Oct. 19. The principal Church of this City, which was destroyed by the Bombs thrown in by the French during the Siege in the Year 1747, being entirely finished, was confecrated on Sunday last; after which Divine Service was performed in it as formerly.

Hague, Oct. 24. This Morning M. Hop, Envoy Extraordinary from this Court to that of his Britannick Majesty, who arrived here lately from Hanover, set out from hence on his Return to London. The Duke of Brunswick Wolfembuttle is expected here this Evening or To-morrow Morning from his Government of Bois-le-Duc.
