Petersbourgh, January 25.

E are informed by our last Advices from Moscow, that Count Rasoumossky, Attaman or Chief of the Cossacks, was arrived there from the Ukraine; and that he had been introduced to the Empress, and met with a gracious Reception, her Imperial Majesty expressing the highest Satisfaction at the Account he gave of the Affairs of that Province. Count Bestuchest, the Great Chancellor, is still so weak, that there is no Appearance of his being soon able to follow the Empress; but Baron Pretlack, Am-'bassador from Vienna, is greatly recovered, and proposes shortly to set out for Moscow; for , which Journey he is already making Preparations.

Stockholm, Feb. 4. The Court is still at Ulrichsdahl, from whence the King comes frequently to assist at the Deliberations of the Senate. The College of Commerce has published an Ordonnance, by his Majesty's express Order, commanding all Captains or Masters of Swedish Ships whatsoever, who shall happen to fall in with the three Dutch Ships which were last Year obliged to be left amongst the Ice on the Coast of Greenland, not to suffer any of their Crews to take the least Thing out of them; but, on the Contrary, to do all in their Power to secure them for the Use of the Owners.

Copenhagen, Feb. 9. The King, who some Days ago was pretty much indisposed, is now perfectly recovered, and goes frequently a Hunting in the Neighbourhood of Jagersbourg. The Chamberlain Count Cheusses, whom his Majesty has named to replace the late Count Dehn in the Post of Envoy Extraordinary and Minister. Plenipotentiary to the States General of the United Provinces, is arrived here from his Country Seat in Holstein, in order to receive his Instructions before he repairs to the Hague. child, is confirmed; and we are now affured, that the same will consist of twelve Battalions, and the like Number of Squadrons; and that his Majesty has appointed Field Marshal Count Schulembourg to have the Chief Command, thereof. The King has appointed M. Erboe to be Conful from this Kingdom to the Emperor of Morocco; and, as 'tis agreed he shall reside at Saffia, most People here imagine our Commerce with the States of that Kingdom, is settled upon a good Footing.

Berlin, Feb. 13. M. Kupferberg, having received his Instructions, set out on Monday last for Vienna, in order to renew the Negociations begun some Time ago with that Court by the late Baron Dewitz. The King has conferred the Post of Grand Master of the Queen's Houshold, vacant by the Death of the late Count Dohna, on Baron Kannenberg, whom he has likewise honoured with the Order of the Black Eagle. His Majesty has appointed M. Cupner, to be Counsellor of War and Domains of the Chamber of Konisberg, in the room of his Father, who has obtained Leave to resign that Employment.

Mayence, Feb. 14. Count Cobentzel, whom their Imperial Majesties named some Time ago to assist, in Quality of their Commissary, at the Election that is shortly to be made of a new Prince-Archbishop of Saltzbourg, set out from hence on Sunday last for Saltzbourg; and Count Pergen, who came here lately to compliment the Elector our Sovereign upon the Re-establishment of his Health, is appointed to take Care of the Affairs of the Court of Vienna in his Absence.

Paris, Feb. 14. Since the Beginning of this Month several Couriers have arrived here from Stockholm and Berlin, whose Dispatches have occasioned the holding of divers Councils. The Colonels and other Officers of the Regiments in Garrison in Alsace, have received Orders to join their respective Regiments forthwith; from next Summer in the Neighbourhood of Rotts- | whence 'tis believed a Camp is intended to be formed formed there in the Spring. The Disputes between the Clergy and the Parliament continue to be carried to a great Height; and no longer ago than last Saturday, the Parliament issued an Arret, by which a Curate in the Diocese of Amiens, is condemned to perpetual Banishment from this Kingdom, for resusing publickly to administer the Sacrament to one of his Parishioners.

Brussels, Feb. 15. The States of Brabant, who have been assembled here eyer since the Beginning of this Month, continue their Deliberations on the Demands made by the Empress Queen, and tis-believed will shortly come to a final Resolution thereupon. The Conferences relating to the Barrier and Tariff are renewed, and, 'tis thought, will be attended with Success.

Amsterdam, Feb. 17. M. Henry Ter-Smatten, ancient Burgomaster and Counsellor of this City, and one of the Commissaries of the Posts of the Province of Holland and Westfrizeland, died here on Friday last, in the 44th Year of his Age. We are informed by our last Letters from Lisbon, that Part of the Fleet from Rio de Janeiro, which had been expected for some Time, were at length arrived, very richly laden, as well on the King's, as on the Account of the Merchants.

Hague, Feb. 20. On Friday last M. Wynbergen took the usual Oaths, before the Assembly of their High Mightinesses, in Quality of Counsellor of the Court of Justice of the Upper Quarter of Guelderland. Her Royal Highnels the Princes Governante is establishing a publick School for teaching the Mathematicks, under the Direction of Captain Chardon, and the same will be ready towards the End of April next, when young Gentlemen are to be taught three Times a Week gratis. We learn from Amsterdam, that the Dauphin Man of War, commanded by Captain Hoogstraten, and the Rayen, commanded by Captain van Stokken, arrived on Saturday last in the Texel from Gibraltar, having on Board Captain Steenis and his Crew, who were for a long Time detained Prisoners in the Dominions of the Emperor of Morocco. We are informed by our last Letters from Venice, that M. Feitama, who has resided there for several Years in Quality of Consul from their High Mightinesses, the States General, died in that City on the 4th Instant, in the 57th Year of his Age.
