PRESENT,

The King's most Excellent Majesty in Council.

HEREAS Monf. Hop, Envoy Extraordinary from their High Mightinesses the States General of the United Provinces, hath presented a Memorial to his Grace the Duke of Newcastle, one of His Majesty's Principal Secretaries of State, setting forth, "That three "Dutch Ships, named the Groenlandia, the "Bruynvis, and the Vrouw Leonora, were fent, the Beginning of last Year, upon the Greenland Whale Fishery, where they were froze up, on the 21st of August; That the * Crews did thereupon return to Holland with "Commodore Harmanse, having first secured the said three Ships by their Anchors in the best Manner they could, in Hopes of finding them again, upon their going to Green-16 land this Year—That three Ships are now " ordered to be fitted out to sail for Greenland in Search of the said Vessels so lest "there; but the Owners and Freighters having been under some Apprehensions, least the said Ships should be taken and carried away by Persons who have no Right or Title thereto, had therefore made Application to the States General, praying, that all Persons might be forbid to intermeddle with the faid Ships and their Cargoes, exto cept only those, who shall be authorized to es go and look after them: And the States "General having complied therewith, the necessary Placards have been issued for that "Purpose;—The aforementioned Envoy Ex-"traordinary therefore humbly begs, that the " like Orders may be given with Regard to "His Britannick Majesty's Subjects." Which Memorial being this Day laid before His Majesty at this Board, the same was taken into Consideration: And His Majesty is pleased, with the Advice of His Privy Council, to Order, as it it is hereby Ordered, That none of His

Majesty's Subjects do presume to seize, take away, or molest the aforementioned Dutch Ships, or any of them, or their, or either of their Cargoes, or otherwise to intermeddle therewith, without the Consent of the Owners thereof, or fuch as shall be authorized to take Care of the same, as they shall answer the contrary at their Peril.——And to the End, that all His Majesty's Subjects may be informed hereof, It is His Majesty's Commands, that this Order be printed and published in the London Gazette.

Naples, Feb. 12. Their Majesties, who are still at Caserta with the young Royal Family, propose setting out from thence towards the End of the Week for Bovino, in order to take the Diversion of hunting. The Project that was some Time ago presented to the King for repairing and enlarging the Port at Salerno, having been examined in Council and approved. the same will be immediately carried into Execution, from whence great Advantages are expected to arise by the Encrease of our Commerce.

Stockholm, Feb. 20. There is no Talk at present of recalling our Troops from Finland; on the contrary 'tis now said they are to remain in that Province till the new Fortifications lately begun there, are entirely finished. The Queen, who has been confined to her Chamber by a feverish Disorder, is now much better, 'Tis faid the King intends to fet out early in the Spring on a Tour to Scania, and some other Provinces of this Kingdom, which his Majesty has not visited fince he came to the Throne. We are informed by some Travellers who are arrived here from the Northern Frontiers of this Kingdom, that two violent Shocks of an Earthquake were lately felt in those Parts, particularly in the District of Angermanland, but that the same happily went off without doing any considerable Damage.

Vienna, Feb. 21. On Sunday last Part of a large Bridge upon the Danube was broke down and carried away by a great Quantity of Ice that came floating down that River, by which

Means two or three Persons lost their Lives. M. Joseph de Khevenhuller, Count of Franckenbourg, Baron of Landskron, and one of her Imperial Majesty's Privy Counsellors, died here on Saturday last, in the 45th Year of his Age.

Copenhagen, Feb. 24. They are already making Preparations, by express Order of the King, for the intended Camp near Rotschild. His Majesty has been slightly indisposed, but is now perfectly recovered. The Engineers appointed to view the Coast, and take the Soundings from hence to Elseneur, in order to find out a proper Place for making a Harbour for the King's Gallies, having made Choice of Niebo, and his Majesty having approved of the Plan that was presented to him for that Purpose, the same is ordered forthwith to be carried into Execution. We are informed by our last Advices from Madrid, that the Negociation which was on Foot for fome Time at that Court by the Members of our Asiatick Company, in order to obtain the Liberty of carrying on a Trade from Tranquebar to the Islands of the Manilles, is entirely broke off, the Spanish Ministry having absolutely refused to hear any Thing farther in Relation to that Affair.

Ratisbon, Feb. 25. The following Incident feems to excite the Attention of the whole Circle of Franconia. A Gentleman of the Empire, named Ritter, the last of his Family, dying some Days ago, the Margrave of Brandebourgh-Onoltzbach sent immediately a Detachment of his Troops to take Possession of his Estate, as a vacant Fief; but as the Bishops of Bambourg and Wirtzbourg, and the Magistrates of the Town of Nurembourg, form the same Pretentions, and have likewise each sent a Body of Troops thither, 'tis imagined it will soon become a very serious Assair.' The Danube is now free from Ice, and the Navigation of that River is cartied on as before the Frost.

Dresden, Feb. 26. A Camp is to be formed next Summer in the Neighbourhood of this City, which will consist of about twenty or two and

twenty thousand Men.

Berlin, Feb. 28. There have been several Cabinet Councils held at Potzdam within these two or three Days past, and itis said they were occasioned by some Dispatches received from M. Mitchell, who is charged with the Affairs of this Court at that of London. A few Days ago a Courier was sent from hence to Vienna, with Dispatches relating to the Disputes between this Court and that of Great Britain. All the Officers who are on their Parole, or Recruiting, have received Orders to join their respective Regiments by the 15th of hext Month, being the Time they usually begin to exercise the Troops in order to prepare them for the Reviews.

Dusselderp, March 2. On the 24th of last Month an Experiment was made near the Village of Lindorff, of a Machine, of a new Invention, for drawing Water out of Mines, which answered entirely to the Satisfaction of all pre-

sent. They write from Vienna, that the Empress Queen has sent Orders to Bohemia and Moravia, for putting the Militia of those two Countries upon the same Footing with those of France.

Paris, March 2. The Parliament having, by an Arret of the 21st of last Month, ordered the Bishop of Orleans, and the three Superiors of the Hotel Dieu of that City, to attend their Chambers, in order to be examined touching a new Resusal of the Sacraments to a Nun of the Abby of St. Loup at Orleans, the King issued the next Day his Letters Patents to stop their Proceedings, which being delivered to them, great Debates arose, at last it was determined to postpore the Registring the said Letters Patents, and so make Remonstrances thereupon to his Majesty.

Brussels, March 5. An Ediet was published here a few Days ago, by Order of her Imperial Majesty, which permits the old Escalins of this Country to pass current till the 1st of May next, after which they are to be deemed only as base

Hague, March 6. Our Lords the States of this Province are to open their Assembly Tomorrow, for which Purpose most of the Members are already arrived. Great Preparations are making at the Hotel of Prince Maurice for celebrating, on Thursday next, the Anniversary of the Birth of his Serene Highness the Prince Stadtholder. We learn from Ziericzee, that M. Jean-Corneille Ockerse, Pensioner of that Town, died there on Thursday last, in the 32d Year of his Age.
