Moscow, April 19.

ESTERDAY in the Afternoon an extraordinary Council was held at Count Bestuchess's; upon some Dispatches lately arrived from the Court of Vienna. As there are no Preparations making for her Imperial Majesty's intended Journey to Kiow, 'tis imagined that Journey will not take Place this Summer.

Naples, April 27. Advice is arrived at Court, that our Chebecks have fallen in with and taken a Tunisian Corsair of 18 Guns and 150 Men, off Messina, which they have conducted to Palermo, in order to her performing Quarantine.

Lèghorn, April 30. We learn by our last Letters from Corsica, that since the Departure of the French Troops from that Island, the Malecontents have made several Attempts to drive the Genoese from the Posts of Paludella and San Fiorenzo; but as they have always been repulsed with Loss; 'tis imagined they will make \*no more Attempts on that Side. The same Letters add, that the Malecontents have seized upon one of their Chiefs, whom they accuse of having carried on a secret Correspondence with the Marquess de Grimaldi, the Republick's Commissary General in that Island. They write from Florence, that the Hereditary Prince of Anspach arrived there on Monday last from Rome; and that his Highness was to continue his Journey in a Day or two for Germany.

Genoa, May 3. The Chevalier Chauvelin, the French Envoy Extraordinary and Minister Plenipotentiary to this Republick, had his Audience of Leave of the Doge and Senate on Friday last, and proposes to set out the Beginning of next Week on his Return to Paris; and M. Faucher, his first Secretary, is appointed to take Care of the Affairs of France at this Court, till the Arrival of another Minister. We are informed by the Master of a Pink lately arrived from Bareelona, that the Fleet which has been for some Time equipping in the different Ports of Spain, will put to Sea some Time in July. We are informed, that besides the Orders given some Time ago by his Catholick Majesty, for putting his Troops on the same Footing they were at the Time of making the late Peace, Orders are fince issued for making some Augmentations to the Army. Prince Doria, who went from hence to Turin, to take the Investiture of

certain Fiefs which he is possessed of in the Dominions of the King of Sardinia, is returned here from thence, greatly satisfied with the Reception he met with at that Court.

Dantzick, May 6. The Contentions between the Clergy and Nobility of the Kingdom of Poland, become every Day more serious; and 'tis feared they will be attended with bad Confequences.

Stockholm, May 8. The King, who went on the 3d Instant to Ulrichsdahl, being the first Time of his Majesty's going Abroad since his late Illness, returned Yesterday to his Palace in this City, in perfect Health. The Prince Royal is also recovered of his late Fever, and appears in Publick as before. Baron Roth, the Prussian Minister; has obtained his Letters of Revocation, and intends to fet out soon on his Return to Berlin; his Prussian Majesty having appointed M. de Molzan to come here in his Room.

Breslau, May 8. The Troops assembled at Lissa, having passed in Review before his Prussian Majesty, separated on Friday last, and are all returned to their respective Quarters. The same Day, about Noon, his Majesty arrived here, and set out early the next Morning for ' Neis, on his Return to Potzdam.

Vienna, May 12. Her Imperial Majesty has added four Professors of Equity to the University of this City, on each of whom she has settled a considerable Income. A large Quantity of Artillery has been embarked upon the Danube within these sew Days past, being intended for the Use of the Camp that is going to be formed at Kitsee.

Leipsick, May 15. Their Polish Majesties, accompanied by the Prince Royal, with the Princess his Spouse, and the Princes Xavier and Charles, and attended by most of the principal Lords and Ladies of the Court, arrived here on Sunday last from Dresden, on Purpose to honour the Fair of this Place with their Presence, for some Days; since which the Nobility and Gentry are continually coming in from all the Country round us, which makes our Fair this Year extremely brilliant.

Berlin, May 15. The King arrived here last Night from Silesia in persect Health. His Majesty has appointed M. Negelein to be Counsellor of the Court of Justice of Koningsberg, vacant by the Death of M. Sahme. A great Number of Foreign Officers are arrived here, in order :

On Thursday Night last an Express arrived here, with an Account of the Death of Prince Maximilian of Hesse, Brother to the Spouse of Prince Henry, for whom this Court will go immedi-

ately into Mourning.

Paris, May 18. Their Majesties, and all the Royal Family, went on Monday last to Marly, where they propose staying till the 30th Instant. His Majesty has appointed the Duke d'Aiquillon, to be Commander in Chief in the Provinces of Bretagne. On Saturday last a Fire broke out in the Street called Deux Ponts, in this City, which consumed four Houses, and damaged several others. We-have Advice, that the Archbishop of Sens, died at his Archiepiscopal Palace, at Sens, on the 11th Instant, in

the 76th Year of his Age.

Brussels, May 20. On Sunday last, being the Empress Queen's Birth-day, Prince Charles of Lorrain, our Governor General, went in great State to the Church of St. Gudule; where were likewise, the Members of the Privy Council, the Council of the Finances, that of Brabant, the Chamber of Accompts, and the Magistrates of this City in a Body. When Divine Service was over, his Highness returned to the Palace, where he received the Compliments of the Nobility, Foreign Ministers, and Gentry, on that Occasion; after which he dined in Pub-· lick, and at Night gave a grand Supper, and afterwards a Ball for the Entertainment of the Ladies. The Regiment of Prince Charles of Lorrain, which is here in Garrison, passed in Review last Friday before the Commissaries of War, and made a fine Appearance. Last Week four Companies of the Regiment of Trip's Dragoons, in the Service of the Dutch, arrived at Tournay from Maestricht, where they have been - for a long Time in Garrison.

Hague, May 22. The Deputies of the several Colleges of the Admiralty of these Provinces have opened their Assembly, and apply themselves, with great Attention, to the Assairs of their Department. The Regiment of Dutch Guards is to be reviewed To-morrow in the Mall, as is that of the Swiss Guards the Day sollowing. A Solemn Deputation, from the Province of Frizeland, is expected here Tomorrow, in order to execute a private Commission from that Province, with her Royal High-

ness the Princess Governante.
