Moscorv, June 8.

HE New Summer Palace, which the Empress had ordered to be built in this Capital, being entirely finished, her Imperial Majesty begun her Residence there some Days ago. The Repairs of the Damages occasioned by the late Fires, are carried on with the greatest Diligence; and the Empress has been graciously pleased to order the greatest Part of the Timber, and other Materials, for the Rebuilding of the Houses, to be furnished at her own Expence. And by her Imperial Majesty's Commands, all possible Measures are taken to prevent the like Misfortunes for the future; for which Purpose the Guards in the several Quarters of the Town have been considerably augmented; and all Housekeepers have been strictly enjoined to keep themselves constantly provided with a certain Quantity of Water, sufficient for the extinguishing of a Fire, whenever it may happen.

Naples, June 9. Upon Advices received, that a great Number of Barbarian Corsairs were putting to Sea, to interrupt our Navigation, Orders have been given to equip, with all possible Diligence, some Men of War and Frigats, in order to form a Squadron, effectually

to disperse those Pyrates.

Naples, June 12. A Usurer of this Place, called Murepa, having been committed to Prison some Time ago, for his illegally lending Monies to several private Persons at a very high Interest, has made an Offer of giving a considerable Sum to the Poor, in order to obtain his Liberty; but the King being informed thereof, far from indulging his Scheme of flying from Justice, by bestowing Alms at other People's Expence, has strictly charged his Judges to proceed against him, according the Rigour of the Law; and he will soon be brought to his deserved Punishment.

Turin, June 18. The Dutchess of Savoy is so savoy is so far advanced in her Pregnancy, that it is supposed her Delivery will happen-the Beginning of

September.

Aranjuez, June 18. Last Week the Duke of St. Elizabeth arrived at this Court, and had the Honour of being presented to their Catholick Majesties. He is come to reside here, in Quality of Minister Plenipotentiary from the King of Naples, during the Absence of Prince Jaci, who has

Obtained Permission to return home for some Time on his private Affairs. The Infant Cardinal, who has been here ever since the King's Name-Day, sets out this Evening on his Return to St. Ildesonso. By Letters from Cadiz of the 5th Instant we learn, that Advice had been received there from Carthagena de Indias, of Don Pedro de la Cordas having taken a Dutch Ship, with a Prussian Passport, trading on that Coast: She is said to have had 60,000 Dollars on board.

Warfaw, June 19. On the 14th of this Month, at Three o'Clock in the Afternoon, a violent Fire broke out in the New Street, where the Pope's Nuncio lives; and notwithstanding all possible Means were used to extinguish the Flames, several Houses were entirely destroyed. We here from the Frontiers of the Ukraine, that a considerable Body of Haidamacks, have again made an Incursion upon our Territories, and that they had not only plundered several Places, but also murdered the Inhabitants.

Vienna, June 20. The Emperor is returned, with his Brother Duke Charles of Lorrain, from Hollitch to Schonbrun. The Bailli Majo, Envoy Extraordinary from the King of the Two Sicilies, arrived here Yesterday, and is soon to have his first Audiences of their Imperial Majesties, and the Arch-Dukes and Arch-Dutchesses. An Ordonnance has been published this Morning, whereby the Trusting of Officers, and all other Military Persons, is limited to certain Sums, and certain Rules, in respect to the Mortgaging of their Pays.

Franckfort, June 25. We hear from Bamberg, that the Election of a new Prince-Bishop of that Place, is fixed for the 31st of next Month; and that there are, amongst other Candidates, Count Stadion, Baron Rechtolsheim,

and Count Seinsheim.

Dresden, June 25. On the 18th Instant the Troops that were encamped at Ubingau, separated; and the Regiments of our Garrison, which had made Part of them, viz. Grenadiers, Footguards, and Prince Clement's, returned hither the same Day. The Foreign Officers, and other Persons of Distinction, who have been present at the Exercises of the said Troops, are setting out in order to return to their respective Residences.

Paris, June 25. The Dauphiness being entered in the Sixth Month of her Pregnancy, publick Prayers, for her Royal Highness's safe

Berlin, June 27. The King has conferred on M. de Kalnein, Major General of Foot, and Colonel of a Regiment, the Rank of Lieutenant General; and, amongst several other Military Promotions, M. Heyde, and M. Lossau, both Captains in the Regiment of Konigsberg, have been raised to the Rank of Majors. Count Puebla, their Imperial Majesties Envoy Extraordinary at this Court, is soon expected here on his Return from the Baths of Carlsbad.

Franckfort, June 27. According to our Advices from Landau, and other Places in Alfatia, there are so little Signs of a Camp to be formed in that Province, that it begins to be doubtful

whether it will take Place this Year.

Munich, June 28. Their Electoral Highnesses, who are still at Lichtenberg, are expected
back at Nymphenberg towards the Beginning of
next Month. Friday last, being the Birth-day
of the Princess Consort of the Duke Clement of
Bavaria, the same was celebrated here in a very
grand Manner.

Cologn, June 28. The Countess Uhlseld, Spouse of Count Uhlseld, Grand Master of the Empress's Houshold, arrived here Yesterday, and will set out this Morning for Spa, where she intends to make Use of the Waters of that Place.

Hague, July 1. The States of Holland and West-Friesland are to continue their Deliberations next Tuesday. M. Hiemstra has been introduced into the Assembly of the States General, as one of the Members of that august Assembly, for the Province of Friesland.

Hague, July 3. M. de Cheusses, Chamberlain to the King of Denmark, is arrived here, in order to succeed the late Count de Dehn, as Envoy Extraordinary and Plenipotentiary from his

Danish Majesty to the States General.

Hague, July 5. The States of Holland and West-Friesland assembled this Day. Count Henckel de Donnersmarck has taken the Oath as Colonel Commandant of the Prince of Baden-Baden's Regiment. General Baron de Burmania, who has been taking Possession of his Governments in Dutch Flanders, is returned hither.

And for the notifying this Order, it is further ordered, That the same be forthwith inserted in The London Gazette, The Daily Advertiser, and London Evening Post.
