who, jointly with Count Montecuculli, has executed here some important Commissions on the Part of the Duke of Modena, set out a sew Days ago on his Return to his Court. Their Imperial Majesties, willing to give that Minister Proofs of their Approbation of his Conduct, ordered him, before his Departure, a Present to the Value of 12,000 Florins.

Parma, June 28. The Infant Duke our Sovereign continues at Colorno, whence his Royal Highness goes from Time to Time to

Sala, to take the Diversion of Hunting.

Copenhagen, June 30. His Majesty, the Queen, and the young Royal Family, return To-morrow to Friedensburg, and are to dine

with the Queen Dowager at Hirscholm.

Dresden, July 1. The Dutchess Dowager of Courland, and the Dutchess of Saxony-Weissenselds, after a Stay of about three Weeks at this Court, are set out from hence, the first con her Return Home, and the other for Top-litz, to use the warm Baths of that Place. Sir Charles Hanbury Williams, his Britannick Majesty's Minister, returned hither from Vienna some Days ago. Two Deputies from Thorn in Poland are arrived here, on Account of the Difficulties arisen about the Building of the Protestant Church in that Town.

Berlin, July 3. The King's Reception from Prince Maurice of Anhalt Dessau, in his Passage through Stratgard, was so agreeable to his Majesty, that he has been pleased not only to express his Satisfaction on that Occasion, but to present his Highness with a Diamond Ring,

computed to be worth 2000 Crowns.

Berlin, July 4. The Queen continues her Residence at the Palace of Schonhausen, where her Majesty has begun the Use of some Mineral Waters. Prince Ferdinand is gone to visit his Regiment at Ruppin, where it is in Garrison. The Major General de Meyering is returned from Carlsbad, whether he went to use the Baths.

Hanau, July 6. The Duke of Ursal arrived here last Monday Night from Brussels, with a numerous Retinue, and proceeded the next Day on his Journey to Vienna, whence he proposes to wait on their Imperial Majesties to the Camp of Kittsee in Hungary.

Hague, July 8. On Friday her Royal Highness the Princess Governante was present at the Deliberations of the States of Holland and Westfrizeland; which Assembly separated Yester-

day.

Hague, July 12. The Baron de Borsselen is returned hither from Zealand. Her Royal Highness the Princess Governante, and their Serene Highnesses the Prince Stadtholder, and the Princess Carolina, will set out next Wednesday for Dieren, Part of their Baggage being already sent thither.

Brussels, July 9. The Deputies of the State of Flanders, who are returned hither, have had last Week several Conserences with the Mar-

quess de Botta d'Adorno. It is resolved to finish, without Delay, the Works relative to the Canal of Bruges; as likewise the Rebuilding of the Sluice of Schlick.
