Naples, June 19.

HE 13th Instant being the Birth-Day of his Royal Highness the Hereditary Prince, who enter'd into the Sixth Year of his Age, the same was celebrated at Court; and in the Evening there was a triple Discharge of the Cannon of the Fortresses. On the 18th the Bali Buegnes arrived here from Malta, with full Powers from the Grand Master to the King, to treat and reconcile the Disagreements with the Bishop of Siracula, relating to the Visitation, which the latter insists upon having a Right to make, to the Bishoprick of Malta, as Suffragan of that of Siracula.

Rome, June 23. On the 16th Instant anchor'd at Civita Vecchia, on their Return from Marseilles, three of the Pope's Gallies, which had attended M. di Calignac, which, after having taken in some Resreshments, were ordered again to Sea on a Cruize against the Barbary Pyrates. On the 17th the Prince of Ardore, the late Neapolitan Ambassador to the French Court, who arrived on the 11th Instant from Paris, fat out with his Lady and Family, on his Return to Naples. On the 21st M. Stadion, the German Auditor di Rota, received a Courier, who, it is faid, brought an Account of the Death of the Prince and Bishop of Bamberg. The same Day, being the Festival of Corpus Christi, the Pope, who is at Castle Gandolfo, attended by feveral Cardinals and Prelates, and many Gentry, performed the Function of the usual Procession on that Occasion.

Rome, June 25. There are Advices from Turin, that M. Merlini, the Pope's Nuncio,

is dangerously ill there.

Florence, June 29. A few Days ago the Marquis Alamanni, a Florentine Nobleman, and Inspector of the Silk Manufacture, who had always been esteem'd a very prudent Man, was found dead in his Bed, with eight Wounds, which he had given himself with a Penknise: The strictest Examination has been made, by Order of the Government, into every Circum-Stance relating to this tragical Action, but nobody pretends to guess at the Motive of it. The Celebration of the Feasts of St. John having been deferr'd on account of Corpus Christi

Day, till this Morning, M. Tornaquinci, the Secretary of State, whole Turn it was to reprefent the Emperor's Person on this Occasion, being attended by all the different Magistrates of this City, and a proper Guard, received the publick Homage on the Great Ducal Place, from the respective Towns and Feudatories of Tuscany, and every Thing passed with great Decency and Magnificence. On the 26th M. Arostequi, Ambassador from the King of Spain to the Court of Naples, arrived here from Parmain his Way to Naples. On the 28th General Salins returned hither from the Pisa Baths, where he had been a few Weeks for the Benesit of those Waters. Last Week arrived here the Earl of Pembroke, the Earl of Dartmouth and Lord North, the Earl of Tylney, Lord and Lady Kilmurry, Lady Chapman, and many other English Gentlemen.

Copenhagen, July 2. The King, amongst other Military Promotions, has conferred the Rank of Lieutenant General on Major General de Reitzen. Prince Frederick-Francis of Brunfwick Wolfenbuttle set out last Monday on his Return to Germany, after having been presented by his Majesty with a very fine Gold Snuffbox, enriched with Diamonds, as a Token of his Majesty's particular Esteem and Affection. General Numsen has received a Gratification from his Majesty of 4000 Crowns, as a Reward for the extraordinary Expences he has been at, on Occasion of the late Camp, of which he had the Command.

Paris, July 6. On the 29th of last Month some Deputies from the Town of Havre de Grace, with the Duke de St. Aignan, Governor of that Place, and several other Persons of Distinction at their Head, were introduced to the King, and had the Honour to present his Majesty with a printed Relation, illustrated with Copper-Plates, of his Majesty's Journey to and Residence in that Town in the Month of September 1749. They met with a very gracious Reception, as well from the King, as afterwards from the Queen, the Dauphin, and all the Royal Family; to whom they had also the Honour to present the like Token of their Respect and Loyalty.

Gologn, July 9. Julius-August, Count of la Mark and Schleiden, Privy-Counsellor of his Serene Highness the Elector Palatine, General of Foot, and Governor of the Dutchy of Juliers, &c. died here last Night, aged 73.
