Moscow, June 24.

HE Empress, accompanied with the Grand Duke and Dutchess of Russia, are returned hither from the Convent of the Trinity, where her Imperial Majesty and their Highnesses have passed the Holidays. Great Magazines are erecting for the Subsistance of the Troops which are to form a Camp in the conquer'd Provinces, for which Purpose the Leave which had been given to export Corn out of Livonia, Esthonia, and Courland, is suspended. General Baron Pretlack, Ambassador from the Court of Vienna, is preparing to set out on his Return to his Court, on the Arrival of his Successor Count Esterhasi. Orders have been given by her Imperial Majesty to pull down all the wooden Houses in the Neighbourhood of the Palace of Kremelin, and to build others with Stone.

Genoa, July 2. Among the Ships that arrived last Week, there was one from Bastia, by which we are informed, that the Deputies of the Pieves of the Island of Corsica, continued to have frequent Conferences with the Marquis of Grimaldi, Commissary General of this Republick; and it was not doubted, but that the Affairs of that Island would at last be brought to a happy Conclusion.

Modena, July 7. On the 2d of this Month was celebrated here, with great Splendor, the Birth-day of the Duke our Sovereign, who then entered into the 56th Year of his Age. His most Serene Highness intends going next Week to Mirandola, to visit the Fortifications of that Place, and at the same Time to review the Troops which are there in Garrison.

Warsaw, July 9. Last Friday we received Advice that some Incendiaries had set Fire to a Castle situated a little Distance from Kaminieck, belonging to the Countess of Renard, Wife to the Count of that Name, and General of the Infantry, and that the said Building, together with many other adjacent ones, had been entirely confumed by the Flames: The Damage whereof is computed to amount to little less than 50000 German Florins.

Madrid, July 9. On the 6th Instant their Catholick Majesties returned from Aranjuez to their Palace of the Buen-Retiro, where they will reside the Remainder of the Summer. This Day being the Anniversary of the late King's Death, the Court wore Mourning upon that Occasion. Prince Jaci, the Neapolitan Ambassador, sets out To-morrow for St. Ildefonso, in order to take his Leave of the Queen Dowager;

· after which his Excellency will continue his Journey to Naples.

Vienna, July 11. Field Marshal Prince Werlcessas of Lichtenstein returned hither on Saturday last from his Tour into Saxony: His Highness went the same Evening to Schonbrun, where he had a private Audience of their Imperial Majesties. The next Day the Marriage of Count Sigismond of Hessenstein, with the Countess Maximilian of Pitazzi, Daughter of the General of that Name, was celebrated at Court, and M. Sherbelloni, the Pope's Nuncio, performed the Ceremony.

Hambourg, July 13. Count'de Sack, who is appointed Minister from Saxony at the Court of Sweden, is expected here towards the latter End of this Month, on his Way to Stockholm; and M. de Malzatin, named for the same Court; on the Part of his Prussian Majesty, takes his Route likewise thro' Hambourg, and will be here, 'tis thought, much about the same Time.

Manheim, July 14. The Elector our Sovereign has appointed the Prince of Deux Ponts. Governor of the City and Citadel of Juliers, in the Room of the late General Count de la Marck:

Brussels; July 16. The Empress our Sovereign having appointed M. Veisyden de Varick; to be Councillor of the Chamber of Accounts for Brabant, he last Saturday took the usual Oaths in that Quality, and has entered upon the Execution of that Employment.

Berlin, July 17. The King, accompanied by Frince Ferdinand of Brunswick, and attended by a great Number of General Officers, arrived here on Wednesday Evening. His Majesty alighted at the Castle, and after having given some Audiences, went to Mont Bijou, and supp'd with the Queen Mother and the Royal Family; and the next Motning returned to Potzdam.

Hambourg, July 17. We are informed from Stockholm, that as foon as the Regiment of Guards, which had been encamped near Ulrichsdahl, was gone into Quarters, the Court removed from thence to the Country Palace of Drotningholm, where the Queen proposes to reside till towards the Month of September, when her Majesty's Delivery is expected; and that the King intends, in about three Weeks, to make a Tour into some of the Provinces. which confirms the Accounts of that Prince's being recover'd from his late Indisposition. . An Ordonnance has been publish'd to forbid any Subject of Sweden, of what Rank or Condition soever, to go out of the Kingdom, either

upon Business, or for Amusement, or to engage in any foreign Service, without a special Leave from the King, upon pain of being treated as Deserters.

Whitehall, July 28.

The King has been pleased to constitute and appoint Humphry Fowle, Esq; Sir Moore Molineaux, Knt. John Paul Yvounett, and Edward Montague, Esqrs. together with Robert Coney, Esq; in the Room of Edwin Coney, Esq; to be his Majesty's Commissioners for Appeals and regulating the Duties of Excise.
