TYHEREAS His Majesty hath received Information, that great Numbers of ill disposed and disorderly Perfons, dwelling in or near the Forest of Kingswood in the County of Gloucester, did, on Monday the Twenty First, and on Friday the Twenty Fifth Days of May last, in a Riotous and Tumultuous Manner assemble themselves thear to the City of Bristol, and armed with Clubs, Pitchforks, and other offensive Weapons, and with a Drum beating before them, did, on both the said Days, proceed to the said City, and did there commit many great and enormous Outrages, in open Defiance of all Law, and to the Terror of His Majesty's good Subjects—And whereas it appears by Informations taken on Oath, and this Day laid before His Majesty in Council, That Sampson Phips, Samuel Britten, John Woody otherwise Wordy, and John Summers, Coalminers, and also Hezekiah Hunt, Cordwainer, were very active in one or both of the said Riots, and were principal Leaders therein; which said Sampson Phips, Samuel Britten, John Woody otherwise Wordy, John Summers, and Hezekiah Hunt, are fled from Justice: To the End therefore that the faid Offenders, and every of them, may be brought to condign Punishment—His Majesty is pleased to order, by and with the Advice of His Privy Council, that the Sum of Two Hundred Pounds shall be paid to such Person or Persons as shall discover and apprehend, or cause to be discovered and apprehended, the said Sampson Phips, so as he may be convicted of the said Offence; and that the Sum of One Hundred Pounds shall in like Manner be paid to such Person or Persons as shall discover and apprehend, or cause to be discovered and apprehended, either of them the faid Samuel Britten, John Woody otherwise Wordy, John Summers, and Hezekiah Hunt, so as they, or

Offence: Which said respective Sums the Lords Commissioners of His Majesty's Treasury are hereby directed and required to pay accordingly. -And his Majesty doth hereby strictly charge and command, all Justices of the Peace, Mayors, Bailiffs, Constables, and other Peace Officers, and all His loving Subjects, that they do use their utmost Diligence, by all lawful Ways and Means, in and about the apprehending the said Offenders and every of them.

Algiers; June 15: Though the Plague continues to make a great Havock amongst the Inhabitants of this Place, it don't lessen in the least the Activity of the Corsairs, who are actually equipping several Chebecks; and other Warlike Vessels, to carry on their Piracies.

Constantinople, June 16. The Porte is very vigilant to prevent any interior Disorders. We have had no Fires of late. The Heads of several Highwaymen have been brought hither from Asia.

Moscow; June 28. The Empress is again returned to the Country, where her Imperial Majesty intends to stay a Fortnight or three Weeks. The Troops that are to form a Camp on the Frontiers of Livonia, by her Imperial Majesty's Orders, are already drawn together at their general Rendezvous, 2 or 3000 Hustars, and 8000 Donith Cossacks, only excepted.

Madrid, July 5. The King has been pleased to grant the Place of Corrigidor of the City of Benabarra, to Don Angelo de Figueroa. His Majesty has given Orders to built a Fort at Jonquiera, in the Province of Catalonia, similar to that which is building at Figuiera, for the greater Security of that Province. Two eminent Physicians are set out from hence for St. Ildefonsa, on account of the Queen Dowager being indisposed at that Place.

Naples, July 5. We hear from Civitella, in the ulterior Abbruzzo, that at the latter End of last Month, they had felt, for several Days together, at the Rising and Setting of the Sun, very strong Earthquakes, some Shocks of which

had lasted five or six Minutes, but without be-

ing attended with any Damage.

Genoa, July 9. The late Insurrection at St. Remo is entirely quelled, the Inhabitants having paid 200000 Livres in ready Money, and about goooo in Oyl; they are now to build a Castle to contain 200 Men, with a Governor and Officers. Letters from Bastia of the 2d Instant advise, that the Deputies from Corsica were to assemble at Corti, in order to receive their In-Aructions, and then to go to Bastia to treat with the Republick's Commissary General for an Accommodation.

Ratisbon, July 14. The Ministers of the Protestant Princes of the Empire have again held a great Affembly for some Days, in which, amongst other Deliberations, they have agreed to take more efficacious Measures than those they have as yet made use of, in order to get Redress of the Grievances of which several Protestant Communitities have already made their Complaints, at several Times to the Aulick Council of the Empire, without the defired Success. According to our Advices from Bohemia, great Preparations were continued in that Kingdom for the feveral Camps of Imperial Troops which are to be formed there in the Course of next Month.

Berlin, July 18. The Queen continues the Use of the Mineral Waters with great Success at Schonhausen, where the Princess Consort of his Royal Highness the Prince of Prussia waited on her Majesty last Saturday. The same Day arrived here from Glatz, the Baron La Mothe-Foucquet, Lieutenant General of Foot, and Commandant of that Place, who went the next Day to Potzdam, where he was to receive some particular Orders from the King. The Marquess of Castromonte, a Spanish Nobleman of great Distinction by his Birth, who is visiting the principal Courts of Europe, arrived here some Days ago from Hanover, and has already had the Honour to be presented to the Queens, and to the Princes and Princesses of the Royal Family.

Berlin, July 21. Some Days ago a considerable Number of Troopers, belonging to his Royal Highness the Prince of Prussia's Regiment, mutinied against one of their Officers; they pretended that he had killed one of their Comrades by severe Usage, and in Consequence thereof re- | Repairs which are making to the Prince Stadtholfused to attend the Burial of the deceased. This . Disobedience has been severely punished, as contrary to the Military Discipline, so strictly observed amongst the Prussian Troops. Every one of the Mutineers was arrested, and a Council of War being held, eight of them were sentenced to be hanged, and were immediately executed; the others, less guilty, have ran the Gauntlet two successive Days.

Compiegne, July 18. The King has disposed of the late Count Egmont's Regiment of Dra-1

goons in Favour of M. de Marboeuf, Lieutenant Colonel of the Dauphin Regiment of Horse and of a Brigade in the Life-Guards, vacant by the Chevalier de Sommery's retiring from the Service, in Favour of the Chevalier de St. Sauveur, Brigadier of Dragoons. Lieutenant General Gourdon de Legliriere, Director of the Fortifications of the Towns and Ports in Normandy, died at Paris last Saturday, in the 67th Year of his Age.

Franckfort, July 19. It appears by several Advices which we have lately received from Alsatia, that there is no Likelyhood of a Camp

to be formed there this Year.

Copenhagen, July 21. Two of the four Danish Frigates which were sent out at different Times to the Coast of Barbary, are now returned hither, the third is hourly expected with Colonel Longueville on board, a Treaty of Peace and Commercé having been concluded between Denmark and the Emperor of Morocco, in Confequence whereof that Minister and his Followers are redeemed; but the fourth Frigate, called the Falster, a Forty Gun Ship, had the Misfortune, on the very Day of Rejoycing for the Conclusion of the Peace, and the Delivery of the Captives, to take Fire and blow up. The, Captain, who affisted at the Entertainment given on that Occasion by the Commodore, escapedi with 186 of his Men, but the Remainder, being above 100, perished, except about 20, who got to shore near Saffy, where this Accident happen'd, and are as yet in the Hands of the Moors; 'tis hoped, however, that their Liberty may be obtained without Ransom, One of the aforesaid Frigates having been at Tunis, has brought a Present of Animals from the Rey of that Place: They both lie in the Road at some Distance from hence performing Quarantine.

Hague, July 21. Their Serene Highnesses the Prince Stadholder and the Princess Carolina took a few Days ago an Airing to Ryswyok, where they were entertained with a magnificent Colation by Count Golofkin, the Russian Am

bassador.

Hague, July 24., Count Charles Bentink,

Hague, July 26. Her Royal Highness the Princess Governante came this Morning here from the Palace-in the Wood, in order to view the der's 'Apartments at Court. Her Royal Highness intends to set out next Saturday with their 1/2 Serene Highnesses the Prince Stadtholder and Princess Carolina, for Soestdych, where the Court will remain for Part of the Summer. The Detachments of Life-Guards, who are to escort their Highnesses to the said Country-Palace, have already been ordered to fet out for their respective Posts.
