Constantinople, August 16.

Zade Effendi, who was formerly Musty, and has been some Time exiled at his House on the Bosphorus, died there a

few Days ago.

Moscow, Aug. 20. From the Preparations which are making at Court, it is believed that the Journey, which the Empress has for some Time proposed making into the Ukraine, will foon take Place; and we are informed, that by the Care of Count Rasoumossky every Thing is actually ready at the Castle of Kiow, for the Reception of her Imperial Majesty and her Retinue. As the Troops, which have been for some Time encamped on the Frontiers of the said Province, and which were to have separated at the End of this Month, in order to return to their respective Quarters, have received Orders to remain encamped during all the next Month, it is inferred from thence, that her Imperial Majesty, in her Journey to Kiow, may make a Tour to that Camp. The Marquis d'Arragona, a Neapolitan Nobleman, is arrived here, in order to engage himself in the Service of this Court. He is soliciting the Rank of Colonel, and there is a great Appearance that it will be granted him.

Naples, Aug. 28. Within these few Days two Projects have been presented to the King, which, if they are put in Execution, cannot fail of producing great Advantages to the Commerce; the first is, to erect a Causey or paved Road, which is to reach from Salerno almost to Reggio in Calabria, in order to facilitate the Transportation of Merchandize between these two Cities; and the second is, to turn the Course of the Volturno, to render that River na-

vigable, and to make it pass by Caserta.

Genoa, Sept. 1. The Prince d'Yachi, who was formerly Ambassador from the King of the Two Sicilies to the Court of Spain, passed thro' this City a few Days ago, on his Return to Naples. The last Letters which the Republick have received from Corsica, are not favourable, and give Room to apprehend, that the Troubles in that Island, instead of diminishing, will daily increase.

Genoa, Sept. 3. The Government has given Orders for arming again two or three Feluccas,

in order to send them to cruize on the Coasts of Corsica, that they may more effectually prevent the Malecontents of that Island from receiving any Provisions or military Stores.

Hermanstadt in Transylvania, Sept. 1. The States of this Principality, who opened their Diet on the 22d past, continued to deliberate on the Demands which have been made to them on the Part of our August Sovereign, by the Count Wenslas de Wallis, whom her Majesty

the Queen of Hungary has named her Com-,

missary to this Assembly.

Turin, Sept. 2. The Marquis de Crussol, Minister Plenipotentiary from the French King to the Court of the Infant Duke, arrived here from Paris the 29th of last Month: The next Day he had the Honour to be presented to his Majesty and the Royal Family, and the Day before Yesterday he continued his Rout to Parma.

Rome, Sept, 4. We continue to be affured, that the Promotion of Cardinals, which has been fo long expected, will take Place the 19th Instant.

Milan, Sept. 5. The Duke of Modena is soon expected here to take Possession of the Employment of Governor General of the Austrian Lombardy,; and every Thing is preparing with great Diligence at the Castle of this City, for

the Reception of that Prince.

Madrid, Sept. 6. On the 26th past, an Order, signed by his Majesty, was issued from the Secretary of State's Office, forbidding the Subjects of this Grown to carry on any Commerce with the Danes. There is Advice from Cadiz, that Don Venturo de Ozio, Administrator of the Customs, died there lately, and that he is succeeded by Don Francisco de Villasota, before Collector de Millones. From the fame Place we learn, that the Hon. Captain. Howe, Commander of his Majesty's Ship the Dolphin, now in that Bay, having been ordered to go to the Port of Sallee, to inform himself of the Intention of the Moors, with Regard to Great Britain, was answered, That their Defign was to observe their Treaties with his Britannick Majesty. The same Letters add, that a Dutch Ship from the Westward had seen six Algerines off Cape St. Mary's, which made People very uneasy for the South Sea Ships hourly

expected. M. Cloppenburgh, the Danish Conful at Cadiz, having received Orders from his Court to leave his Catholick Majesty's Dominions, was preparing to set out for London in his Way to Copenhagen.

Modena, Sept. 7. Every Thing is ready for the Journey which our Hereditary Prince propofes to make to the Imperial Court; and his Royal Highness, we are assured, will set out

about the End of next Week.

Vienna, Sept. 8. The Empress Queen has been so well fatisfied with the Exercise of the Body of the Corps of Artillery, which they perform'd lately in her Presence at the Camp of Maldau-Thein, that her Majesty has given Orders for making an Augmentation thereto of 500 Meh, and in Consequence thereof they are to be forthwith raised. By the last Dispatches which the Court received from Baron de Penckler, their Imperial Majesties Resident at the Ottoman Porte, we are informed that a contagious Distemper was again broke out at Constantinople, which daily carried off a great Number of People.

Ratisbon, Sept. 8. The Chevalier de Foilard, Minister from France to the Diet of the Empire, is again set dut to make a Tour into Franconia, in order to employ his good Offices, for an Accommodation of the Differences which still subsist among several Princes and States of

that Circle.

Prague, Sept. 8. The Camp which the Corps of Artillery had formed at Moldau-Thein, having broke up some Days ago, several Persons of Distinction in this City, who went to see it, , are let out from thence - to the Camp at Colin, which will not break up, as 'tis imagined, till the 15th of this Month. This Camp is composed of ten Regiments of Foot, viz. Francois de Lorraine, Henry Daun, Hildbourghausen, Jeune and Vieux Wolfembuttle, Wenceslas Wallis, Leopold Daun, Nicolas and Joseph Esternasy, and that of the Grand Master of the Teutonick Order; the two Regiments of Dragoons of Wirtemberg and Emanuel Collowrath; and that of Pretlack's Cuiraffiers. As Duke Charles of Lorraine, in his Return to the Low Countries, is expected to pass through this City, great Preparations are making for his Highness's Reception. The greatest Part of the Artillery which was made use of at the Camp of Moldau-Thein, having been drawn out of our Arsenal, was brought hither again a few Days ago.

Dresden, Sept. 9. Last Wednesday there was a splendid Appearance at Court, on Occafion of the Anniversary of the Birth of the Prince Royal and Electoral, who entered that Day into the Thirty Second Year of his Age. The King of the Two Sicilies has fent here one of his Gentlemen of the Bed Chamber, with the Order of St. Janvrier, to the young Prince Charles Maximilian, who will be forthwith in-

vested therewith. The Departure of the Court for Hubertsberg remains fixed for the 26th of this Month; and the necessary Orders have been given for their Majesties Reception at that Place. The Count de Mniszeck, Grand Chamberlain of the Dutchy of Lithuania, who has been here for Tome Time, set out Yesterday on his Return to Poland.

Bareith, Sept. 10. Last Thursday being the Birth Day of the Reigning Dutchess of Wirtemberg, Daughter of our Serene Sovereign, there was a grand Appearance at Court; and upon that Occasion M. de Margrave performed the Ceremony of conferring the Order of the Red Eagle on Count de Bosc, Grand Marshal, and on the Baron de Croix de Frechapple, his Great Chamberlain; his Highness at the same Time disposed of several Vacancies in the Regiment of Guards.

Brussels, Sept. 17. The Count de Cobentzel, who is come to relieve the Marquis de Bottar d'Adorno, as Chief Minister of the Empres Queen in the Low Countries, Yesterday took Possession of that Employment: In Consequence of which his Predecessor is preparing to return. immediately to Vienna, from whence he will repair to his new Post in Italy.

Cologn, Sept. 18. The Prince of Tour Taxis, Principal Commissary from the Emperor to the Diet of the Empire, arrived here last Night, with the Princess his Spouse, from

Bruffels.

Whitehall, September 25. The King has been pleased to constitute and appoint Sir James Gray, Bart. His Majesty's' Envoy Extraordinary to the King of the Two Sicilies.
