Constantinople, August 12.

N Ingineer, who has been for many few Days to all the I Years in the Service of the Grand Majesty's Dominions. been presented to the Grand Vizir, delivered to him an exact Plan of the Fortifications of that Island, with a Project setting forth the Methods to be taken for conquering the said Island. He was in Hopes of receiving an ample Recompence: And the better to infinuate himself into the good Graces of the Turks, he embraced their Religion; but the Grand Signior, who is naturally of a pacifick Disposition, did not appear to have given great Attention to the Advantages proposed by this Traytor; and it is believed he has been strangled by Order of his Sublime Highness, he not having appeared since that Time.

Lisbon, Aug. 29. The Court is still at Bellem, from whence the King makes a Tour from Time to Time to this Capital. A few Days ago a Fire broke out in the Park of Almerino, which consumed great Part of the Wood.

Naples, Sept. 8. On the 1st of this Month, about Six o'Clock in the Evening, we had a most violent Storm; accompanied with frightful Claps of Thunder. The Lightning fell upon the Church of the Nunnery of the Nuns of St. Sacrament, pierced the Roof, and set Fire to the Cieling; and from thence the Flames communicating themselves to the whole Building, it was in less than two Hours almost reduced to Ashes, notwithstanding all the Assistance that visions and Carriages as they may stand in Need could be given.

Palarma, Sept. 12. Two Neapolitan Men of War, which have for two Months past been cruifing against the Corsairs of Barbary, came into this Port on the 10th Instant, and as soon as they have taken in some necessary Resress. ments, they will return to their Station.

Madrid, Sept. 14. The Decree by which the King has thought proper to prohibit his Subjects having any Commerce with those of the Crown of Denmark, has been sent within these few Days to all the Ports and Havens of his

Master of Malta, arrived here the Milan, Sept. 14. The Installation of the latter End of last Month, and having Duke of Modena into the general Government of the Austrian-Lombardy being fixed for the next Month, every Thing is preparing here with great Diligence, that can be necessary for so splendid a Ceremony.

Rome, Sept. 15. The Maltese Ambassador had on Saturday last a particular Audience of the Pope, in which he communicated to him. the Dispatches which he had just received, relating to the Difference which has arisen between the King of the Two Sicilies and the Grand Master of the Order of Malta, concerning the Pretensions of the Archbishop of Syracusa.

Barcelona, Sept. 17. When we received here the King's Orders, in Regard to the Prohibition of Commerce with the Danes, there was a Danish Ship in this Road, and she was permitted to sail, having arrived here before the said Orders.

Venice, Sept. 18. The Republick, at the Requisition which has been made on the Part of the Court of Vienna, having granted a Passage through its Territories for a Body of Troops of about 10 or 12000 Men, which the Empress Queen is fending into Lombardy, the Senate has; in Consequence thereof, dispatched the necesfary Orders to divers Places of the Frioul, and of the Veronois, through which they are to pass, in order to their being supplied with such Proof.

Vienna, Sept. 19. The Empress Queen having lately received fresh Complaints from her Protestant Subjects in Hungary, her Imperial Majesty has thereupon been pleased to send Orders, expressly forbidding their being disturbed, in any Manner whatever, in the Exercise of their Religion. In the Chapter of the Order of La Croix-Etoilée, which was held last Fri-

day at Schonbrun, by the Empress Queen, her Imperial Majesty created seven new Ladies of that Order, viz. the Princess, Spouse of the Hereditary Prince of Modena; the Princess of Stolberg, born Princess of Hornes; the Countesses de Fuger, de Chamisto and de Kuffstein, and the Baronesses Marie Marguerite and Marie-Henriette de Mammingen.

Prague, Sept. 19. Prince Charles of Lorrain arrived here Yesterday in the Asternoon, and continued his Route for the Netherlands; and his Highness proposes to reach Brussels, on

the 20th Instant.

Copenhagen, Sept. 22. The President Ogier, who is appointed to succeed the Abbe le Maire as Minister Plenipotentiary from his most Christian-Majesty to this Court, arrived here last Wednesday, and is soon to have his first Audiences of the King and the Royal Family, Prince Ferdinand of Brunswick, the Queen's Brother, is expected here from Berlin, to pay a Visit to their Majesties. The Works of the new Haven at Nyebo are already considerably advanced, and it is supposed, that next Summer it may be ready to receive therein the King's Galleys.

Copenhagen, Sept. 25. The Marquis of Puente-Fuerte, Envoy Extraordinary from his Catholick Majesty to this Court, set out last Friday for Stockholm, where he is to reside with the same Character. Last Night a Fire broke out at the House of the Privy-Counsellor Count de Levetzau, situated upon the new Place of Amelienbourg; but by speedy Assistance, the Progress, thereof was stopt from doing much Damage.

Berlin, Sept. 25. The King has conferred on M. de Luderitz, Major General, and late Commandant of the Regiment of Oertz Dragoons, the Command of the Regiment of Curassiers of Prince Frederick. His Majesty has almade several other Military Promotions. The Duke of Brunswick-Wolfembuttle, and the Hereditary Prince his Son, set out from hence last Thursday on their Return to Brunswick. The reigning Prince d'Anhalt-Cothen set out the same Day to return to the Place of his Residence.

Cologn, Sept. 28. Prince Charles of Lorrain, accompanied by the Count de Vitrimont his first Gentleman of the Bed-Chamber, and attended with a numerous Retinue, arrived here Yester-

day about Seven in the Evening, and was faluted by the Cannon on the Ramparts. His Highnels did not stay longer than changing the Relays, and continued his Route for Masseck's where, before he goes to Brussels, he proposes to make a Visit to the Cardinal Prince Bishop of Liege.

Brussels, Oct. 1. On the 29th past Prince Charles of Lorrain arrived here, in persect Health, from Vienna, and received thereupon the Compliments of the principal Nobility. His Highness is preparing to set out for Marimont,

to take the Diversion of Hunting.

Hague, Oct. 2. Baron Burmania, one of the Members of the Council of State for the Province of Friezland, set out this Day for that Province. By the last Advices from Soestdyk, their Royal and Serene Highnesses con-

tinued in perfect Health.

Hague, Oct. 4. Field Marshal Duke of Brunswick Wolfembuttle, who atrived here some Days ago from his Government of Bois-le-Duc, set out on the 2d Instant for Soestdyk. According to the last Advices received from that Place, there is Room to believe the Court will not return from thence till the Celebration of the Anniversary of the Birth of her Royal Highness the Princess Governante.
