Constantinople, December 16.

HE contagious Distemper, which broke out some Time since in this City, is now entirely ceased. Letters from Aleppo of the 13th of No- Pyrates. vember say, that they had received Advice from Bassora, that Solyman Pascha, of that Place and Bagdat, had received the Sword and Sable Furr, sent by the Grand Signor, for his Victory gained over the Courds, and a full Confirmation of all the Governments he holds, or has held. They had received Advices from Banderuck at Bassora, which confirmed that Kherim Chaan, who had hitherto governed at Ispahan for some Time, had been twice vanquished by Azaat Chan, an Ophgoon, who has declared himself in Favour of one Schach Sultan Hussein, returned lately from Russia, where, it is said, he lay long concealed, and now gives himself for the Son of the late Schach Tamas: He governs, for the present, Ispahan and the adjacent Countries. Cherim Khan fled from thence, to attempt to seize Schiraz; but that Governor, who had submitted to him whilst he was at Ispahan, refusing him Admittance, he has laid Siege to it. Other Advices concerning this Schach Hussein fay, that though he has mentioned in his Manifest, his Arrival from Russia, it is certain, he was for a confiderable Time at Bagdat, with the Persian Ambassador Mustapha Khan, who was intended for this Court, and since that he has appeared in several Forms in the Kingdom of Persia; but we are without any certain Advice of his Success, without this from Bassora can be depended on.

Lisbon, Jan. 6. The Court having received repeated Advice of some Corsairs from the Coast of Africa being eruizing in the Mouth of the Tagus, and that they have actually taken several of our Fishing-Vessels, Orders were given for two Men of War to sail immediately in Quest of them. Two Ships accordingly put to Sea Yesterday Morning, and 'tis not doubted but that they will soon clear the Coast of this Kingdom from those Pyrates.

Genoa, Jan. 7. Advice having been received-at Court, that several armed Vessels were put to Sea from Tunis, in order to cruize in the Sardinian Sea, Orders are given for manning two of our Chebecks, which are to be stationed in such Manner as to protect the Navigation of this Coast from the Insults of those Pyrates.

Rome, Jan. 12. The Pope having appointed M. Buono to be Auditor and M. Perelli to be Treasurer of the Apostolick Chamber, they took the usual Oaths on Monday last, before the Secretary of State, to qualify themselves for their respective Employments. Within these sew Days past all the Beggars in this City have been taken into Custody by the Pope's express Order; those capable of Business are to be sent to Anzio, to work at the new Port which is making there.

Florence, Jan. 18. The King of the Two Sicilies has issued fresh Orders to forbid all Commerce between his Subjects and the Island of Malta, to seize the Effects belonging to that Order within his Dominions, and to sequester the Commanderies that belong to the Knights of that Order, who do not reside in his State. This is done in Consequence of the repeated Refusal which the Order of Malta has given to admit a Royal Visitation of the Cathedral and Bishoprick of Malta, which his Sicilian Majesty claims a Right to send at his Pleasure. As this Affair interests the Order of Malta where-ever dispersed, it has occasioned great Alarm, and has been generally disapproved of at Rome; from whence Orders have been sent all over the Ecclesiastical State, to supply the Island of Malta with Provisions, though it will be very inconvenient and dangerous for the Maltele to be obliged to go so much farther for all the common Necessaries of Life, which they used to be furnished with from Sicily. By Letters received Yesterday from Leghorn we have Advice, that the Day before a Tunefine Corsair, of 28 Guns and 350 Men, was forced into that Port by bad Weather. The said Corsair had made many Prizes in these Seas, which were sent to Tunis. This is the second Corsair that has taken Shelter in the Port of Leghorn within these few Days; évery Instance of which gives great Disturbance to the Commerce of it, by the Alarm

Alarm it occasions, both in the Port and all along the Coast, amongst the Officers of such Ships as belong to Christian Powers with whom

the Tunesians are not in Treaty.

Turin, Jan. 19. His Excellency Count Cra stiani arrived at Milan the 10th of this Month. He was faluted at his Arrival with 24 Guns, and the Tribunals of Justice, and the Nobility, went to his House to acknowledge him as their Chief. His most Serene Highness the Duke of Modena, who also arrived there the 14th, was faluted with 36 Guns. He was met upon the Stairs of the Palace by the Tribunals abovementioned, and all the Body of Nobility; at the Head of whom was the Great Chancellor Count Cristiani. They afterwards went into the Duke's Apartment, and acknowledged him as Administrator of the Government. His Serene Highnels has fince received the Compliments of the Commander in Chief of the Troops, attended by all the Officers; and also those of all the chief Magistrates of the Towns His Excellency the Marquis d'Aix, Knight of the Order of the Annunciation, and Governor of this Town, died at Chambery on the 16th Instant.

Madrid, Jan. 21. Yesterday being the King of Naples's Birth-day, their Catholick Majesties received the Compliments of the Nozbility and Foreign Ministers upon that Occasion, The Chevalier de Guevara, lately appointed Minister Plenipotentiary from his Sicilian Majesty to the Court of Portugal, arrived here the Beginning of last Week, and had the Honour of being presented to their Majesties; he has since been to wait upon the Queen Dowager at St. Ildesonso, and intends continuing his Journey to Lisbon in a few Days. By Letters from Cadiz of the 15th Instant, we have an Account of the Arrival of a Register Ship from Cartagena, said to be very rich.

Dantzick, Jan. 25. Baron Pretlak, heretofore Ambassador from their Imperial Majesties at
the Court of Russia, arrived here last Wednessday Evening from Moscow. Yesterday Moraing he was complimented by a Deputation from
the Magistracy of this City, and in the Asternoon he continued his Journey for Vienna.

Vienna, Jan. 26. The Chevalier Correro, Ambassador from the Republick of Venice to this Court, will make his publick Entry into this City the Beginning of the Month of May next, and he has already begun to make Preparations for that Purpose. Her Imperial Majesty has appointed Lieutenant Colonel Felix to be Colonel of the Regiment of Foot of Arnim, vacant by the Death of the late Count Arnim.

Turin, Jan. 26. The Marquis de Clerici arrived here from Milan the Beginning of this Week, to compliment the King of Sardinia on the Part of the Duke of Modena, and to notify his most Serene Highness's having taken upon him the Administration of the Government of Milan; and To-morrow he will leave this Place on his Return to Milan.

Dresden, Jan. 27. The Hereditary Prince of Modena set out from hence Yesterday Morning on his Return to Vienna, extremely latinied with the Reception he met with at this Court. A sew Hours afcet his Departure the Electoral Princels was brought to Bed of a Prince, whole Birth was foon after made known to the People by a triple Discharge of the Cannon upon our Ramparts, The new-born Prince was christianed the same Night by the Names of Joseph. Marie-Louis, &c. the Dauphin and Dauphinels of France standing Godfather and Godmother. by their Proxies Prince Charles and the Princes Christine; and to Day Te Deum was sung in all the Churches of this City, on Occasion of her Royal Highness's happy Delivery. They write from Leipsick, that a Body of twenty Robbers were secured last Week in that City, being Part of a large Gang, who have for forme Time past insested this Electorate, and committed the greatest Disorders.

Frankfort, Jan. 28. The Austrian Officers continue to taile Recruits in this City and in Neighbourhood with great Success, several Parities having lately marched from hence in order to join their respective Regiments. Baron Reischack, Envoy Extraordinary from their Imperial Majesties to the States General of the United Provinces, passed through this City of sew Days ago in his Way from the Hague to Vienna. We are informed by several private Letters from the Weteraw, that the Counted de Isembourg, Daughter to the late Counted that Name, died at Budingen on the 18th Internation, in a very advanced Age.

Hague, Feb. 5. The States of Holland and Westfrizeland will open their Assembly Ter morrow, for which Purpose most of the bers are already arrived. Yesterday M. Cauter, bach, the Polish Resident, notified in Form to her Royal Highness the Princess Governantes and to their High Mightinesses the States-Gener meral, the Birth of a Prince, of whom the Elect toral Princess of Saxony was safely delivered of the 26th of last Month. Prince William of Hesse Philipstall is appointed Major to the Regiment of Horse of Heynenoors, and M. Holthe is appointed Major to that of Dragoons of Nels fau. On Friday last the Princess Governante, the Prince Stadtholder, and the young Princes, accompanied by feveral Persons of Distinction, took again the Diversion of Sledging upon the Voorhout, and through Teveral of the principal Streets of this Place. They write from Lilla, that M. Prevost, Major of that Fort, died/there a few Days ago.
