Lisbon, March 5.

ARDINAL Almeyda, Patriarch of this City, died here last Week; and 'tis thought he will be succeeded by Don Bragance, Brother to the Duke of Lafrens. The Fleet bound for the Bahia, which has lain for some Time Wind-bound in this Port, is at last put to Sea. This Fleet consists of ten Merchantmen, convoyed by 'two Men of ] War, on Board of which is Don Joseph de Soto-Mayor, whom the King has lately appointed Governor of Prince's Island, and of that of St. Thomas.

Florence, March 20. The Regiments in Garrison in this City have been so weakened this Winter by Sickness and Desertion, that the Regency have thought proper to issue the necessary Orders for having the same compleated, and they are now actually raising Recruits for that Pur-

posë. Stockholm, March 22. Their Majesties and the Royal Family fet out this Day for Ulrichsdahl, where they propose to stay till Monday next. The King has appointed Vice-Admiral Count Sparre, to be one of the Admirals of his Majesty's Fleet. The Court of Russia having brdered that no Protection shall be given to any of his Swedish Majesty's Subjects who shall take Refuge in such Parts of Finland as belong to · that Empire, this Court has likewise ordered, that the same Precaution shall be taken in Relation to any Russian Subjects who shall endeavour to shelter themselves in any Part of Finland in

Toulon, March 24. Two Men of War and two Frigats are getting ready in this Port. They are ordered to be victualled for fix Months, during which they are to cruize in the Levant, in order to oblige the Corsairs of Barbary to pay more Respect to the French Flag than they have hitherto done.

Ratisbon, March 25. The Cardinal of Bavaria, our Bishop, having named Baron Stingelheim for his Suffragan, and the Pope having approved and confirmed his Nomination, this new Prelate was consecrated Yesterday in the Cathedral Church of this City with great Solemnity and Pomp. The Concourse of People prefent on this Occasion, was surprizingly great. The Ministers of the Diet having nominated the Margrave of Baden-Dourlach to be General of Foot, and the Landgrave of Hesse Darmstadt to be Lieutenant Field Marshal of the Forces of the Empire, his Imperial Majesty's Ratification thereof was published here a few Days ago.

Munich, March 25. Yesterday in the Evening the Hereditary Prince of Modena arrived here from Vienna. He went immediately to the Palace, and was received in a very polite Manner by their Electoral Highnesses. His Serene Highness proposes to spend about a Fortnight at this Court, and then to proceed to Modena.

Hambourg, March 29. By the Advices we have lately received from Konigsberg, Memel, Pillau, and some other Towns of Ducal Prussia, they are hard at Work in repairing and augmenting the Fortifications of those Places, and in filling the Magazines with all Kinds of Provi-

fions.

Copenhagen, March 30. The Ships appointed to go this Year to the Coast of Guinea and the East Indies, are getting ready with all Expedition. The Emanuel and Vesuvius will sail forthwith, and the King Frederick V. and the Union, have taken on Board great Part of their Cargo. The last Letters received here from Norway, are dated the 22d Instant, and take Notice, in particular, that the Frost is set in so very severe in that Country, that the Ice was then four or five Feet thick.

Turin, March 30. The Earl of Rochford, His Britannick Majesty's Envoy Extraordinary and Minister Plenipotentiary to this Court, having obtained Permission to return to England for a few Months on his private Affairs, and having had his Audiences of Leave of his Sardinian Majesty, and all the Royal Family here, his Lordship, with his Lady, left this Place the 26th of this Month: And Mr. Charles, who is charged with the Correspondence, during the Earl of Rochford's Absence, has had the Honour of being presented to the King of Sardinia, and his Royal Highness the Duke of Savoy, and was very graciously received.

Dusselders, April 3. Count Harschamp, Lieutenant General and Governor of this City, having obtained Leave to resign his Employments on Account of his great Age and bad State of Health, the Elector our Sovereign has named for his Successor Count Limbourg Styrum, heretofore Governor and Commander of

Heidelberg.

Paris, April & The King set out this Morning from Versailles for Choisy. His Majesty has lately disposed of several vacant Benefices in the Church, and made several Military Promotions. Many vacant Employments have likewise been filled up, among others, Lieutenant General Chevert is appointed Commander of the Royal and Military Order of St. Louis; the Sieur Caumortin, Master of the Requests, is named Intendant of Metz; and the Government of Louisbourg in Canada is given to Captain Rencourt.

Brussels, April 7. Almost all the Regiments belonging to the States General of the United Provinces, that have been sot some Time gardioned in the Barrier Towns, and in Dutch Brabant, are on their March in order to change

sheir respective Garrisons.

General Post Office, March-2, 1754, Whereas the Post Boy, bringing the Kent Mail a this Office, upon Thursday the 28th of Pehruary last, was, between the Hours of Eight and Nine of the Clock in the Evening, attacked and robbed, at a Place called Snipps Hill, about a Mile beyond Sittingborn by three Footpads, one of whom fired a Pistol, seized the Horse which varried the Mail, beat the said Post Bay cruelly, and cut the Mail from the Horse and carried it away.

Two of the Persons who committed this Robbery and described as short Men, dressed like Sailors; and the

other a tall Man in a red Coat.
