THEREAS, on the 17th Instant, a Written Paper of Verses was dropt in the Market Place at Oxford, containing the most infamous and \* audacious Expressions of Treason, Sedition, and Rebellion, and such false, wicked, and traiterous Aspersions of His Majesty's Sacred Person and Government, as must raise the utmost Indignation and Abborrence in all those, who have any Sense of the Duty, , and Gratitude, they so justly owe to His Majesty, or the least Regard to the Peace and Happiness of the Nation, under His Majesty's most mild and gracious Govern-+ ment: In order that the Author, or Authors, of the said presumptuous, seditious, stand treasonable Paper, or any Person, or Persons, concerned in writing, publishing, or dropping the same, as aforesaid, may be discovered, and brought to the Punishment due to so high and heinous an Offence; These 'are, in His Majesty's Name, striktly to require, and enjoin all His Majesty's Justices of the Peace, and all other Civil Magistrates whatsoever, to make diligent Search after \* the Author or Authors, Publisher or Pub-\* lishers, of the said seditious, treasonable, infamous, and abominable Paper, and that, on discovering him, her, or them, they do immediately sapprehend and seize the said Person, or Persons, and carry him, her, or - them, before a proper Magistrate, that the · Jaid Offender, or Offenders, may be prosecuted for the said Offence, according to the utmost Rigour of the Law. And all-His .Majesty's loving Subjects are hereby strictly sbarged, that they do use their utmost Endeavours to discover and apprehend the said Offender, or Offenders. And for the Encouragement of all Persons to be diligent and industrious in their Endeavours to make such Discovery, His Majesty does, bereby, promise à Reward of Two Hundred Pounds sto any Person, for Persons, who shall discower the Author, or Authors, or Publisher, or Publishers, of the said detestable, treasonable, and seditious Paper, or any of them, so as ssuch Offender, or Offenders, be convitted thereof: For the Payment of which aforesaid Reward, His Majesty bath given the necessary Orders to the Lords Commisfionets of His Treasury.

Expatum. In last Saturday's Gazette, in the sirst Line of the above Advertisement, for the 13th Instant,

Lisbon, June 18. The Departure of the Court to Belem is fixed for Sunday next; in which Journey their Majesties are to be accompanied this Year by the Queen Dowager, as also by the Infants Don Anthony, and Don Emanuel. 'Tis confidently reported, that the King intends shortly to make a numerous Promotion of General Officers.

Rome, July 1. On Friday last, being the Eve of St. Peter and Paul, Patrons of this City, the Pope went in great State to the Vatican Church; and being returned to the Palace, the Constable Colonna delivered to him the white Horse and Purse of Gold, being the annual Present from the King of the Two Sicilies. At Night there were great Rejoycings throughout the City; a grand Firework was play'd off, and several Discharges were made of the Cannon of the Castle of St. Angelo.

Stockholm, July 6. The King intends going to Scania, and some other of the Southern Provinces of this Kingdom, towards the Beginning of next Month. On Saturday last died Baron Siobald, one of the oldest General Officers in

the Service of this Crown.

Stockholm, July 10. We are informed by Express, that the Gothick Lyon, a Ship belonging to our East India Company, that left Canton the 30th of December, arrived safe in the Road of Gottenbourg on Sunday last, ha-

ving on Board a very valuable Cargo.

Dresden, July 10. The Prince Royal has nominated the young Count Calenberg, his Polish Majesty's Minister to the Elector of Bavaria, to be his Adjutant General, in the Room of Count Witzthum, who was lately killed in a Duel. The last Letters from Warsaw informs us, that his Majesty enjoys a good State of Health, and is very successful in his Endeavours to reconcile the Differences that have arisen between several of the principal Families in that Kingdom.

Vienna, July 10. Her Imperial Majesty'is perfectly recovered of her late lying-in, and appears in Publick, and transacts the Business of her Hereditary Countries as before. Count Keyserling, Minister Plenipotentiary from the Court of Russia, has received, by an Express from Petersbourg; the Ribbon, and other Ensigns of the Order of St. Andrew, with which the Empress his Mistress has lately honoured

him.

Vienna, July 13. Yesterday the Emperor was present at a great hunting Match in the Neighbourhood of Neustadt: After which he visited the Military School, where he was splendidly entertained at Dinner by Count Leopold Daun, Governor of that Establishment, and in the Evening he returned to Schonbrun. The Departure of the Court for Presbourg will take Place some Day next Week; but their Imperi rial Majesties intended Journey to Moravia and Bohemia is deferred till the 16th of next Month,

Copenhagen, July 13. The King and all the Royal Family continue to enjoy perfect Health at Frederichbourg. Orders are given for equipping, with all Diligence, the Christiansbourg, a Man of War, but no one as yet knows her Destination. The Privy Counsellor de Luhe has taken Possession of the Employment of President of the Magistracy of this City, to which he was lately appointed, and is to continue his Post of first Gentleman of the Bedchamber to his Majesty.

Progue, July 13. Their Imperial Majesties having signified their Intention of coming here next Month, great Preparations are making for their Reception. The Troops destined to soft the Camp in the Neighbourhood of Kolin, under the Command of Field Marshal Count Brown, wait only for their last Orders to march to the Ground that is already marked out for

their Encampment.

Mentz, July 13. On Saturday last, being the Birth-Day of the Elector our Sovereign, who then enter'd into the 66th Year of his Age, there was a very brilliant Court at the Palace of the Favourite, to compliment him thereupon; and what greatly hightened the Pleasure his Electoral Highness received on that Occasion, was the Arrival of the Elector Palatine and Prince Frederick of Deuxponts, who came on Purpose from Schlangenbad, and returned the same Night. Count Pergen, their Imperial Majesties Minister to this Court, is daily expected here from Frankfort, where he has been to assist at an Assembly of the States of the Circle of the Upper Rhine.

Berlin, July 16. The Margravine of Bareith, who was so extremely indisposed for several Days together, that the King thought proper to send Dr. Cothenius, his Majesty's first Physician, to attend her during her Illness, is already much

better, and in a fair Way of Recovery.

Compeigne, July 19. The Baron de Knip-hausen, whom the King of Prussia has named to replace the Lord Marshall in the Post of Minister Plenipotentiary to this Court, had Yesterday his first private Audience of his most Christian Majesty, and delivered his Credential Letters: He was afterwards introduced to the Queen, and to the rest of the Royal Family.

Paris, July 21. The Sieur de Maupeou, first President of the Parliament of this City, having been ordered to repair to the King at Compeigne, he had accordingly a private Audience of his Majesty on Sunday last, which last d for a considerable. Time. Nothing relating to this Audience has as yet transpired, but the Friends of the Parliament statter themselves that an Accommodation between the Clergy and that Body is certainly on Foot.

Brussels, July 22. The Regiment of Foot of Arberg arrived here on Wednesday last from Mons, and was reviewed the same Day by Prince Charles of Lorrain, our Covernor General; and the next Morning continued its Route for Bruges and Ghent, to which Places

it is ordered into Garrison.

Whereas the Post Boy, bringing the Kent Mail so this Office, upon Thursday the 28th of February last, was, between the Hours of Eight and Nine of the Clock in the Evening, attacked and robbed, at a Place called Snipps Hill, about a Mile beyond Sittingborn by three Footpads, one of whom fired a Pistol, seized the Horse which carried the Mail, beat the said Post Boy cruelly, and cut the Mail from the Horse and carried it away.

Two of the Persons who committed this Robbery are described as short Men, dressed like Sailors; and the

other a tall Man in a red Coat.

This is therefore to give Notice, That whoever shall apprehend and convict, the Persons, or any of them who committed this Robbery, will be intitted to a Reward of Two Hundred Pounds, over and above the Reward given by Act of Parliament sor apprehending of Highwaymen: Or if any Person or Persons, where ther Accomplice in the said Robbery, or knowing thereof, do, or shall make Discovery, whereby any one, or more of the Persons, who committed the same, may be apprehended and brought to Justice, such Discoverer, or Discoverers will, upon Conviction of any one, or more, of the said Robbers, be intitled to the same Reward of Two Hundred Pounds, and also have his Majesty's most gracious Pardon.
