HEREAS, on the 17th In-stant, a Written Paper of Verses was dropt in the Market Place at Oxford, containing the most infamous and audacious Expressions of Treason, Sedition, and Rebellion, and such false, wicked, and traiterous Aspersions of His Majesty's Sacred Person and Government, as must raise the utmost Indignation and Abborrence in all those, who have any Sense of the Duty, and Gratitude, they so justly owe to His Majesty, or the least-Regard to the Peace and Happiness of the Nation, under His Majesty's most mild and gracious Government: In order that the Author, or Authors, of the said presumptaous, seditious, and treasonable Paper, or any Person, or Persons, concerned in writing, publishing, jor dropping the same, as aforesaid, may be discovered, and brought to the Punishment due to so bigh and beinous an Offence; These re, in His Majesty's Name, strictly to require and enjoin all His Majesty's Justices of the Peace, and all other Civil Magistrates what soever, to make diligent Search after be Author or Authors, Publisher or Publishers, of the said seditious, treasonable, infamous, and abominable Paper, and that, on discovering bim, ber, or them, they do immediately apprehend and seize the said Person, or Persons, and carry him, her, or them, before a proper Magistrate, that the aid Offender, or Offenders, may be prosecuted for the said Offence, according to the most Rigour of the Law. And all His

Majesty's loving Subjects are bereby strictly charged, that they do use their utmost Endeavours to discover and apprehend the said Offender, or Offenders. And for the Encouragement of all Persons to be diligent and industrious in their Endeavours to make such Discovery, His Majesty does, hereby, promise a Reward of Two Hundred Pounds to any Person, or Persons, who shall discover the Author, or Authors, or Publisher, or Publishers, of the said detestable, treasonable, and seditious Paper, or any of them, so as such Offender, or Offenders, be convicted thereof: For the Payment of which aforesaid Reward, His Majesty bath given the necessary Orders to the Lords Commissioners of His Treasury.

HOLDERNESSE.

Warsaw, Aug. 4. The Universalia, for holding a general Diet on the 30th of next Month, are already dispatched to the different Provinces of this Kingdom. Yesterday, being the King's Name-Day, and also the Festival of the Order of the White Eagle, there was a brilliant Appearance at Court of the Nobility and Gentry, when his Majesty was pleased to create nine new Knights of that Order, viz. Prince William of Schwartzbourg-Sondershausen, Count Hohenlohe-Oeringen, Count Schuwaloff, in the Service of the Empress of Russia, M. Sierakowsky, Bishop of Przemislaw, M. Walewsky, Palatin of Lenczic, Count Hulsen, Palatin of Minsko, M. Pac, Castallan of Samogitia, M. Wolsty, Castallan of Lublin, and Count Branicky, Castallan of Braclaw.

Stockholm, Aug. 6. On Tuesday last their Majesties set out from Drottningholm, in order



to visit the West and Southern Provinces of this Kingdom. The following is the Route they propose to take: Last Night they rested at Orebro, a small Town in the Province of Nericia, and this Night they are to lie at Hofwa. To-morrow they are to reach Wennersbourg in Dalecarlia. The 9th they proceed to Gottenbourg, where they are to rest till the 13th, in order to examine into the State of the Marine. The 14th they go to Helmstadt, the Capital of the Province of Halland, and on the 15th they are to arrive at Aby. The 16th, 17th, 18th, and 19th, are to be employed in reviewing the Troops quartered in the Neighbourhood of that Place. On the 20th they are to fet out for Landscron, where they are to rest till the 23d. The 24th they go to Malmoe, where they are to stay till the 26th, and then proceed to Lund, where his Majesty intends to review the Regiment of Horse of Scania. On the 31st their Majesties are to continue their Route for Christianstadt. Here they propose to rest till the 4th of September, and then to return to Drottningholm, which they intend to reach by the the 23d, taking their Route by Jonkoping, Christineham, Kongshor, and Gripsholm.

Vienna, Aug. 7. The Departure of the Court for Prague, to view the Camps of Teynitz and Kollin, is fixed for the 16th Instant, and Count Choteck is already set out for Bohemia, in order to settle the necessary Relays for that Purpose. They are raising Recruits in this City and its Neighbourhood for compleating the Regiments in Hungary and Styria, small Bodies of whom are often marching off for their respective Regiments. The Navigation of the Danube, which has been greatly interrupted of late, by its Overslowing its Banks, is now regularly carried on again. M. Crivelli, the Pope's new Nuncio to this Court, had his first private Audience of their Imperial Majesties on

Sunday last.

Breslau, Aug. 9. The Swarms of Locusts, that appeared last Month on the Frontiers of this Province, bordering upon Poland, are since gone off, without having damaged the Herbage so much as was expected. We are informed by private Letters from Berlin, that the King intends shortly to take a Tour into this Dutchy, in order to examine the Fortifications.

Ratisbon, Aug. 12. The Chevalier de Follard, who has resided for several Years past in Quality of Minister from France to the Diet of the Empire, returned to his Court the Beginning of last Week; and the Abbe le Maire, who succeeds him in that Post, has already delivered his Credential Letters to the Elector of Mentz.

Dresden, Aug. 12. The Hereditary Prince of Anspach arrived here on Tuesday Night last, accompanied by Field Marshal Count Secken-

dorff. This young Prince came incognito, under the Name of Count Sayn. The next Day he dined with the Prince and Prince's Royal, and the Day following fet out for Prague, in order to attend their Imperial Majesties in viewing the Camps of Teynitz and Kollin. Besides the Cartel which this Court has agreed to with that of Hesse Cassel, for the mutual Exchange of Deserters, another of the like Nature is settled with the Prince of Saxe Hildbourghausen, and Orders are dispatched to all the Commanders of the Troops of this Electorate, to cause the same to be published at the Head of their respective Corps.

Brussels, Aug. 15. The Princess Charlotte of Lorrain is expected here on the 10th or 11th.

Middlebourg, Aug. 15. Her Royal Highness the Princess Governante has been pleased to approve of the Nomination, that was laid before her, of Burgomasters, and other Magistrates

of this Place for the Year ensuing.

Paris, Aug. 16. The King has conferred on the Marquess de Chetardie, heretosore his Ambassador to different Courts of Europe, the Government of Fort Lewis upon the Rhine, vacant by the Death of Count Montesquiou. His Majesty has likewise disposed of the Intendancy of Valenciennes, in Favour of M. de Boismont, Intendant of Rochelle; and that of Besancon is given to M. Bourgeois de Boines, Master of the Requests and Procurator General of the Royal Chamber.

Hague, Aug. 20. The States of Holland and Westfrizeland being to open their Assembly To-morrow, most of the Members, who compose that Body, are already arrived. Yesterday in the Asternoon a solemn Deputation, som the States of Guelderland, were admitted to an Audience of her Royal Highness the Princess Governante, at the House in the Wood.
