In order that the Author, or Authors, of the said presumptuous, seditious, and treasonable Paper, or any Person, or Persons, concerned in writing, publishing, or dropping the fame, as aforesaid, may be discovered, and brought to the Punishment due-to so high and heinous an Offence; These gre, in His Majesty's Name, strictly to require and enjoin all His Majesty's Justices of the Peace, and all other Civil Magistrates whatsoever, to make diligent Search after the Author or Authors, Publisher or Pub-"lishers; of the said seditious, treasonable, inamous, and abominable Paper, and that, on discovering him, her, or them, they do immediately apprehend and seize the said Person, or Persons, and carry him, her, or them, before a proper Magistrate, that the Jaid Offender, or Offenders, may be prosecuted for the said Offence, according to the utmost Rigour of the Law. And all His Majesty's loving Subjects are bereby strictly charged, that they do use their utmost En- jesties arrived here on Friday last, and were sa-

deavours to discover and apprehend the said. Offender, or Offenders. And for the Encouragement of all Persons to be diligent and industrious in their Endeavours to make such Discovery, His Majesty does, hereby, promise a Reward of Two Hundred Pounds to any Person, or Persons, who shall discover the Author, or Authors, or Publisher, or Publishers, of the said detestable, treasonable, and seditious Paper, or any of them, so as such Offender, or Offenders, be convicted thereof: For the Payment of which aforesaid Reward, His Majesty bath given the necessary Orders to the Lords Commissioners of His Treasury.

The Proprietors of the Works for Refining of Sugar at Bergen in Norway, are equipping two Ships, which they propose to send in a short Time to the East Indies.

Prague, Aug. 14. Their Imperial Majesties are expected here on the 24th Instant from the Camp at Kollin, and propose to spend about ten Days in visiting the principal Nobility in this Neighbourhood; after which they will set out for Olmutz in Moravia; in order to see the Camp, formed near that City, under the Com-

mand of Prince Piccolomini.

"Vienna, Aug. 17. Yesterday their Imperial Majesties set out for Bohemia. Last Night they proposed to lie at Iglau, and this Evening to reach Neuhoff, a Seat belonging to Field Marthal Count Bathiany, near the Camp of Kollin. We are assured, that the Command of the Regiment of Cuirassiers, vacant by the Death of Field Marshal Baron Diemar, will be given to went on Saturday last to the House in the the Hereditary Prince of Anspach. Count Puckler. Privy Counsellor and Chamberlain to their Imperial Majesties, died here Yesterday, in the 64th Year of his Age.

Berlin, Aug. 20. The King has disposed of the Regiment of Foot, vacant by the Death of M. de Roeder, in Favour of M. Sydow. His Majesty, accompanied by Prince Ferdinand of Brunswick, and several General Officers, came here on Wednesday Morning last from Potzdam: After giving divers Audiences, he went to Montbijou, and dined with the Queen Mother, and from thence- to Charlottenbourg, I

where he lay that Night, and the next Day returned to Potzdam. On Saturday Night last Count de Haacke, Lieutenant General of Foots Governor of this City, and Knight of the Order of the Black Eagle, died here, in the 56th Year of his Age.

Ratisbon, Aug. 21. The Prince of Tour Taxis, principal Commissary of the Emperor to the Diet of the Empire, is expected here from Swabia towards the End of October or the Beginning of November, about which Time 'tis thought the Diet will open its Assembly,

Versailles, Aug. 22. The King is expected here this Evening from Choily. His Majesty has disposed of the Post of Lieutenant General of the Nivernois, vacant by the Death of the Marquess de Richerand, in Favour of the Marquess de Fourgeres. On Tuesday last the Deputies of the States of Languedoc had an Audience of the King, being introduced by the Prince de Dombes, Governor of that Province, and by the Count de St. Florentin, Minister and Secretary of State.

Franksort, Aug. 23. The French continue to fend great Numbers of Horses through the Territories of this State, for the Use of thelf Regiments in Alface and Franche Comte, We have an Account from Swabia, that the Princes ' of Hohenzollern-Sigmaringen is fafely delivered of a Princess, who is baptized by the Names of Marie-Francoise-Anne-Antoinette-Jeanne.

Amsterdam, Aug. 24. By Letters from Smyrna, dated the 1st of July, we are informed, that the Report which had been spread of an iff tended Expedition against Bassora, was without Foundation.
