HEREAS, on the 17th Instant, a Written Paper of Verses was dropt in the Market Place at Oxford, containing the most infamous and audacious Expressions of Treason, Sedition, and Rebellion, and such false, wicked, and traiterous Aspersions of His Majesty's Sacred Person and Government, as must raise the utmost Indignation and Abborrence in all those, who have any Sense of the Duty, and Gratitude, they so justly owe to His Majesty, or the least Regard to the Peace and Happiness of the Nation, under His Majesty's most mild and gracious Government: In order that the Author, or Authors, of the said presumptuous, seditious, and treasonable Papers or any Person, or Persons, concerned in writing, publishing, or dropping the same, as aforesaid, may be tifcovered, and brought to the Punishment due to so high and heinous an Offence; These are, in His Majesty's Name, strictly to require and enjoin all His Majesty's Justices of the Peace, and all other Givil Magistrates what soever, to make diligent Search after be Author or Authors, Publisher or Publishers, of the said seditious, treasonable, inamous, and abominable Paper, and that, on discovering him, her, or them, they do immediately apprehend and seize the said erson, or Persons, and carry him, her, or them, before a proper Magistrate, that the said Offender, or Offenders, may be prosecuted for the said Offence, according to the tmost Rigour of the Law. And all His Majesty's loving Subjects are bereby strictly charged, that they do use their utmost Endeavours to discover and apprehend the said Offender, or Offenders. And for the Encou-Pragement of all Persons to be diligent and industrious in their Endeavours to make such Discovery, His Majesty does, hereby, promise a Reward of Two Hundred Pounds to any Person, or Persons, who shall discover the Author, or Authors, or Publisher, or ublishers, of the said detestable, treason-

able, and seditious Paper, or any of them, so as such Offender, or Offenders, be conviEted thereof: For the Payment of which aforesaid Reward, His Majesty bath given the necessary Orders to the Lords Commis- ' sioners of His Treasury.

HOLDERNESSE.

Lisbon, July 31. The Difficulties that were started at the Court of Madrid, under the Ministry of the Marquess de la Ensanade, on Account of the Exchange of the Possessions of this Crown and that of Spain in America, are now in a fair Way of being settled to the Satisfaction of both Courts. Commodore Brito is still at Sea with his Squadron on a Cruize against the Barbary Corsairs, of whom he has, cleared the Coast; so that the Commerce and Navigation of this Kingdom is now carried on without the least Interruption from those Pyrates.

Naples, Aug. 13. On Friday Night last the Fair of this City was proclaimed as usual. The Presence of their Majesties, and the rest of the Royal Family, makes this Fair extremely brilliant. A few Days ago a Knight of the Order of Malta arrived here with some new Propositions for ending the Disputes between this Court and the Grand Master of that Order. They continue to raise Recruits throughout this Kingdom, not only for compleating the two new Regiments with which the King has lately thought fit to augment his Troops, but likewise

to compleat the old Regiments. Genoa, Aug. 19. The Gallies that carried to Bastia the Marquess Doria the new Commissary General of Corsica, returned into Port last Thursday, having on Board the Marquess de Grimaldi, the late Commissary General of that Island, who, upon his Arrival, went to the Ducal Palace, and communicated to the Doge the present State of Affairs in Corsica. We learn by the Master of a Felucca lately arrived here from Sicily, that the Duke de la Vieux-ville, Viceroy of that Kingdom, died on the 24th of last Month at Palermo; and that M. Girau, Governot of the Citadel of Messina, had taken Charge of his Affairs as Viceroy of Sicily till his Sieilian Majesty shall think fit to nominate a Successor to the Duke de la Vieuxville.

, Parma, Aug. 19. The Duke our Sovereign, and the Republick of Genoa, have agreed about

making a High Road from hence to Sestri-di-Levante, which 'tis believed will be of the greatest Advantage to the Commerce of the Sub-

jects of both Countries.

Vielun in Poland, Aug. 21. The Dietine of this Palatinate being assembled here on Monday last, for the Choice of Deputies to the General Diet, the Election fell on the eldest Son of Prince Sulkowsky, and on Count Niemojewsky.

Modena, Aug. 22. Yesterday the Duke our Sovereign set out with a numerous Retinue for Milart. A Council is nominated to manage publick Affairs during his Highness's Absence, of which the Hereditary Prince is appointed

President.

Milan, Aug. 22. Orders are given by the Empress Queen for examining into the Condition of the Regiments in Garrison in Austrian-Lombardy; when all those Soldiers, who by Age or Infirmities, are no longer able to bear Arms, are to be fent to the. Hospital for Invalids at Pest in Hungary. A large Body of new Recruits, raised in this City and its Neighbourhood, are speedily to march from hence for Hungary, in order to join the different Regiments they are inlifted for.

Prague, Aug. 24. Yesterday their Imperial Majesties arrived here from the Camp at Kollist, where they spent five Days in viewing the Troops, and leeing them go through their Exercise. They propose staying here till the 2d of next Month, and then to proceed to Moravia, in order to see the Camp formed there under the Command of Prince Piccolomini,

Copenhagen, Aug. 24. On Tuesday last Began the Sale of Merchandize brought from Tranquebar on Board his Majesty's Ship the Bornholm; and that brought by the Nelleblad is foon to follow. We also expect the Three Princesses to arrive this Year from Tranquebar; but as to the Sudermanland, The is not expected till the Middle of next Summer.

Cossel, Aug. 26. The Landgrave our Sovereign has agreed to a Cartel with the Court of Dresden, and so another with Prince Waldeck,

for the mutual Exchange of Deferters.

Madrid, Aug. 26. Last Monday a Courier from Lisbon having brought the melancholy News of the Death of the Queen Dowager of Portugal, Mother to the Queen of Spain, their Catholick Majesties were pleased to order the Court to go into Mourning for fix Months. Yesterday the Cardinal Infant arrived here from St. Ildephonso, in order, as it is said, to resign, with the King's Leave, the two Archbishopricks of Toledo and Seville. The Marquis de Coria, only Son to the Duke of Huescar, who has been ill of the Small Pox, is out of Danger. By Letters from Cadiz we are informed, that four Men of War, belonging to the Portuguese Squadron, that was lately in that Port, were returned thither, in order to take in Provisions; Lafter which they were to proceed upon a Cruize off Algiers,
