Smyrna, August 24.

HE Contagious Distemper that raged here with great Violence for two or three Months, is at length totally ceased; and the Christians, who are by much the greatest Part of the Inhabitants of this City, have caused Te Deum to be sung in all their Churches, for so happy a Deliverance.

Naples, Oct. 1. It is currently reported, , that a Treaty of Accommodation between this Court, and the Order of Malta, is upon the Point of being fettled to the mutual Satisfaction of both Parties. The two Gallies that have been for some Time on a Cruize off Orbitello and Porto Longone, in order to protect the Na-, vigation of this Kingdom against the Pyrates of Algiers, Tripoly, and Tunis, are returned into Port for the Winter, the stormy Weather not permitting them to continue out at Sea any longer. Amongst the great Number of rich Pieces of Sculpture that have been found in the Ruins of the ancient City of Heraclia, the Curious seem most to admite an Equestrian Statue of black Marble that represents the Consul Nennius Balbus, which is very little damaged.

Petersbourg, Oct. 3. On the 23d of last Month, a new Man of War, of 80 Guns, was launched here, and called the St. Nicholas. The Great Princess was happily delivered of a Prince on the 1st Instant, who was afterwards christened by the Name of Paul. This happy Event was soon after made known to the People by several Discharges of the Cannon of the Fortees, and of the Admiralty. The Great Princes, and the young Prince, are as well as can be expected.

Legborn, Oct. 5. We are informed by our last Advices from Corsica, that the Conferences between the Marquess Doria, the Genoese new Commissary General in that Island, and the Deputies from the several Pieves attached to the Interest of the Malecontents, at Calvi, are broke off, and 'tis seared nothing but open Force will bring them to Reason.

Warsaw, Oct. 6. Last Monday the General Diet of this Kingdom was opened here with the usual Ceremonies. About Ten o'Clock in the Morning the King went in Procession to the Collegiate Church of St. John, and affisted at High Mass, at which the Bishop of Cracow officiated Pontifically. After which he went to the Senate, where Count Sapieha, Palatin of Polock, and Count Humiecki, Castellant of Kaminieck, took, from the Hands of his Majesty, the Oaths in Quality of new Senators. The Nuncios being afterwards affembled in their Chamber, M. Massalski, Treasurer of the Crown in Lithuania, and Nuncio of Grodno, who was Marshal the preceeding Diet, made, in Quality of Director of that Chamber, an excellent Speech, in which he exhorted the Nuncios to proceed immediately to the Election of a Marshal; but, some warm Debates arising, thereupon, the Chamber adjourned. Since which they have met several Times, but the Disputes still continue, and they have not as yet been able to choose a Marshal.

Rome, Och. 8. The Harvest has proved so very plentiful this Year in the Ecclesiastical State, that the Pope has granted his Subjects the Liberty to export Corn into other Countries. M. Archinto, the Pope's Nuncio at Poland, is arrived here, in order to take Possession of the important Post of Governor of this City. The Small Pox continues to tage here with great Violence, upwards of 3060 Persons having died of that satal Distemper within these six Weeks.

Milan, Oct. 10. The Duke of Modena set out from hence last Monday Morning with a numerous Retinue for Mantua. His Highness was escorted by a Detachment of Hussars, and proposes, after visiting Mantua, to continue his Tour to Bozzolo, Casal-Maggiore, Cremona, and other Places in Austrian Lombardy.

On Thursday last, Marshal Count Palavicini, who arrived here lately from Italy, had a private Audience of their Imperial Majesties, and laid before them an Account of the present State of Affairs in that Country. We have received an Account by our last Letters from Swabia, that Count Schonbron, elder Brother to the Elector of Treves, and Knight of the Order of the Golden Fleece, died a few Days ago at Wiesentaigh, where he resided for many Years.

Berlin, Oct. 17. The King has conferred on M. de Sohr, the Office of Great Master of the Waters and Forests in the New Marche, vacant by the Death of M. de Bock, who

died lately at Custrin.

Utrecht, Oct. 19. The Distemper amongst the Horned Cattle having broke out in several Places of this Province, the States have thought proper to cause an Ordonnance to be published, by which all Persons are subject to severe Penalties, who shall presume to drive Cattle from one Place to another, without a Certificate, signed by the Magistrate or chief Officer of the Place from whence they come, that they are in Health.

Dusseldorp, Oct. 20. The Regiment of Horse of Prince Frederick, that has been for some Time quartered in the Dutchy of Juliers, is thought proper to augment his Troops, and 'tis thought they will be both compleat in a very thort Time.

Hague, Oct. 24. Her Royal Highness the Princess Governante, the young Prince Stadtholder, and the Princess his Sister, have received the Compliments of the Nobility and Gentry upon their Return from Spestdyk. Next Sunday the Court goes into Mourning, for three Weeks, on Occasion of the Death of the Queen of Portugal.

Dublin, October 24.

Tuesday last, being the Anniversary of His Majesty's Coronation, the Great Guns were fired in His Majesty's Park the Phoenix, and answered by Vollies from the Regiments in Garrison, which were drawn out in the Royal Square at the Barracks. At Noon there was a numerous Appearance of the Nobility and other Persons of Distinction, to compliment their Excellencies the Lords Justices upon this Occasion; and at Night there was a Play given by their Excellencies for the Entertainment of the Ladies. And Yesterday, being the Anniversary of the Irish Rebellion in 1641, their Excellencies the Lords Justices went in the usual State chtist Ohurch, escorted by a Squadron of Horse, where they heard a most excellent Ser-

mon preached by the Reverend Dean St. George, upon that Occasion. The Sword of State was carried to and from the Church by Lord Rawden. After their Excellencies Return to the Castle, the Great Guns in His Majesty's Park the Phoenix were fired three Rounds, and answered by Vollies of Small Arms from the Regiments of Foot on Duty, drawn out in the Royal Square at the Barracks.
