Lisbon, September 24.

HE four Men of War that sailed from hence some Time ago on a Cruize against the Corsairs of Barbary, under the Command of Don Juan da Costa de Brito, returned into Port last Wednesday. The same Day the Fleet from Fernambuco arrived at the Mouth of the Tagus: It consists of forty-four Ships, and is reckoned as rich a Fleet as has arrived from thence for some Years. The King has advanced a Million of Cruzades to the Sieur Oldenbourg, Director of the new Company of Macao and Goa. Cardinal Tempi, who has resided for several Years at this Court in Quality of the Pope's Nuncio, had last Thursday his Audiences of Leave of their Majesties and the Royal Family, and intends to fet out in a few Days on his Return to Rome.

Naples, Oct. 5. The Court is gone to Portici, where their Majesties propose to reside till the End of this Month. The King, in Confideration of the faithful Services performed by the Family of Tagliavia, has conferred the Title of Marquess on the first Branch of that Family. The two Gallies that cruized off Saletno during the Time of the Fair, and which returned into Port some Days ago to be unrigged and laid up for the Winter, are, upon Advice being received that two or three Corsairs are cruizing on the Coast of Calabria, and greatly obstruct the Navigation, ordered to Sea again forthwith, in order to chace those Pyrates.

Warfaw, Oct. 13. The Debates in the Chamber of Nuncios still continue to run so high, that they have not as yet been able to chuse a Marshal, so that 'tis feared this General Diet will, in the End, break up as unsuccessful as the last.

Nuremberg, Oct. 16. The Margrave of Brandebourg-Culmbach, who arrived last Thursday at Erlang from Bareith, set out on the Mon-

day following for Anspach, in order to spend some

Days at that Court.

Copenhagen, Oct. 19. The King, who a few Days ago was confined to his Apartment with a very bad Cold, appears now again in Publick, and is perfectly recovered. Major General Ulrichsdahl having lately been appointed Commandant of Frederichstadt in Norways 'tis thought his Regiment will be given to Count Wedel-Jarsberg. Captain Kaas, who carried the Ratification of the Treaty lately concluded between this Court and that of Morocco, is returned from thence, and performing Quarantine.

Berlin, Oct. 22. The King came here last Thursday, and having viewed the Repairs that are making at the Castle, returned the next Day to Potzdam. A few Days ago his Majesty made a great Promotion of Civil and Military Officers.

Amsterdam, OE. 26. The East-India Company of these Provinces have come to a Resolution to build five new Ships, viz. two for the Chamber of this City, one of which is to be named the Amerongen, and the other the Dame Rebecca Jacoba; one for the Chamber of Zealand, to be named the Walcheren; one for the Chamber of Delft, to be named the s'Gravesande; and one for the Chamber of Hoorn, to be named the Lekkerluft.

Hague, Oct. 29. M. van den Heemert, Burgomaster of the Town of Campen, has taken the usual Oaths to the Assembly of the States-General, in Quality of Deputy from the Province of Overyssel to the College of the Admiralty of Amsterdam. This Week are expected here the Deputies appointed by the Province of Zealand, to consider, in Conjunction with those of this Province, of the Choice of a new Prefident of the High Council of Holland, in the room of the late M, van Hees.
