St. James's, November 12.

WNDAY being the Anniversary of the King's Birth-Day, at Noon the Guns in the Park and at the Tower were fired, and in the Evening there were Bonfires, Illuminations, and other Publick Demonstrations of Joy throughout London and Westminster: And Yesterday there was a numerous and brilliant Appearance of the Nobility, Foreign Ministers, and other Persons of Distinction, to compliment his Majesty on that Occasion; and in the Evening there was a Ball at Court.

The King has caused an Edict to be published, commanding the Cortigidor in each Division to take an exact Account of all the Lands held by Religious Communities, contrary to Law, or without his Majesty's Permission, and to sequestre the same forthwith. And tis said a Decree is soon to be published, for reducing the Number of Monks and Nuns to the first Institutions of their respective Orders and Communities.

Telt some small Shocks of Earthquakes, but they have done very little Damage. The Grand Seignor, who retired to one of his Palaces upon the Borders of the Black Sea, is returned to the Seraglio, in Hopes that his Presence will be of Service to dissipate the Consternation and Terror into which the late dreadful Earthquakes had thrown the Inhabitants.

Naples, Oct. 15. We have received the agreeable News, that one of our armed Chebecks has taken an Algerine Corfair in the Cathal of Piombino, after an obstinate Engagement, and conducted her to Civitta Vecchia.

Possonia, Oct. 23.1 A Fire broke out a sew Days ago at Sembitz, a small Distance from hence, which burnt with such Violence, that 25 Dwelling Houses, besides many Barns and Stables, were reduced to Ashes in a very short Time. We learn by our last Advices from the Ukraine, that the Heyducks continue to commit great Outrages upon the Frontiers of that Province.

Stockholm, O.A. 23. The Court will remove in a few Days from Drottningholm to Ulrichfdahl. Last Week a Ship was cast away in passing the Streights of Dahlero. As the Weather was very tempestuous, the whole Crew was lost.

Rennes, Oct. 23. The States of this Province have agreed to compliment his Majesty with a Free Gift of two Millions, Every Thing passes in this Assembly with the greatest Tranquility, under the Direction of the Duke d'Aiguillon, President thereof.

Milan, Ott. 23. The Duke of Modena, accompanied by Field Marshal Count Apremont, and several other Officers of Distinction, set out from hence last Monday Morning for Lodi, to review the Troops in that Garrison; from whence his Highness goes to Pavia, in order to examine the Fortifications of that Place.

Majesties reviewed the Regiments which compose this Garrison, and were highly pleased with their Appearance and Behaviour; and the rather, as they went through their whole Exercise with the greatest Exactness. Last Tuesday the Prizes given by her Imperial Majesty to those of our Academy of Painting and Sculpture, who should excell most in those Arts, were adjudged to the greatest Proficients. A sew Days ago died suddenly Count Francis Esterhasy, who, in the Year 1751, was raised to the Rank of Field Marshal of her Imperial Majesty's Armies. M. Swacheim,

Copenhagen, Oct. 26. The Queen continues to advance happily in her Pregnancy. The Ship called the Ebenezer, one of those which our Afiatick Company proposes to send this year to the Indies, waits only for a favourable Wind to

proceed on her Voyage.

Warsaw, Oct. 26. The Deputies appointed by the Chamber of Nuncios to wait on their abfent Member, and to endeavour to prevail on him to return, having declared he was not to be found, and that they were informed he had left Warsaw soon after he lodged his Protest against their Proceedings; it was agreed, that as the Chamber had by that Means lost its Activity, the Diet could no longer subsist; and accordingly it was dissolved Yesterday, when the Nuncios took Leave of each other, in order to Fetufn to their respective Homes.

Berlin, Oct. 29. The Diversions for the Winter are not to begin till the 1st of December. They write from Stettin, that the Celebration of the Marriage of Field Marshal Count Schwerin with Madame de Wackenitz, was celebrated on the 20th Instant at the Castle of Schwerinsbourg; and that the Entertainments given on that Occasion were extremely magnificent.

Paris, Nov. 1. The Court will return from Fontainbleau to Versailles on the 18th

· Instant.

Hague, Nov. 5. Last Saturday being the Birth-Day of her Royal Highness the Princess Governante, who then entred into the Forty-Tixth Year of her-Age, there was a numerous and 'brilliant Appearance of the Nobility and Foreign Ministers at Court, to compliment her Royal Highness on that Occasion. The States of this Province will open their Assembly Tomorrow, for which Purpose most of the Members are already arrived. Baron Heekeren de Roderlo, has taken his Seat in the Assembly of the States General, on the Part of the Province of Guelderland. And this Morning the Baron de Capelle was introduced to the Council of State, and took his Seat in Quality of Deputy from the same Province. We are informed by our last Letters from Germany, that the Margravine of Brandebourg-Anspach, was a few Days ago seized with the Small Pox; but as it is, a favourable Sort, we hope it will be attended with no bad Consequence. We have received Advice from Haerlem, that a Fishing Vessel, belonging to Zandvoort, had the Misfortune to be cast away on the 30th of last Month; and that the Crew, consisting of six or fewon Persons, were all lost.

Whereas the Post Boy carrying the Hungersord Branch Mail, dispatched from this Office on Thursday the 10th Instant, was, upon Saturday iast, between Morden and Lawington in the County of Wilts, attacked and robbed, by two Highwaymen, who opened the said Mail, and took thereout the Lavington and Tinehead Bags of Letters, and like-wife took from the Post Boy sive Shillings, and otherwise used him very cruelly.

The only Description that is yet come to hand, of the two Persons who committed this Robbery, is, that the one was mounted upon a black Horse or Mare, the other

upon a brown one.
