St. James's, November 19.

Alt, Minister from the Court of Hesse Cassel, had this Day a private Audience of the King, and delivered a Letter to His Majesty from his most Serene Highness the Landgrave of Hesse Cassel.

Maples, October 16. Yesterday Cardinal Sersale, Archbishop of this City, arrived here from Sorento. Tis said the King has prevailed on the Pope to confer the Cardinal's Hat, that the Insant of Spain is about to resign, on Prince Tarente, his Majesty's Second Son.

Petersbaurg, Oct. 18. The Great Princess, and the young Prince of whom she was lately delivered, are as well as can be wished. Most of the Regiments that were assembled during the Summer, on the Frontiers of Courland, are going into Winter Quarters in Livonia and Ingria, where they are to hold themselves in Readiness to march, as Circumstances may require. The Great Chancellor Count Bestucheff is confined to his Apartment, but we hope his Indisposition will not be attended with any satal Consequences.

Leghern, Qt. 20. The Differences between the King of the Two Sicilies, and the Order of Malta, are upon the Point of being adjusted, on which Account their Ships pass by each other without Molestation. They write from Malta, that one of their Men of War has fallen in with an Algerine Corsair, which she took after a smart Engagement, and has brought her safe

into Port.

Rome, Off, 22. The Small-Pox continues to carry off great Numbers of the Inhabitants of this City. Cardinal Delci has received an Express from Florence, with an Account of the Death of Count Scipion, his Brother, of an Apoplectick Fit. The Persons lately confined in the Castle of St. Angelo, for playing at unlawful Games, were all fined considerable Sums, which they have since paid, and are set at Liberty.

Parma, Oct. 25. Their Highnesses our Sovereigns, who have passed some Time at Sala, are returned to Colorno, where they propose to stay till the End of next Month. The Duke

of Penthievre, High Admiral of France, is expected here To-morrow or next Day from Genoa, where he landed last Saturday Night.

Their Majesties set out Yesterday Morning from Drottningholm for Ulrichidahl, where they propose to reside till the new Palace, that has been building for fome Years in this City, is fit for their Reception, which the Workmen have engaged shall be ready by the Beginning of December next at farthest. The Marriage of Baron Hopken with Mademoiselle de Ribbing, one of the Ladies of the Bed-Chamber, has been declared at Court, and will be solemnized in a sew Days. Within these two Months past, several Counterseit Bank Notes for different Sums, have been discovered, and strict Search is making after the Authors of them; but 'tis generally imagined, that they were counterseited in Finland, and afterwards brought here.

Vienna, Oct. 30 'Tis said their Imperial Majesties have already declared their Intention of going in the Spring to Trieste, in order to see that the new Regulations, for promoting the Commerce of that Port, are duly carried into Execution. The Opening of the Assembly of the States of Lower Austria is fixed for the 12th of next Month. Yesterday their Imperial Majesties, accompanied by the Archdukes Joseph, Charles, and Peter Leopold, went to the Favourite, and reviewed the Regiment of Cuirassiers of Radicati, which is lately come, here to relieve that of Gelhay. They are going to introduce a new Exercise amongst the Imperial Horse, which was lately performed in the Presence of Prince

Lichtenstein, and greatly approved.

Copenbagen, Nov. 2. The King continues to go frequently to Jagersbourg, to take the Diversion of Hunting in that Neighbourhood. His Majesty has appointed young Count d'Osten to be one of the Gentlemen of his Bed-chamber. An Ordonnance is just published, for encouraging and promoting the Art of Resigning Sugars in this Kingdom.

Berlin, Nov. 5. The Queen-Mother, who spent best Part of the Summer at Monthijou, came here last Wednesday for the Winter.

The same Letters add, that the Marriage of the Hereditary Prince of that Name; with the Princess of Saxe-Cobourg, is to be celebrated at Cobourg towards the End of this Month. We have received an Account, that the Princess Mary Anne of Brnnswick-Bevern, died a few Days ago in the 26th Year of her Age. We hear from Erbach, that the reigning Countess of that Name was safely delivered of a Prince on the 29th of last Month, who was baptized the same Day by the Name of Francis.

Brussels, Nov. 10. Prince Charles of Lorrain, and the Princess Charlotte his Sister, set out on Thursday last for the Seat of Prince Ligne, where they propose to stay some Days, and then to continue their Journey for Mons, where the Princess Charlotte of Lorrain intends to reside. On Thursday last Field Marshal Count Chanclos was feized with an Apoplectick Fit, but he is since greatly recovered. Last Week M. Haaren, one of the Dutch Commissaries, returned here from the Hague.

Utrecht, Nov. 11. M. Mansvelt, ancient Burgomaster of this City, having resigned, on Account of his ill State of Health, the Place he held in the Council of our Regency, her Royal Highness the Princess Governance has appointed his Son, M. Abraham Mansvelt, to succeed him; and Yesterday he took his Seat in the said Council with the usual Formalities.

Leyden, Nov. 12. Her Royal Highness the Princess Governante having appointed M. vander Marck to be Chief Magistrate of this City, he was accordingly installed into that Office last Sunday i and Messrs. Hoogenhouck, de Bye, de Gerven, and van Buren, were declared Burgomasters. At the same Time M. Schoonhoven was declared Treasurer; and Messrs. van de Velde, and Alensoon, to be Deputies, one to the Chamber of Accompts of the Generality, and the other to the College of the Admiralty of Amsterdam.

Hague, Nov. 12. Sunday being the King of Great Britain's Birth-Day, the same was obferved here Yesterday, when the Ambassadors, Foreign Ministers, Lords of the Regency, and other Persons of Distinction, went to Court in their tichest Habits, to compliment her Royal Highness the Princess Governance on that Occasion. And in the Evening Col. Yorke, the British Minister, gave a magnificent Supper, and a Ball; to which all Persons of Distinction were invited.

Yesterday being the Anniversary of His Majesty's Birth-Day, the Great Guns were fired in His Majesty's Park the Phœnix, and answer'd by Vollies from the Regiments in Garrison, which were drawn out in the Royal Square at the Barracks: And this Day there was a numerous and splendid Appearance of the Nobility, and other Persons of Distinction, at the Castle, to compliment their Excellencies the Lords

Justices upon this happy Occasion, before whom an Ode was performed as usual. In the Evens ing there was a Play given by their Excellencies for the Entertainment of the Ladies; and the Night concluded with Bonfires, Illuminations, and all other Demonstrations of Joy.
