For Encouraging Seamen to enter themselves on Board His Majesty's Ships of War.

WHEREAS it is Our Royal Intention to give all due Encouragement for " to give all due Encouragement to all fuch Seamen, who fhall voluntarily enter themfelves in Our Service; We have thought fit, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation : And We do hereby promife and declare, That all fuch able Seamen, not above the Age of Fifty, nor under the Age of Twenty Years, fit for Our Service, who shall, on or before the Twentieth Day of February next, voluntarily enter themfelves to ferve in Our Royal Navy, either with the Captains or Lieutenants of Our Ships, or the Chief Officers on Board fuch Tenders, as shall be employed for raising Men for the Service of Our Navy, shall receive, as Our Royal Bounty, the Sum of Thirty Shillings each Man: And all fuch Ordinary Seamen fit for Our Service, who **Inall to enter themfelves as aforefaid, fhall re**ceive the Sum of Twenty Shillings each Man, as Our Royal Bounty; fuch respective Sums to

cations of the Seamen, fo entering themselves as aforefaid, shall be certified by the Captain, Mafter and Boatfwain of the Ship or Veffel where they fhall enter. And for Prevention of any Abuses, by any Persons leaving the Vessels to . which they fhall belong, and entering themfelves on Board any other Our Ships or Vessels, in order to obtain the faid Bounty Money; We do hereby declare and command, That fuch Seamen, belonging to any of Our Ships or Veffels, as shall absent themselves from any of the faid Ships or Veffels to which they fhall belong, and shall enter themselves on Board any other of Our faid Ships or Vessels, in order to obtain the faid Bounty, shall not only lose the Wages due to them in the Ships or Vessels they shall leave, but also be feverely punished according to their Demerits.
