THEREAS His Majesty was graciously pleased, by His Order in Council of the Twenty-seventh Day of March last, to direct, That the Bounties given by His Royal Proclamation bearing Date the Eleventh Day of the same Month, of Three Pounds for every Able Seaman, of Forty Shillings for every Ordinary Seaman, and of Twenty Shillings for every Able-bodied Landman, should be continued to be paid to every such Seaman and Landman respectively, who should, on or before the Thirtieth Day of this Instant April, voluntarily Enter themselves to serve in His Majesty's Royal Navy; and that a Reward of Two Pounds, likewise given by the faid Proclamation, should be continued to be paid to any Person, who should, on or before the said Thirtieth Day of this Instant, discover any Seaman, or Seamen, who should conceal themselves, so that such Seaman or Seamen should be taken for His Majesty's said Service—And whereas the Time limited by His Majesty's said Order in Council, for paying the faid Bounties and Rewards, is now near expiring; and His Majesty's Service requiring that the same should be continued for some longer Time: His Majesty, with the Advice of His Privy Council, doth therefore Order, and it is hereby Ordered, That the Time limited for Payment of the said Bounties and Rewards, be prolonged and extended from the said Thirtieth Day of this Instant April, to Tuesday the Twenty-seventh Day of May next inclusive. -Whereof all Persons concerned are to take Notice, and govern themselves accordingly.

Leghorn, May 2. Yesterday arrived the Conquest, Captain Pollard, in eight Days from Valencia, who brings Advice, that on the 21st of April five Spanish Chebecks fell in with three Algerines near Alicant, and after an Engagement of fixteen Hours, sunk the Algerines, whose Crews confisted of 1057 Men in all, of which 570 were taken up by the Spaniards; amongst them is the famous Cruiser Archimura, said to be Brother to the present Bey of Algiers. We have Letters from Algiers of the 26th of April, when they had carried in only one Dutch Ship, i. e. the Princess Dowager of Orange, Adrianus Vanderham, Master. Two Spanish Ships of War have retaken the Daniel, Dirk Dirkson, Master, belonging to Amsterdam, and carried her into Carthagina The Genoese Commissary at Bastia has lately been a little alarmed, by Reason of the Peasants in the neighbouring Villages having assembled under Arms, but 'tis thought they have no other Intentions than collecting the Contributions from the several Districts as they have often done.
