The Lords Justices in Council.

**W**HEREAS the Time limited by His Majesty's Order in Council of the Twenty-sixth of April last, for paying the respective Bounties therein mentioned, to all Able and Ordinary Seamen, and also to all Able-bodied Landmen, who should voluntarily Enter themselves in His Majesty's Royal Navy; and likewise for paying Rewards to Persons discovering any Seamen who should conceal themselves, will expire upon this Day: And whereas it is judged expedient for His Majesty's Service, that the Bounties and Rewards thereby given, should be continued to be paid for some longer Time—The Lords Justices do therefore Order, and it is hereby Ordered, with the Advice of His Majesty's most Honourable Privy-Council, that the Bounty of Three Pounds for every Able Seaman, of Forty Shillings for every Ordinary Seaman, and of Twenty Shillings for every Able-bodied Landman, be continued to be paid to such Seamen and Landmen respectively, who shall enter themselves in the Royal Navy on or before the Twenty-fourth Day of June next; and that the Reward of Forty Shillings to Persons discovering any Able Seaman or Seamen, who shall conceal themselves, so that such Seaman or Seamen be taken for His Majesty's said Service, be likewise continued to be paid until the said Twenty-fourth Day of June next inclusive.—Whereof all Persons concerned are to take Notice, and govern themselves accordingly.

*Naples, April 22.* Advice has been received at Court, that Don Joseph Martinez, Commander of the King's *Chebecks*, being on the 6th Instant on a *Cruise* off the Island of *St. Mary*, discovered at a Distance two *Tripolitan Corsairs*, to which he immediately gave Chace; and, after a short Time, came up with and took one of them; she mounted 12 Guns, besides *Patteraroes*, and had 50 Men on Board, who were all put in Irons, and carried into *Slavery*.

*Rome, May 3.* The Pope's two *Frigates* having cruized in the Channel of *Piombino*, off *Port Ferrairo* and the Island *del Giglio*, the *Barbary Pirates*, on their Appearance, are withdrawn from the *Roman Coasts*, and the *Frigates* are returned to *Civita Vecchia*. The Pope, for the farther Security of the Vessels at *Fiumicino*, has ordered a new *Pallisade* to be made immediately at that Port. From *Civita Vecchia* we are informed, that on the 30th past, a *Neapolitan Half Gally* sailed from that Port for *Naples*, with a *Tunefine Corsair*, which she had taken the Day before, after a short Engagement in the Channel of *Piombino*, on Board of which were 60 *Moors*, whom they had put in Irons.

*Vienna, May 3.* Their Imperial Majesties, who have been for some Days past at *Laxemb-*

*bourg*, propose to return to *Schonbrun* on the 12th Instant, in order to celebrate, on the 13th, the *Empress Queen's Birth-day*. *Prince Ligne* is arrived here from the *Low Countries* with the Prince his Son, who is going to be married to one of the Daughters of *Prince Lichtenstein*. *Count Betleem*, the new *Chancellor of Transilvania*, is expected here next Saturday from *Hermanstadt*, in order to lay before her Imperial Majesty the present State of Affairs in that Province.

*Petersbourg, May 3.* The *Turkish Minister*, who arrived here this Week, is to have his Audience after To-morrow.

*Munich, May 5.* On the 29th of last Month, about Three in the Afternoon, the *Lightning* fell on the Church of *Peysenberg*, about three Leagues from hence, and though the Tower was in Part thrown down, yet none of the People, who were then at their Devotions, received the least Hurt. Yesterday the *Electour* our Sovereign was taken extremely ill with a cholicky Disorder, but he is something better to Day, and we hope it will go off without any bad Consequences.

*Florence, May 10.* On the 27th past, in the Morning, the *Margrave and Margravine of Bareith* arrived here from *Genoa*, attended by a Retinue of about 30 Persons, among whom are three Ladies of Honour, and two Knights of *Malta*. They travel incognito by the Name *Count and Countess de la Marche*, and lodge at an Inn hired for them. On the 30th their Highnesses were entertained at Dinner by *Count Richecourt*, to which the *Foreign Ministers* (the *Pope's Nuncio* excepted) and many Persons of Distinction were invited; after which they were entertained with a Concert of Music. On the 5th in the Evening their Highnesses were entertained by *Count Richecourt* at his Country Seat, and, on the 7th, they sat out on their Journey to *Rome*. The *Regency* has ordered the Towers and small Forts along the Coasts, especially those at the *Serchio* and *Bocca d'Arno*, immediately to be provided with the necessary Stores and Men; for which Purpose, not to expose the regular Troops to the Inclemency of that Air, they have ordered a sufficient Number of Natives of those Coasts, consisting of about 180 Men, to be raised and distributed in the respective Towers, and a Troop of 80 *Cuirassiers* to patrol on the Shore, to prevent any Attempts which the *Algerines* might make to land. On the 28th a small Corsair from *Tunis*, with 20 Men, took Shelter at *Leghorn*, after an Engagement off *Corsica* with a Bark of that Island, in which the *Tunefine* lost four Men.

*Dusseldorp, May 10.* They are making Preparations at the Castle in this City for the Reception of the *Electour* our Sovereign, who is shortly expected here from *Manheim*.

*Turin, May 10.* The *Count de la Trinité*, Lieutenant General of Infantry, and Colonel of a Provincial Regiment in this Service, having been appointed *Viceroy of Sardinia*, set out last Sunday to embark at *Genoa* for that Island, and

and to succeed the Count Brigueras in that Government. The King of Sardinia and all the Royal Family are gone this Day to the Venerie to pass Part of the Summer Season there.

*Vienna, May 14.* Yesterday being the Empress's Birth-day, there was a great Appearance of Nobility and Foreign Ministers, &c. at Schonbrun. The Turkish Envoy is to have his first Audience of the Emperor this Day, and on Saturday next of the Empress. Chevalier Montecucoli, the Minister of Modena, sets out for Italy on Friday next, but is to return hither about the Beginning of August.
