Whitehall, September 16.

HE King landed this Day-about Noon at Margate, and arrived at Kensington about Nine o'Clock this Night, in persect Health.

Munich, Aug. 20. On Monday last the Elector of Cologn took Leave of all the Princes and Princesses, and Yesterday Morning he fet out for Italy, accompanied by the Baron de Roll, his Master of the Horse. His Highness travels incognito, by the Name of the Count de Werth, and proposes taking his Route by Inspruck, Verone, Venice, &c.

Bareith, Aug. 24. The Duke and Dutchess of Wirtemberg, who came here a few Days ·ago, to congratulate the Margrave and Margravine our Sovereigns on their safe Return from their late Tour to Italy, set out last Tuesday

Morning for Wirtemberg.

Cologn, Aug. 24. We hear from Coblentz, that the Elector of Treves, who had lately the Missortune to fall down Stairs and hurt his Knee, is so well recovered, that he intends to fet out in a few Days for Schonbornfust for the Remainder of the Summer. The Elector Palatin, and the Electress his Spouse, who embarked at Manheim last Thursday with a numerous Retinue, passed by here this Morning, and were saluted by a triple Discharge of the Cannon upon our Ramparts. 'Tis thought their Electoral Highnesses will reach Dusseldorp this Evening.

Stuttgard, Aug. 25. On Wednesday last the Duke our Sovereign, and the Dutchels his Spoule, arrived at Ludwigsbourg from Bareith, and on Saturday their Serene Highnesses came to their Palace in this City, in order to celebrate, on the 6th of next Month, the Anniversary of the Birth of her Highness the Dutchess, for which the necessary Preparations are already making.

Frankfort, Aug. 25. On Monday last, in the Asternoon, we had a most violent Hurricane in these Parts, which stripped off the Tiles from a great Number of Houses, and did other considerable Damage. 'Tis reckoned that upwards of one Thousand Trees were blown down by the Storm in the Neighbourhood of Croonenberg, a small Town about four Leagues from hence, belonging to the Elector of Mayence. We hear from Hanau, that the Landgrave of Hesse Cassel is expected there next Week. They write from Stuttgard, that the Duke and Dutchess of Wirtemberg returned there last Saturday from Bareith. We have received Advice, that the Princels of Hohenzollern-Sigmaringen was, a few Days ago, safely delivered of a Prince at the Castle of Sigmaringen, who

was baptized by the Names of Joachim-Adam-

Marie-Antoine, &c.

Munich, Aug. 26. The Elector and Electress, who went last Week to Herock, to take the Diversion of Hunting in that Neighbourhood, and afterwards to Landshut, returned to their Palace in this City Yesterday, which being the Feast of St. Lewis, whose Name the Margrave of Baden-Baden, Brother-in-Law to the Elector, bears, there was a very brilliant Court to compliment their Electoral Highnesses on that Occasion.

Dusseldorp, Aug 26. Last Night the Elector our Sovereign arrived here with his Spoule, and this Morning they were complimented thereupon by the Nobility, Gentry, Magistrates, and

all the Officers of the Garrison.

Dresden, Aug. 31. His Prussian Majesty. considering the Loss his Subjects sustain by the Prohibition of Commerce with Saxony, has agreed to the settling of it upon the former Footing. In Consequence thereof, it has been signified to the Merchants here, who traffick by the Way of Magdeburgh, that they may send their Vessels down the Elbe to the same Place. However the Merchants in Leipzig, upon Notice received of it, have desired that, as they had already ordered those Goods and Effects required for the next Fair to be carried by Waggons from Hamburgh, and as it would be a Detriment to them if the like Goods should be sold here at a cheaper Rate as coming by Water, the Grant to go down the Elbe might be deferr'd for a Fortnight; so this their Desire has been agreed to, and when that Time is elapsed, the Commerce will be opened again.

Vienna, Sept. 3. The Emperor went on Saturday last to Schloss-Host, where, and in the Neighbourhood, his Imperial Majesty will take the Diversion of Hunting until the 11th Instants Baron Klinggrave, the Prussian Minister at this Court, is gone to wait upon the King his Master, who is to be on the 4th Instant at Neiss itt Silesia, to make the annual Review of his Troops there; from whence that Minister will return hither, upon his Prussian Majesty's going back to Berlin. The Turkish Envoy, after having had his Audiences of Leave from their Imperial Majesties, waited, on Saturday last, upon Count Coloredo, Vico Chancellor of the Empire; and, the Monday following, upon Count Kaunitzs Great Chancellor of the Court; when both those Ministers delivered to him respectively, the Emperor's and the Empress's Presents for him, and for the Chiefs of his Attendants; so that he will set out, on his Return to Constantinople, in a few Days, extremely well satisfied withall the Civilities and Favours which he has received

Copenhagen, Sept. 5. The Anniversary of the Queen of Denmark's Birth-Day was celebrated, on the 4th Instant, at Friedensburg, in the usual Manner, and some Promotions were then made; the following Privy Counsellors, viz. M. de Plessen, M. vonder Osten, and M. des Mercieres, having received, on that Occasion, a certain Augmentation of Dignity, by the Ti-

tle of Privy Counsellors of Conference. Brussels, Sept. 9. According to our last Advices from Mons, the Prince of Soubise remained at Aimerie, where the Head Quarters were fixed; but the Troops under his Command were still in their Cantonments last Saturday. As the Weather seems to mend, we expect to hear, in a Day or two, of their being returned into their Camp. We likewise hear from Richemont, that the Troops assembled there have been also obliged, on Account of the Badness of the Weather, to break up their Camp, and to go into Cantonments. The Corps encamped at Aimegie consists of sixteen Battalions and twenty eight Squadrons, and that at Richemont of fifteen Battalions and twenty fix Squadrons.

Brussels, Sept. 12. Upon the Appearance of fine Weather, the French Troops had received Orders to prepare to quit their Cantonments, and to return into their Camp at Aimerie last Wednesday; but as we have again, had continual Rain for these three Days past, it is supposed that those Orders will have been countermanded. Count Lannoy, Governor of this City, was found dead in his Bed last Wednesday Morning. Venice, Aug. 29. This Evening his Serene

Highness the Elector of Cologne arrived here in · his Way to Rome.
