GEORGE R.

THEREAS our Parliament stands prorogued to Tuesday the Twenty Third Day of this Instant September; we, with the Advice of our Privy Council, do hereby publish and declare, That the said Parliament shall be further prorogued, on the said Twenty Third Day of September, to Thursday the Thirteenth Day of November next; and we have given Order to our Chancellor of Great Britain, to prepare a Commission for proroguing the same accordingly. And we do hereby further declare our Royal Will and Pleasure, That the said Parliament shall, on the said Thirteenth Day of November next, be held, and fit for the Difpatch of divers weighty and important Affairs: And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required to give their Attendance accordingly at Westminster on the said Thirteenth Day of November next.

the Reign of His present Majesty, in that Case made and provided—His Majesty doth, by and with the Advice of His Privy Council, by this His Order in His Privy Council, require and command, that the said John Byrn do surrender himself, within the Space of Forty Days after the First Publication of this Order in the London Gazette, to the Lord Chief Justice, or one other of His Majesty's Justices of the Court of King's Bench, or to one of His Majesty's Justices of the Peace.

Kensington, September 21.

This Day Prince Golitzin, Envoy Extraordinary from the Empress of Russia, had his sirst private Audience of His Royal Highness the Prince of Wales.

And afterwards his first private Audience of the Princes Dowager of Wales at Carleton To both which he was introduced by Sir Clement Cottrell Dormer, Knt. Master of the Ceremonies.

Petersbourg, Aug. 23. The Empress, who has been for some Time past at Petershof and Czarkazelo, came to her Palace in this City on the 13th Instant, which was immediately proclaimed to the People by a triple Discharge of the Cannon of the Fortress and the Admiralty. Their Imperial Highnesses the Great Duke and Great Dutchess came here likewise the same Day from Oranienbaum.

Warfaw, Aug. 25. We are informed by our last Letters from Lithuania, that the Distemper amongst the horned Cattle is broke out again in the Palatinate of Podlachia, and car-

ries off great Numbers.

Stockholm, Aug. 26. The Court is still at Drottningholm, where Count Sintzendorff, who arrived here lately from Petersbourg, has been presented to their Majesties and the Royal Family. We hear from the different Provinces of this Kingdom, that the Elections of their Deputies to assist at the next General Diet, are carried on with great Unanimity; and, as the Time for holding the said Diet is drawing near, the Senators, who have been for some Time at their Country Seats, are daily returning to this City.

Berlin, Sept. 6. The King, who came here last Tuesday from Potzdam, dined that Day with the Queen Mother at Montbijou; and the next Morning his Majesty set out for Silesias accompanied by the Prince of Prussia, Prince Maurice of Anhalt-Dessau, the Duke of Holstein, Major General Retzow, and several other

General Officers.

Breslaw, Sept. 6.—Last Thursday Morning & King of Prussia arrived at Glogaw, and the King of Prussia arrived at Glogaw, and having

having reviewed the Troops in Garrison at that Place, took the Route by Schwednitz, and arrived that Night at Neiss. Yesterday his Majesty reviewed the Regiments that were assembled, by his Order, in the Neighbourhood of Tschirna, and this Night is expected in this City, where great Preparations are making for his Reception.

Vienna, Sept. 8. Yesterday his Highness the Duke of Modena was declared Veldt Marechal, and Colonel Proprietor of the Regiment of

Horse late Czernini's.

Berlin, Sept. 9. The King is expected at Potzdam from Silesia, towards the latter End of this Week.

Dresden, Sept. 14. The Differences, with respect to Commerce, between this Court and that of Berlin, are not yet entirely made up. Count Vitzthuin being appointed his Polish Majesty's Minister to the Court of France, sets out

this Day on his Journey to Paris.

Hague, Sept. 16. On Thursday last in the Evening her Royal Highness the Princess Governante arrived here from Soestdyk, with the young Prince Stadtholder, and the Princess Caroline his Sister. And the same Night her Royal Highness received the Compliments of the Lords of the Regency, and several other Persons of Distinction, upon her safe Arrival.

Brussels, Sept. 19. By Letters received this Morning from Mons, we are informed, that the French Troops returned into their Camp at Aimerie the Day before Yesterday. Prince San Severino arrived here the Day before Yesterday from Hanover. And Yesterday Count Colloredo went to Mons, where he purposes to review his Regiment, and then to proceed next

Monday on his Return to England."
