As it is with the fullest and most dutiful Sense of the many inestimable Blessings deriv'd to us thro' the unvaried Wisdom and Goodness of your Majesty's Administration, that we prefume to approach your Royal Throne; so we cannot omit our most grateful Acknowledgements of your Majesty's unspeakable Vigilance and affectionate Concern for the Interest of your People, in seasonably providing for the Security of their Trade, and the Desence of their Possessins, against the Attempts of a restless and powerful Invader of them.

May your Majesty's Measures for vindicating the Rights of your Crown, and restoring the publick Tranquillity, be attended with Success as eminent, as the Vigour and Firmness with which they are conducted; and may your Majesty long enjoy the Returns of Duty and Allegiance, from a happy and sourishing People.

Kensington, October 5.

This Day Count Viri, Envoy Extraordinary from the King of Sardinia, had a private Audience of his Royal Highness the Prince of Wales.

And afterwards a private Audience of her Royal Highness the Princess Dowager of Wales, at Carlton House.

To both which he was introduced by Charles Cottrell, Esq; Assistant Master of the Ceremonies.

Lisbon, Sept. 22. On the 1st Instant the Fleet from Rio de Janeiro anchored in this River, consisting of 28 Ships from thence, and seven from Fernambuco, under the Conyoy of a Man of War. The Treasure on Board of the latter is computed at about Eight Millions of Cruzados, one Million of which belongs to the King, and the rest to the Commerce, bessides a great Quantity of Hides, and other Articles of the Produce of those Parts, brought home by the Merchantmen. The Bahia Fleet, consisting of 19 Merchantmen under Convoy of a Man of War, arrived here on the 19th In-

Itant, together with two Ships from the Indiesa. The Treasure amounts to between two and three Millions of Cruzados, much the greater Part of which belongs to the Commerce, besides 10,000 Rolls of Tobacco, 5000 raw and as many tanned Hides. In one of the India Ships came home the Marquis de Tavora; late Viceroy of Goa, with his Lady, who have both met with a most gracious Reception from their most Faithful Majesties.
