Westminster, November 13.

IS Majesty came this Day to the House of Peers, and being in his Royal Robes seated on the Throne with the usual Solemnity, the Honourable Sir Henry Bellenden, Gentleman Usher of the Black Rod, was sent with a Message from His Majesty to the House of Commons, commanding their Attendance in the House of Peers. The Commons being come thither accordingly, His Majesty was pleased to make the following most gracious Speech.

My Lords, and Gentlemen,

HE present critical Conjuncture of Affairs, and my constant Inclination to have the Advice and Assistance of my Parliament on all important Occasions, have made me desirous to

meet you here as early as possible.

Since your last Session, I have taken such Measures as might be most conducive to the Protection of our Possessions in America, and to the Regaining of such Parts thereof, as had been encroached upon, or invaded, in Violation of the Peace, and contrary to the Faith of the

most solemn Treaties.

For this Purpose, the Maritime Force of this Kingdom has been got ready with the utmost Application and Expedition, and been principally employed; some Land Forces have been sent from hence to North America; and all proper Encouragement has been given to the several Colonies there, to exert themselves in their own Defence, and in the Maintenance of the Rights

and Possessions of Great Britain.

With a fincere Desire to preserve my People from the Calamities of War, as well as to prevent, in the Midst of these Troubles, a general War from being lighted up in Europe, I have been always ready to accept reasonable and honourable Terms of Accommodation; but none such have hitherto been proposed on the Part of France. I have also confined my Views and Operations to hinder France from making new Encroachments, or supporting those already made; to exert our Right to a Satisfaction for Hostilities committed in a Time of profound Peace; and to disappoint such Designs, as, from various Appearances and Preparations, there is Reason to think, have been formed against my Kingdoms and Dominions.

By these Methods, I have pursued the Plan which I formerly pointed out to you, and for which I had the Satisfaction to receive the strongest Assurances of your vigorous Support.

What other Power can object to Proceedings so absolutely necessary to our own Desence and Security? My good Brother, the King of Spain, sees with Concern these Differences; and the Part which he generously takes in the comm 1 Welfare of Europe, makes him earnestly with the Preservation of the publick Tranquility. He has also given Assurances, that he will cost-

tinue in the same pacifick Sentiments.

In pursuing these great Ends, I make no Doubt of the vigorous and chearful Support of my Parliament; and that, whilst I ain engaged. in this just and national Cause, the affectionate Assurances which they gave me the last Session, will be effectually made good. In Consequence thereof, I have greatly increased my Naval Atmaments; augmented my Land Forces in such a Manner as might be the least burthensome's and have concluded a Treaty with the Emple's of Ruffia, and another with the Landgrave of Heffe Cassell, which shall be laid before you.

Gentlemen of the House of Commons,

I have ordered the proper Officers to lay before you Estimates for the Service of the ensuing Year, and likewise Accounts of the extraordinary Expences which have been made this Year, in Pursuance of the Power given me by Parliament. I see, with great Concern, that the necessary Services before-mentioned will require large Subplies. I ask only such as shall be requisite for the effectual carrying on of those Measures, which shall be necessary to support what has been begun, according to your Inclination, for the Security of my Kingdoms and Dominions, and for the Purposes which have been already mentioned to you. Whatever you grant shall, with the strictest Œconomy, be applied to those Uses only for which it shall be given.

My Lords, and Gentlemen,

I rely upon your Duty and good Affections, which I have so often experienced. never was a Situation in which my Honour, and W the essential Interests of Great Britain, called more strongly for your Zeal, Unanimity, and Dispatch.

#### A PROCLAMATION,

For recalling and probibiting Seamen from serving Foreign Princes and States; for giving Encouragement to Seamen and Able-bodied Landmen to enter themselves on Board His Majesty's Ships of War; for granting Rewards for discovering such Seamen as shall conceal themselves; and also for taking up all Straggling Seamen.

GEORGE R.

THEREAS we are informed, That great Numbers of Mariners and Sea-faring Men, our natural-born Subjects, are in the Service of divers Foreign Princes and States, to the Prejudice of our Kingdom; We have therefore thought it necessary, by and with the Advice of our Privy Council, to publish this our Royal Proclamation; and do hereby strictly charge and command all Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, and other Seafaring Men whatsoever, and wheresoever (being our natural-born Subjects) who are in the Pay or Service of any Foreign Prince or State, or do ferve in any Foreign Ship or Vessel, that forthwith they, and every of them, do (according to their known and bounden Duty and Allegiance) withdraw themselves, depart from, and quit such Foreign Services, and return Home to their Native Countries: And further, we do hereby Arically prohibit and forbid all Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, and other Sea-faring Men what loever (being our natural born Subjects) from entering, and do charge and command them, and every of them, from henceforth to forbear to enter themselves into the Pay or Service of any Foreign Prince or State, or to serve in any Foreign Ship or Vessel whatfoever, without our special Licence first had and obtained in that Behalf; to all which we expect due Obedience and exact Conformity. And , we do hereby publish and declare, that the Offenders to the contrary, shall not only incur our just Displeasure, but be proceeded against for their Contempt, according to the utmost Severities of the Law. And we do hereby declare, that if any such Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, or other Seafaring Men (being our Subjects) shall be taken in any Foreign Service by the Turks, Algerines, or any others, they shall not be redeemed by us as Subjects of Great Britain. And whereas it it our Royal Intention to give all due Encouragement to such Seamen and Landmen, who shall voluntarily enter themselves in our Service, we do hereby promise and declare, That the Bounties of Three Pounds for every Able Seaman, and of Thirty Shillings for every Ordinary Seaman, be paid to every such Able I Discovery; the said Certificate to be given by and Ordinary Seaman not above the Age of Fifty, nor under the Age of Twenty Years, who shall, on or before the Thirty First Day of

December next, voluntarily enter themselves to ferve in our Royal Navy, either with the Captains or Lieutenants of our Ships, or the Chief Officers on Board such Tenders as shall be employed for railing Men for the Service of out Royal Navy; and also that a Bounty of Thirty Shillings be paid to every Able-bodied Landman. not above the Age of Thirty Five, nor under the Age of Twenty Years, who shall, on or before the said Thirty First Day of December next, voluntarily enter themselves to serve in our Royal Navy, either with the Captains or Lieutenants of our Ships, or the Chief Officers on Board fuch Tenders, as shall be employed for raising Men for the Service of our Royal Navy: and that such respective Sums be paid them by the Clerks of the Cheque residing at the Ports or Places where the Ships into which they shall be entered shall be, immediately after the Third Muster of such Seamen and Landmen. And we do declare, that the Qualifications of the Seamen and Landmen so entering themselves, shall be certified by the Captain, Master, and Boatswain, of the Ship or Vessel where they shall enter. And for Prevention of any Abuses by any Persons leaving the Ships or Vessels to which they shall belong, and entering themselves on Board any other our Ships or Vessels, in order to obtain the said Bounty Money; we do hereby declare and command, that such Seamen or Landmen belonging to any of our Ships or Veffels, as shall absent themselves from any of the faid Ships or Vessels to which they shall belong, and shall enter themselves on Board any other of our Ships or Vessels, in order to obtain the said Bounty, shall not only lose the Wages due to them in the Ships or Vessels they shall leave, but also be severely punished according to their Demerits. And we do hereby further promise and declare, That a Reward of Two Pounds for every Able, and Twenty Shillings for every Ordinary Seaman, shall be paid any Person who shall discover any Seaman or Seamen who may secret themselves, so that such Seaman or Seamen shall be taken for our said Service, on or before the said Thirty First Day of December next, by any of our Sea Officers employed for raising Men; the said Rewards to be paid for any Seaman or Seamen so discovered and taken in and about London, by the Principal Officers and Commissioners of our Navy; and at the Out-ports by the Naval Officers (where there are any) and (where there are no Naval Officers) by the Collectors of our Customs, immediately upon a Certificate being produced to the faid Principal Officers and Commissioners of our Navy, Naval Officers, or Collectors respectively, by the Person who may make Discovery of any Seaman or Seamen as aforesaid, certifying his Name, and the Name or Names, and Number of Seamen procured in Consequence of his such Officer as may take such Seaman or Seamen for our Service. And we do hereby require and command all our Justices of the Peace, . Mayors,

Mayors, Bailiffs, and Magistrates, of the several Shires, Counties, Cities, Towns Corporate, and all other Places within our Kingdom of Great Britain, to give the strictest Orders and Directions to the Constables and other inferior Civil Officers to take up all Straggling Seamen, not above the Age of Fifty, not under the Age of Twenty Years, who shall be of Health and Ability fit for our Service; and that they do exert themselves in this Service, and take care that the inferior Civil Officers be diligent in the Discharge of their Duty herein: And that the faid Magistrates do cause all Seamen so taken up, and fit for our Service, to be conducted by such Constables or inferior Civil Officers, or other proper Persons, to the Clerk of the Cheque of any of our Yards, or to a Regulating Captain in London, or any other Place, or to any Port or Place where any of our Ships or Vessels may be, or to any Officer of our Navy employed in raising Men: And that the Persons who shall be intrusted with the conducting such Straggling Seamen, be paid a Reward of Two Pounds for every Able Seaman, and Twenty Shillings for every Ordinary Seaman, received from them for our Service, over and above Six Pence a Mile for every Mile they shall travel with such Seaman or Seamen, not exceeding Twenty Miles: Which respective Rewards are to be paid by the Clerks of the Cheque of our Yards, where any of the said Men shall be delivered to them; or if delivered to a Regulating Captain in London, that the faid Rewards be then paid by the Commissioners of our Navy; or if delivered to any of the Officers of our Navy employed in raising Men, that then the said Rewards be paid by the Collector of our Customs residing at or nearest to the Place where such Men shall be brought, upon producing a Certificate from the Officer of our Navy, to whom such Men shall be delivered, of the Names and Number of Men received by him; and the said Collector of our Customs is to take a Receipt on the Back of the said Certificate for the Sum he pays; which Sum the Commissioner's of our Navy are required to reimburle to the faid Collector of our Customs, upon his transmitting such Certificate and Receipt to them.

This Day the Right Honourable Sir Thomas Robinson having resigned the Seals into the King's Hands, His Majesty was pleased to appoint the Right Honourable Henry Fox to be one of His Majesty's Principal Secretaries of State.
