The paternal Care which your Majesty at all Times discovers for the Prosperity and Protection of your People; the Vigilance which your Majesty exerts in Defence of your Kingdom and Colonies against the Encroachments and perfidious Designs of restless Neighbours, inspire our Hearts with the strongest Gratitude and unshaken Attachment to your Majesty's sacred Person, Family, and Government.

That your Majesty's precious and inestimable Life may be long preserved to promote the Felicity of Great Britain, is the unfeigned and fervent Prayer of this always loyal City.

Cologn, Nov. 9. Last Night the Imperial Courier passed through this Town, with the good News of her Imperial Majesty's being safely delivered of an Archdutchess the 2d, between Seven and Eight at Night. The Elector of Cologn came to Rome the 20th past, took Leave of the Pope, and the Cardinal Secretary of State next Day, and was to let out the 23d for Venice. The Elector of Palatine sets out from Dusseldorf in a few Days, intending to be at Manheim before the 19th. The Prince of Deux Ponts set out the 6th, and the Great Marshal passed through this Town, in his Return to Manheim, the 7th.

Brassels, Nov. 11. We are positively asfured, that the French have assembled upon the Esplanade at Douay, between six and seven hundred Waggons. We are likewise informed, that Orders have been given by the Court of France for augmenting the Irish Brigade with 20 Men per Company. A Messenger arrived here Yesterday from Vienna, with the Nev ! that the Empress Queen was safely delivered of

an Archutchess on the 2d Instant.

Brussels, Nov. 14. All the Waggons that were lately assembled on the Esplanade at Douay, are gone empty from thence, and had been employed in transporting Carriages and Wheels for Cannon, which had been made at Peronne and St. Quentin. On the 1st Instant, 24 Pieces of Cannon were likewise brought from Arras, to the Arsenal at Douay, to be new cast. Our Advices add, that a great Number of Blacksmiths and Wheelwrights had been pressed to work in that Arsenal, where every Thing was preparing with the greatest Diligence.
