The humble Address of the Provost, Magistrates and Council of Aberdeen.

May it please your Majesty,

AT a Conjuncture, when the Rights of Great-Britain are openly violated, when her Colonies are invaded, and her Trade, the Source of Power, threatened with Ruin; permit the grateful Thanks of a Trading City, humbly to reach Your Royal Ear, for the truly paternal Care taken of our Brethren in America, and the excellent Provision made for our Defence at Home.

As ever fince the glorious Revolution, the Juccessive Magistracies of this flourishing City have app oved themselves in the Worst of Times, firm Friends to the Protestant Succession and to Your Royal Famly; we most humbly beg Leave to assue Your Majesty of the Intrease of the same Zeal and Affection to Your Sacred Person and Government: For convinced as we are, that our Religion, our Liberties, and every Thing estimable among Men, depend upon our present invaluable Establishment, we will think nothing too dear to venture in the happily united Cause of the best of Constitutions, and the best of Kings.

That Almight God, in Mercy to these Your Kingdoms, may long preserve Your Majesty's precious Life; may crown Your Arms with Success and Victory, until the Peace and Trade of Your extensive Dominions be settled on firm and honourable Foundations, are the ardent Wishes, and constant Prayer, of the Provost, Magistrates, and Council of Aberdeen. By Letters this Day from Sir Benjamin Keene, there is an Account, that his Excellency had received a Letter from Mr. Castres, his Maziesty's Envoy Extraordinary to the King of Portugal, dated the 4th past, in which he mentions that the English Subjects, residing at Lisbon, being in a very distressed State, and their

House destroyed, most of them were embarking for England; and that he was sending a sull and particular Account of the late deplorable Event, to London, by Sea. And by private Letters it appears, that Mr. Consul Hay, the Dutch Bravey, and their Families, and likewise the Dutch Consul, were safe.

Modrid, Nov. 17. Letters from Gibraltat of the 7th Instant make no Mension of the Earthquake; but from the Spanish Camp at Sua Roque, there is an Account that it was sele in those Parts, but has done no great Dumpge either by Sea or Land.

Genoa, Nov. 4. We are informed by the Master of a Ship lately arrived in this Port from the Coast of Barbary, that the Algorines 400 sitting out several new armed Vessels to cruise on the Ships of such Christian Powers with whom they are at War. By our last Advices from Corsica, every Thing seems quiet in that Island, the Divisions amongst the Chiefs of the Malecontents putting it out of their Power to form any Enterprize for the present.

Warfaw, Nov. 8. Last Week we had very stormy Weather in these Parts, which did great Damage in many Places, and particularly amongst the Barks upon the Vistula; one of which, laden with rich Merchandize from Dantzick, was lost.

Dresden, Nov. 16. On Monday last their Highnesses the Electoral Prince and Princess returned from St. Hubertsburgh. Their Polish Majesties, and the rest of the Court, are also expected here this Week. M. Broglio, the French Ambassador, arrived at St. Hubertsburgh the 6th, and came to this Town on Wednesday last the 12th Instant.

Dresden, Nov. 19. The Court is expected here from St. Hubertsburgh towards the latter End of next Week. With Respect to the Conferences at Halle, it is generally assured that they will prove stuitless, and that Commercial Affairs will be rather worse than better.

Liege, Nov. 20. The States of this Principality have, for the Improvement of Commerce, agreed to a Project for making a High Road from hence to Bois-le-Duc; and two Commissaries are appointed to see the same carried into Execution. Such prodigeous Quantities of Rain have fallen in this Country since the Baginning of this Month, that the Maels has overflowed its Banks, and laid all the lower Parts of this City under Water.

Hogue, Nov. 25. The Deputies of the several Colleges of the Admiralty of these Provinces continue to deliberate on the Affairs of their Department; and To-morrow the States of

of Holland and Westfrizeland will open their ordinary Assembly; for which Purpose most of the Members are already arrived. Yesterday the new Council and Magistrates of this Place were fworn in for the Year ensuing, and took their tespective Scats in the accustomed Manner.
