Hereas the Time limited by His Majesty's Order in Council, of the 28th of February last, for paying the respective Bounties therein mentioned, to all Able and Ordinary Seamen, and also to all Able-bodied Landmen, who should voluntarily enter themselves in His Majesty's Royal Navy; And likewise for paying the Rewards to Persons discovering Seamen who should conceal themselves, will expire upon the 31st Day of this Instant March.-And whereas it is judged expedient for His Ma-jesty's Service, That the Bounties and Re-wards thereby given should be continued to be paid for some Time longer: - It is thereupon this Day Ordered in Council, that the Bounties of Three Pounds for every Able Seaman, and of Thirty Shillings for every Ordinary Seaman, not above the Age of Fifty, nor under the Age of Twenty Years; and of Thirty Shillings for every Able-bodied Landman, not above the Age of Thirty-five, nor under the Age of Twenty Years, be continued to be paid to such Seamen and Landmen respectively, who shall, on or before the 30th Day of April next, enter themselves in the Royal Navy, in the Manner directed by His Majesty's Proclamation of the 11th Day of November last. And likewise that the Rewards of Two Pounds for every Able, and Twenty Shillings for every Ordinary Seaman, be continued to be paid to any Persons who shall, on or before the said 30th Day of April next, discover any Seaman or Seamen, who shall conceal themselves, fo as such Seaman or Seamen be taken for His Majesty's Service. Whereof all Persons concerned are to take Notice, and govern them-W. Sharpe. . felves accordingly.

Most Gracious Sovereign; YOUR Majesty having been graciously, pleased to acquaint Your Two Houses of Parliament, that a Defign hath been formed by the French Court; to make an Hostile Invasion upon Great Britain or Ireland; We Your Majesty's most dutiful and loyal Subjects, the Lord Mayor, Aldermen, and Commons; of the City of London; in Common Council assembled, beg Leave to express our Abhorrence of so unjust and desperate an Enterprize, projected in Revenge for Your Royal and Gracious Protection of the Trade and Commerce of Your People, and the necessary Defence of the undoubted Rights and Possessions of Your Crowns

With Gratitude, and unfeigned Loyalty, we most humbly assure Your Majesty, that the Citizens of Your faithful City, united in Duty and Affection to Your Sacred Person and Government, will exert their utmost Power, and Hazard their Lives and Fortunes, to Support and Defend Your Majesty, and the Protestant Succession in Your Royal Family, not doubt-ing, but by the Zeal and Loyalty of Your Majesty's Subjects, conducted by Your known Wildom and Courage, with the Affistance of the Divine Providence, You will be able to defeat all the Defigns of Your Enemies.

To which Address His Majesty was pleased to return this most Gracious Answer.

I Thank you for this very Loyal and Dutiful Address. I have the firmest Reliance on the affectionate Assurances you give Me, of exerting yourselves to the utmost in Support of My Government; and the City of London may always depend upon My Favour, Countenance and Protection; and My constant Care to defend the Rights and Possessions of My Crown, and promote the Trade and Commerce of this Kingdom.

Dresden, March 21. The Reduction proposed in the Troops of this Electorate has now taken Place, viz. of one Serjeant, five private Men, one Fifer, and one Drummer, per Company, and one Band of Hauthoys in the Regiment of Grenadiers. The Plague being lately broke out here, I am obliged to shut up myself and Family in my House, on Account of that dreadful Calamity, (all the Confuls and Merchants having done the fame.) This Distemper has fince increased.

Extract of a Letter from Mr. Castres to Mr. Secretary Fox. Lisbon, March 15, 1756. His most Faithful Majesty having signified His Pleasure, that before any Distribution was made among the Portuguese, I would let M. de Carvalho know what Quantity of Provisions I should think might be allotted for the Poor of our Nation, Mr. Hay, and two or three more of the Members of this Factory, had a Meeting about it at my House, where we agreed to apply for the Thirtieth Part of the Whole; which was immediately ordered to a particular Warehouse, and the Key of it deliver'd to Mr.

Barrett, a Gentleman of this Factory, who has acted, from the Beginning, as Supervisor to the Cargoes, to fee that they were punctually delivered to the Portuguese Officers. As to the Money, the Part of it, that is to be assigned for His Majesty's Subjects, will amount to something more than Two Thousand Pounds Sterling, and shall be put into Mr. Hay's Hands, as foon as the Court shall have ordered this Sum

to be made over to us.

They have lately had the Satisfaction at Court, to hear, by Letters of the 20th of November from the Bahia, by Way of the Western Islands, that they had been entirely free in the Brazils, of the Calamities felt in these Parts by the fatal Earthquake of the 1st of November.
