The Lords of His Majesty's most Honourable Privy Council.

Hereas the Time limited by His Majesty's Order in Council, of the 28th of February last, for paying the respective Bounties therein mentioned, to all Able and Ordinary Seamen, and also to all Able-bodied Landmen, who should voluntarily enter themselves in His Majesty's Royal Navy; And likewise for paying the Rewards to Persons discovering Seamen who should conceal themselves, will expire upon the 31st Day of this Instant March .-And whereas it is judged expedient for His Majesty's Service, That the Bounties and Rewards thereby given should be continued to be paid for some Time longer: — It is there-upon this Day Ordered in Council, that the Bounties of Three Pounds for every Able Seaman, and of Thirty Shillings for every Ordinary Seaman, not above the Age of Fifty, nor under the Age of Twenty Years; and of Thirty Shillings for every Able-bodied Landman, not above the Age of Thirty-five, nor under the Age of Twenty Years, be continued to be paid to fuch Seamen and Landmen respectively, who shall, on or before the 3cth Day of April next, enter themselves in the Royal Navy, in the Manner directed by His Majesty's Proclamation of the 11th Day of November last. And likewise that the Rewards of Two Pounds for every Able, and Twenty Shillings for every Ordinary Seaman, be continued to be paid to any Persons who shall, on or before the said 30th Day of April next, discover any Seaman or Seamen, who shall conceal themselves, fo as such Seaman or Seamen be taken for His Majesty's Service. Whereof all Persons concerned are to take Notice, and govern them-felves accordingly. W. Sharpe.

HIS Day, the Lords being met, a Mesage was sent to the Honourable House of Commons, by the Honourable Sir Henry Bellenden, Gentleman Usher of the Black Rod, acquainting them, that, The Lords, authorized by Virtue of his Majesty's Commission, for declaring his Royal Assent to several Acts agreed upon by both Houses, do desire the immediate Attendance of this Honourable House in the House of Peers, to hear the Commission read; and the Commons being come thither, the said Commission, impowering his Royal Highness the Duke of Cumberland, the Lord Archbishop of Canterbury, the Lord High Chancellor, and several other Lords, to declare and notify the Royal Assent to several publick and private Bills, was read accordingly, and the Royal Assent

An Act for granting to his Majesty several Rates and Duties payable by all Persons and Bodies Politick or Corporate, having certain Quantities of Silver Plate.

An Act for granting to his Majesty a Duty apon Licences for Retailing Beer, Ale, and other Excisable Liquors, and for establishing a Method of granting such Licences in Scotland, and for allowing such Licences to be granted at a Petty Session in England, in a certain Case therein mentioned.

Posnania, March 29. Last Tuesday Morning a most violent Hurricane of Wind came on in these Parts, and continued almost the whole Day. The Damage it did to the Churches, Houses, and Gardens, in and about this City,

Venice, April 2. Procurator Marc. Antonio Giustinian died here some Days ago, in the 8oth Year of his Age. Sig. Niccolo Erizzo sets out in a sew Days on his Embassy to France, in the room of Sig. Alvise Mocenigo, who is to return Home; and M. Du Fort is expected in the Character of Ambassador from

France to this Republick.

Frankfort, April 4. The River Main has role confiderably for fome Days past, occasioned by the late heavy Rains, which makes us fearful least it should overflow its Banks, and lay

the Country under Water.

Hambourgh, April 9. M. Buys, Minister from the States-General, having delivered to these Magistrates his Letters of Revocation, which he lately received from his Principals, sets out To-morrow for the Hague, where he is appointed a Member of the High Council; and his Successor in this Post, M. Mauritius, is not expected at Hamburgh till the beginning of June next.

Dusseldorp, April 9. The Elector of Cologn arrived here last Wednesday Evening, in order to spend a few Days with the Elector

Palatine.

Hague, April 13. The States of Holland and Westfrizeland are to open their Assembly To-morrow, for which Purpose most of the Members are already arrived. The Prince of Nassau-Weilbourg did not leave this Place till Yesterday Morning, when he set out for Helvoetsluys, in order to embark for England.
