WE your Majesty's most dutiful and loyal Subjects, the Mayor, Bailiffs, Burgesses, and Inhabitants, of the Borough of New Windsor in the County of Berks, most humbly beg your Majesty's Permission, at this Time, to lay before you our most grateful Acknowledgments for the many Blessings these Kingdoms enjoy under your Majesty's Protection and Government.

The ambitious Schemes and dangerous Defigns of the French Court; the Usurpations and Encroachments made by them on your Majesty's Territories in the West-Indies and North-America; their repeated Acts of Violence committed in those Parts; the Enlarging the Fortifications of Dunkirk in Breach of the most solemn Treaties; the Threatning to invade these Kingdoms; and the hostile Invasion actually made of your Island of Minorca, have justly made it necessary for your Majesty in Vindication of your own Honour, and the Welfare of your Subjects, to declare War against the French King.

Your Majesty's Moderation and Endeavours, for an Accommodation to avoid a War, will convince the World of the Justice of this Un-

dertaking.

We therefore, most truly sensible of the Duty we owe to your Majesty, do with the warmest Zeal assure your Majesty of our utmost Assistance in Support of so good a Cause, and of the Measures taken by your Majesty for the Honour of your Crown, and the Desence and Protection of your Subjects, who can never be an happy and free People, but under the Government of your Majesty, and your Illustrious House,

WE your Majesty's most dutiful and loyal Subjects, the Justices of the Peace, assembled at their General Quarter Sessions, and the High Sheriff, Gentlemen, Clergy, and Freeholders of the County of Oxford, beg Leave to express our Indignation at the manifest Preparations of the French Court, to execute a daring and unjust Design of invading some Part of your Majesty's Dominions.

It is natural for every People to exert themfelves in repelling Invasions; but we, your Majesty's Subjects, have an higher Call, a superiour Motive, to employ our Fortunes and expose our Persons on such an Emergency. Other Nations, by the Fate of War, may exchange one Servitude for another; but we have a Free Government to lose, which Providence permitted to be established among us at the Revolution, and to be improved under your Majesty's Royal Family.

Accept therefore, the dutiful and ardent Professions of your loyal Subjects of the County of Oxford, the Tender of awakened Zeal in this critical Conjuncture, and the strongest Assurances of our utmost Services in Defence of our Commercial Interests, and of our Religious and Civil Liberties, which will continue to slourish, we hope, under your Majesty's Protection, for many Years, and under your Royal House to

Most Gracious Sovereign,

YOUR Majesty's just Resentment of the Encroachments of the French in America, has compell'd that Nation to throw off the Mask of Peace, under which they have carried on Designs so pernicious to Great Britain. Hostilities are begun in Europe. War is now declared: — France has invaded Minorca, and threatens with Invasion the British Isles.

In this critical Situation of Publick Affairs, we your Majesty's most dutiful and loyal Subjects, the Ministers and Elders of the Church of Scotland, met in the National Assembly, think it our Duty to express our deep Concern for the general Welfare, and our affectionate Regard for a Prince, who is the Guardian of Liberty, and the Father of his People: And we heartily embrace this Opportunity of giving

your Majesty Assurances, which cannot fail of being acceptable to your benign Disposition, authentick Assurances of the Loyalty of the

People of Scotland.

The Members of this Established Church, who make so great a Majority of the Inhabitants of North Britain, are universally servent in their Zeal for your Majesty's Person and Family. Devoted of old to the best of Causes, Religion and Liberty, the Prospections early fixed their Hearts and Hopes in the House of Hanover, by whose Succession alone Religion and Liberty could have been preserved. The happy Experience of almost Half an Age, during the Reign of your Majesty and your Royal Father, have demonstrated the Wissom of our Ancestors, and confirmed the present Generation in their Loyalty and Leve to your Illustrious House.

Nor is it less, from our certain Knowledge of the present Spirit, than of the ancient Principles of the Church of Scotland, that we can venture to affure your Sacred Majesty, that in no Part of your Dominions, the Zazi of the Subjects may be more fafely relied in : For never was the Affection of this Nation to their Prince so manifest, as at this Jancture, roused by the Approach of Danger, the Hearts of your People, most Gracious Sovereign, are more than ever Your's; and should that Danger come, which may the Providence of God avert, it will be found, Great Sir, that your Government will be supported in this Part of the United Kingdom, by the Zeal and Courage of your most faithful People, who hold nothing to dear as Religion and Liberty, and esteem nothing so glorious as Loyalty to a Prince, by whom Religion and Liberty are held sacred.
