A PROCLAMATION.

HEREAS His Majesty hath signified unto us His Royal Pleasure, That the Parliament of this Kingdom, which now stands prorogued to Tuesday the Twelsth Day of October next, be surther prorogued to the Twenty-first Day of April next; we do therefore publish and declare, That the said Parliament be, and accordingly the said Parliament is, hereby surther prorogued to the Twenty-first Day of April next; whereof the Lords Spiritual and Temporal, and the Commons in this present Parliament, are to take Notice accordingly.

Liston, September 11. On the 31st past, early in the Morning, his most Faithful Majesty's Pleasure was signified to M. de Mondonça, Secretary of State for the Department of the Marine, that three Hours Time were only allowed him to prepare for his Banishment to any Past of the Country he should chuse, at the Distance of Forty Leagues from Court. M. de Mendonça having delivered up the Keys of his Publick Office, proceeded soon after in his Coach, to a Friend's House near Oporto, attended by his Confessor and two Servants, under the Guard of Four Dragoons. A few Hours after the Banishment of M. de Mendonça, a Royal Proclamation was posted up in most of the Publick Parts of this City, promising a Reward of Twenty Thousand Crowns to any one, who should discover the Authors of a Design to take away the Life

of some of the Portuguese Ministers. The late-Administrator of the Bishoprick of Oporto has been ordered to lay down his Employment, and remove to some distant Part of the Country, by way of Punishment, for having, without Orders from Court, taken up young Mr. Pawson, an English Gentleman, on a Religious Account, and for not having immediately obeyed the Royal Order sent him for the Release of that Gentleman, who has since been set at Liberty by the special Direction of his most Faithful Majesty.

Genod, Sept. 11. Yesterday we had one of the most terrible Storms of Wind, Rain, Thunder, and Lightning, that perhaps has happened in this Country in the Memory of Man. Great Damage has been sustained on this Occasion by the Inhabitants all round us, and particularly at Bisagno and Possevera, where

feveral Persons lost their Lives.

Dresden, Sept. 27. Within these sew Days past several Prussian Regiments have marched through this City on their Way to join the main Body of their Army in Bohemia. The Saxon Troops are so effectually blocked up by those of his Prussian Majesty, that scarce any Thing can be conveyed to their Camp without falling into the Hands of the Prussian Hussars. The Count de Malachowski, Great Chancellor of Poland, who arrived here some Days ago from that Kingdom, has obtained the King of Prussia's Leave to wait on his Polish Majesty at the Camp near Pirna.
