Hague, Jan. 5. The usual Summonses are sent out for an Assembly of the States of Holland and Westfrizeland on Wednesday next. They write from Marsailles, that the Chamber of Commerce of that City has fitted out a Bark to cruize against the English; and that Orders are given, by the French King, to equip, at that Port, a Man of War, and a Chebeck, at his Expence, for the like Purpose.

War-Office, Nov. 30, 1756. And whereas several of the said Deserters may have inlisted in other Corps, and be now serving therein, His Majesty is likewise graciously pleased to grant His Pardon to all such Offenders, (not being in actual Custody for the same) and also to declare, It is His Royal Intention, that they shall continue to serve in the Corps in which they now are, without being molested or reclaimed by the Officers of the respective Corps to which they did formerly belong.
