AT the Court at St. James's the 4th Day of February, 1757,

PRESENT, The KING's most Excellent Majesty in Council.

HEREAS by His Majesty's Proclamation, bearing Date the Fourth Day of January last, " For giving Encouragement to Seamen, and 66 Able-bodied Landmen, to enter themselves 66 on Board His Majesty's Ships of War; For granting Rewards for discovering such Sea-men as shall conceal themselves; For par-66 doning fuch Seamen as have deferted, and " shall return into the Service; And also for taking up all Straggling Seamen"—His Majesty was pleased to promise and declare, amongst other Things, That the Bounties of Three Pounds for every Able Seamar, and of Thirty Shillings for every Ordinary Seaman, not above the Age of Fifty, nor under the Age of Twenty Years; and also that the Bounty of Thirty Shillings for every Able-bodied Landman not above the Age of Thirty-five, nor under the Age of Twenty Years, should be paid to every such Seaman and Landman respectively, who should, on or before the Tenth Day of this Instant, voluntarily enter themselves to serve in His Majesty's Royal Navy, in the Manner directed by the faid Proclamation; As likewise that the Rewards of Two Pounds for every Able, and Twenty Shillings for every Ordinary Seaman, fhould be paid to any Purson who should, on or before the said Tenth Day of this Instant, discover any Seaman or Seamen who should secret themselves, so that such Seaman or Seamen should be taken for His Majesty's Service: -And whereas the Time limited for paying the faid Bounties and Rewards is now near expiring, and it being judged expedient for His Majesty's Service, that the same should be continued for some longer Time, His Majesty, with the Advice of His Privy Council, doth therefore Order, and it is hereby accordingly Ordered, That the Time limited by the faid Proclamation for Payment of the Bounties and Rewards aforementioned be prolonged and extended from the faid Tenth Day of this Instant February, to the Tenth Day of March next inclusive; and that the said respective Bounties, and Rewards, be continued to be paid by the Perfons, and at the Times directed by His Majesty's aforesaid Proclamation. of the Black Rod, was fent with a Message from His Majesty to the House of Commons, commanding their Attendance in the House of Peers. The Commons being come thither accordingly, His Majesty was pleased to give the Royal Affent to,

An Act for granting to His Majesty a Sum not exceeding One Million, Fifty Thoujand, and Five Pounds, and Five Shillings, to be raifed by Way of Lottery.

An All to discontinue, for a limited Time, the Duties upon Corn and Flour imported, and also upon such Corn, Grain, Meal, Bread, Biscuit, and Flour, as have been, or shall be, taken from the Enemy, and brought into this Kingdom.

An Act to prohibit, for a limited Time, the

Exportation of Corn, Grain, Meal, Malt, Flour, Bread, Biscuit, Starch, Beef, Pork, Bacon. and other Victual (except Fish, and Roots, and Rice, to be exported to any Part of Europe Southward of Cape Finisterre) from His Majest,'s Colonies and Plantations in America, unless to Great Britain or Ireland, or to fome of the faid Colonies and Plantations; and to permit the Importation of Corn and Flour into Great Britain and Ireland in Neutral Ships; and to allow the Exportation of Wheat, Barley, Oats, Meal, and Flour, from Great Britain to the Isle of Man, for the Use of the Inhabitants there.
