The KING's most Excellent Majesty in Council.

HEREAS the Time limited by His Majesty's Order in Council, of the Fourth of February last, For paying the respective Bounties therein mentioned, to all Able and Ordinary Seamen, and alfo to all Able-bodied Landmen, who should vo-luntarily enter themselves in His Majesty's Royal Navy; and likewise for paying the Rewards to Persons discovering Seamen who should conceal themselves, will expire upon the Tenth Day of this Instant March: And whereas it is judged expedient for His Majesty's Service, That the Bounties and Rewards thereby given, should be continued to be paid for some Time longer; His Majesty doth therefore, by and with the Advice of His Privy Council, hereby Order, That the Bounties of Three Pounds for every Able Seaman, and of Thirty Shillings for every Ordinary Seaman, not above the Age of Fifty, nor under the Age of Twenty Years; and of Thirty Shillings for every Able-bodied Landman, not above the Age of Thirty-five, nor under the Age of Twenty Years, be continued to be paid to such Seaman and Landman respectively, who shall, on or before the Twelfth Day of April next, enter themselves in the Royal Navy, in the Manner directed by His Majesty's Proclamation of the Fourth Day of January last: And likewise, That the Rewards of Two Pounds for every Able, and Twenty Shilings for every Ordinary Seaman, be continued to be paid to any Persons who shall, on sembled on the Affairs of their Department. or before the said Twelfth Day of April next,

ceal themselves, so as such Seaman or Seamen be taken for His Majesty's Service. Whereof all Persons concerned are to take Notice, and govern themselves accordingly.

In the Morning there was several Discharges of our Artillery; at Noon the Members of the Government, the Foreign Ministers, and other Persons of Distinction, went to Court, richly dressed, to compliment her Royal Highness the Princess Governante, and the young Prince Stadtholder, on that Occasion; and the Evening concluded with a Ball, where the appearance was very numerous and extreamly bril-The States of Holland and Westfrize land renewed their Deliberations this Morning and the Deputies of the different Colleges of the Admiralty have been for feveral Days past as-

Bruffels, March 81. We hear from Oftend, that on Monday last some Barrels of Gun Powder took Fire, and blevr up the greatest Part of the Caferns, and about 30 Houses. Upwards of 25 People were killed or wounded by this Accident. Count d'Estrées, one of the new Marshals of France, is to command the French Army upon the Lower Rhine; and M. de Lucé, who was Intendant of Alface, is appointed Intendant of that Army. The Letters from France bring a very melancholy Account of a violent Hurricane that happened on the 22th of September last, at Martinico, by which the greatest Part of their Shipping had been cest away, and all the Habitations and Plantations on the North and Southern Sides. of the Island destroyed, with all their Coffee, Sugars, &c. and the greatest Part of the Provisions that had been got together for the Subfistance of the Inhabitants, who, by this Accident, were reduced to the greatest Want.
