PRESENT,

The KING's moft Excellent Majefty in Council.

HEREAS the Time limited by His Majesty's Order in Council, of the Tenth of May last, For paying the respective Bounties therein mentioned, to all Able and Ordinary Seamen, and alfo to all Able-bodied Landmen, who should voluntarily enter themfelves in His Majesty's Royal Navy; and likewife for paying the Rewards to Perfons difcovering Seamen who fhould conceal themfelves, is near expiring : And whereas it is judged expedient for His Majefty's Service, That the Bounties and Rewards thereby given, should he continued to be paid for fome Time longer ; His Majefty doth therefore, by and with the Advice of His Privy Council, hereby Order, That the Bounties of Three Pounds for every Able Seaman, and of Thirty Shillings for every Ordinary Seaman, not above the Age of Fifty, nor under the Age of Twenty Years; and of Thirty Shillings for every Able-bodied Landman, not above the Age of Thirty-five, nor under the Age of Twenty Years, be continued to be paid to fuch Seamen and Landmen refpectively, who fall, on or before the Thirteenth Day of July next, enter themselves in the Royal Navy, in the Manner directed by His Majefty's Proclamation of the Fourth Day of January laft : And likewife, That the Rewards of Two Pounds for every Able, and Twenty Shillings for every Ordinary Seaman, be continued to be paid to any Perfons who shall, on or before the faid Thirteenth Day of July next, difcover any Seaman or Seamen who fhall conceal themfelves, fo as fuch Seaman or Seamen be taken for His Majesty's Service. Whereof all Perfons concerned are to take Notice, and govern themfelves accordingly.

Conftantinople, May 2. By Letters from Baffora, dated the 30th of Dec. and 8th of Jan. we have Advice from Perfia, that Ifpahan has again changed its Mafter, Azad Khan is once more in Poffeffion of that City, Huffein Khan is withdrawn to Miffendroon, and Carem Khan is Mafter of Schiras. Every City or Town of that Kingdom has an oppreffive Mafter, and every petty Governor acts like an abfolute Monarch.

Madrid, May 23. Their Catholick Majefties continue at their Royal Seat of Aranjuez in perfect Health. Letters from Cadiz have brought Advice of the Arrival in that Bay on the 7th Inftant, of one of the Caraças Company's Ships named the San Sebaftian, which failed from la Guayra on the 6th of January ; her Cargoe confifting in 6,334 Dollars, 6,095 Fanegas of Cacao, 800 Hides, and other Effects.

Turin, May 25. On Saturday last the 21st, his Sardinian Majesty and the rest of the Royal Family removed from hence to the Venerie.

Family removed from hence to the Venerie. Drefden, May 29. The Pruffian Generals here, Baron Wylich and M. Bornflett, have received an Account from the Camp before Prague, that they began to batter the City on the 24th, but that they had thrown no Bombs into it on the 25th. The Auftrians have Provision enough, but begin to want Forage, to that their Horfes must foon feed upon Mesi-On the 24th they attempted to fally out with a Body of Troops, confifting of upwards of 10,000 Men, but were happily repulled and driven back ; on which Occafion Prince Ferdinand, the King of Pruffia's youngest Brother, had a Horfe killed under him, and was himfelf flightly The Duke of Bevern, with the wounded. Army of Observation, has pitched his Camp near Kolin; and, if he offers to advance, the Auftrians, under General Daun, withdraw. As it was impoffible to carry the large Magazine the Pruffians took at Pillen to their own Camp, which was then at the Diffance of 12 German Miles, they entirely burnt and deftroyed it. The lecond Transport of Austrian Prisoners, brought hither

hither on the 21ft Inftant, confifted of ro68 Men, of which about 400 engaged in the Pruffian Service. Some Days after, feveral Auftrian Prifoners, not dangeroufly wounded, were alfo brought here upon the Elbe at Night; fo that the Number of Prifoners now in Town, including those that were taken at the Action of Reichenberg, and in other Skirmiss, amounts to upwards of 3000. The Number of the Pruffians wounded in the Battle near Prague, and likewife brought hither, amounts to about 1800.

Cologne, June 2. The 26th the Camp of Ruremonde marched to Wefel. The 28th the Firft Division of the Camp of Horfe at Neuss followed. The 29th the Second Division marched, and the Regiment of Royal Rouffillon brought up the Rear Guard. Yefterday the Regiment of Naffau Larbruck paffed here, making the Rear of Marshal d'Etrées Army.

Bruffels, June 3. We learn by Letters from France, that Marechal d'Etrécs's Army is to be reinforced by a Body of fix thousand Men, which were to begin their March as Yesterday from Lille, and other neighbouring Garrifons.

Bruffels, June 7. All the Regiments that remained in the interior Parts of France, and many of those that are in Britanny and Normandy, have received Orders to march directly into Alface, where they are to form an Army of about 40,000 Men, to be commanded by the Prince de Soubize, who is to proceed with all possible Speed to the Afisstance of the Empress Queen. Our last Letters from Nuremberg mention the Arrival of a Body of Prussians before the Gates of that Town, and that their Van Guard was advanced as far as Forcheim in the Bishoprick of Bamberg.

Whitehall, June 10.

The King has been pleafed to conftitute and appoint his Grace Augustus Henry Duke of Grafton, to be Lord Lieutenant and Custos Rotulorum of the County of Suffolk.

Admiralty-Offics, June 11.

The Lords of the Admiralty have received an Account, That on the 30th of laft Month, between One and Two in the Morning, His Majefty's Ships the Eagle and Medway, being about 48 D. North, and 2 D. Weft Longitude from the Lizard, gave Chace to a large Ship under French Colours, flanding to the Eaftward; and, coming up with her about Four, they attacked her with a very brifk Fire for about three Quarters of an Hour, when the ftruck. She proves to be the Duke d'Aquitaine, commanded by the Sieur d'Efquelen, of about 1500 Tons, mounts 50 Guns upon two Decks, all 18 Pounders; had on Board 493 Men, and

belonged to the French East India Company. She loft in the Engagement about 50 killed, and a great many wounded, 22 very dangeroufly; and all her Mass, Sails and Rigging broke away and fell over board before Night. She came from Lifbon, where she landed, fome Months ago, a very rich Cargo from the East-Indies; and, when taken, was only equipped for War, with Orders to cruize for 15 Days, ten or twelve Leagues off the Rock of Lifbon, in order to intercept the Mermaid, one of our 20 Gun Ships, which was on the Point of failing from Lifbon with a Convoy. During her Cruize, the took an English Brigg from Cadiz, bound to Cork, which was ransomed for 2001. The Eagle had 10 Men killed, and 32 wounded in the Engagement with the Duke d'Aquitaine; but, as the Medway's Fire could only be employed in raking her, the had only ten Men wounded.

General Post-Office, December 20, 1756. W Hereas the Pott Boy carrying the Worceffer Mail from hence to Southall, was, on Sunday Morning the 12th instant, between the Hours of Four and Five of the Clock, attacked and robbed on the Road near Shepherds Bush, by a Footpad, who laid hold of the Bridle of the Post Boy's Horfe, and bid him difmount, and afterwards led the faid Horfe into a Lane near the great Road, and from thence into a Field adjoining, and there near to a Hay Rick took off the Mail from the Horse, opened it, and afterwards the Letters contained in the following Bags, viz: Campden, Chipping-Norton, Everscham, Burford, Weitney, Woodstock, Oxford, Ludlow, Bremyard, Worcefter, Thame, Soutball, Gerrard's Cross, Uxbridge, Higb Wickbam, and Baconsfield.

Note, The following Bags in the faid Mail were unopened, viz. Shipfion, Enflon, and Tenbury; and the faid Foot-pad, after detaining the Poft-Boy upwards of two Hours, mounted the faid Poft-Boy's Horfe, and rode off with the fame towards Acton, which Horfe was found the fame Morning about Eight o'Clock near the Turnpike at Hyde Park Corner.

The Perfon who committed this Robbery has fince put off feveral of the Bank Notes, and indorfed the Name of James Willon thereon, to feveral Innkeepers on the Road to Caxton, by travelling Post in Post Chaifes with four Horses, by the Way of Barnet, Hatfield, Stevenage, and Bugden, and returning from Caxton by Way of Royfton, Ware, and Enfield to London, where he was fet down at Gray's Inn Gate in Gray's Inn Lane, about Twelve o'Clock at Noon, on Tuefday the 14th inftant. This Perfon is defcribed to be rather above the Middle-fize, of a brown Complexion, very thin Vifage and Body, with an effeminate Voice; he had on a Silver-laced Hat with a Cockade, blue Surtout Coat with Brafs Buttons, a dark brown close-bodied Coat underneath, a Pair of Breeches with Silver Gartering at the Knees, his Wig or Hair, or both mixed was a dark brown, and tied behind with a Ribbon.

This is therefore to give Notice, That whoever ihall apprehend and convict, or cause to be apprehended and convicted, the Person who committed this Robbery, will be entitled to a Reward of Two Hundred

ON Friday the laft Day of December 1756, on furficion of the Messles, was bled to five Ounces, and no

on infiction of the Meanles, was near to incorolates, and no Signs of Inflammation appeared. On Saturday the 1ft of January 1757, about Five o'Clock in the Afternoon, the Meanles appeared. On Sunday the 2d they appeared full on his Face and Body.

On Monday the 3d they began to decline, and a Hoarfenefs,

cough, and a Fever came on. On Tue(day the 4th, in the Morning, they had quite difapeared, without leaving the least Rednefs, and the bad Symptoms perior, without rearing the real request, and the old symptoms increafed. He was then bled to five Ounces, the Blood flewing no Signs of Inflammation ; and about Three in the Afternoon, the Apothecary, who attended him, found more violent Symp-toms, fuch as increafed Heat, wheezing Cough; universal lan-toms, fuch as increafed Heat, wheezing Cough; universal languor, and fluttering Polle, on which he immediately applied Blifters to the Back and Arms, and Dr. Baker, Phylician at Stamford, was fent for, who arrived about Eight o'Clock on Tuefday Night, and found the Fever very high, and the Cough

Two Billigers were then applied to the Legs, and as the Cafe became doubt(u) (notwithfkanding Dr. Baker had with great Judgment preferibed every Thing that feemed proper in his Cafe) the Duke defined that Dr. Jamet's Powder might be given, and at the Same Time requested Dr. Balter's Attendance during the Opera-Same Time requerted Dr. Baker's Attendance during the Opera-tion, to which he readily confented, and gave the greateft Satis-faction by his particular Care and Attention: Accordingly, at Five in the Afternoon, four Grains of Dr. James's Powders were given, which, in Thirty-nine Minutes, vomited him brifkly for an Hour, and gave him two Stools; at Nine o'Clock three Grains more were given, in twenty Minutes he had one gentle Puke, and went to fleep. The Pulfe growing quicker in four Hours afterwards, which was One in the Morning, he took four Grains more, which immediately came up; he then vomit-ed twice in an eafy Manner, had two Stools, went to fleep, but continued vomiting and purging gently at diffant Intervals, 'cill Seven o'Clock Friday Morning. On Friday Morning, the 7th, about Three o'Clock, the Fe-ver left him, and he continued free from it 'till Nine at Night,
