And as a further Encouragement for the apprehending and profecuting of the said Offender or Offenders, their Lordships do also hereby promise, that every Person who shall be inticled to the Whole, or any Part of such Reward of One Hundred Pounds as aforesaid, shall also, upon Request, have a Protection from being impressed into His Majesty's Sea Service, for the Space of one Year from the Date of such Protection.
