AT the Court at St. James's, the 24th Day of February 1758,

PRESENT,

The KING's most Excellent Majesty in Council.

HEREAS the Time limited by His Majesty's Order in Council, of the Thirteenth of January last, For paying the respective Bounties therein mentioned, to all Able and Ordinary Seamen, and also to all Able-bodied Landmen, who should voluntarily enter themselves in His Majesty's Royal Navy; and likewise for paying the Rewards to Persons discovering Seamen who should conceal themselves, will expire upon the Twenty Eighth Day of this Instant February: And whereas it is judged expedient for His Majesty's Service, That the Bounties and Rewards thereby given, should be continued to be paid for some Time longer; His Majesty doth therefore, by and with the Advice of His Privy Council, hereby Order, That the Bounties of Three Pounds for every Able Seaman, and of Thirty Shillings for every Ordinary Seaman, not above the Age of Fifty, nor under the Age of Twenty Years; and of Thirty Shillings for every Able-bodied Landman, not above the Age of Thirty-five, nor under the Age of Twenty Years, be continued to be paid to fuch Seamen and Landmen respectively, who shall, on or before the Tenth Day of April next, enter themselves in the Royal Navy, in the Manner directed by His Majesty's Proclamation of the Fourth Day of January 1757: And likewise, That the Rewards of Two Pounds for every Able, and Twenty Shillings for every Ordinary Seaman, be continued to be paid to any Persons who shall, on or before the faid Tenth Day of April next, discover any Seaman or Seamen who shall conceal themselves, so as such Seaman or Seamen be taken for His Majesty's Service. all Persons concerned are to take Notice, and govern themselves accordingly.

Rome, Feb. 11. On the 30th past died, after a lingering Illness, Cardinal Mattei, by which there is thirteen vacant Hats in the College of Cardinals. The Pope has given to M. Mattei, the late Cardinal's Brother, and to the Duke Mattei, jun. his Nephew, the two considerable Benefices which the Cardinal enjoyed.

Florence, Feb. 18. On the 2d Instant anchored at Leghorn His Britannick Majesty's Ship the Syren, with a Convoy of seven Merchant Men with Fish and other Goods for that Market. On the 10th arrived here from Leghorn, a Battalion drasted out of the first Tuscan Regiment to join the Corps designed for Germany. On the 11th sour Companies out of the second Regiment began their March from hence to Leghorn, to be incorporated in that Garrison; and, on the 17th a Detachment of the third Regiment arrived here from thence to remain in Garrison at Florence, together with a Party of the new raised Militia. Last Week, agreeable to the Emperor's Directions, a Promotion of Officers was made here, to fill up the vacant Posts in the Body of Tuscan Troops, consisting of 3,200 Men, that are to march into Germany. They are to proceed in three Divisions, the first of which will begin its March on the
