AT the Court at Kensington, the 15th Day of September, 1758,

PRESENT,

The KING's most Excellent Majesty in Council.

WHEREAS the Time limited by His Majesty's Order in Council, of the Twenty Eighth of July last, For paying the respective Bounties therein mentioned, to all Able and Ordinary Seamen, and also to all Able-bodied Landmen, who should voluntarily enter them-selves in His Majesty's Royal Navy; and likewife for paying the Rewards to Persons discovering Seamen who should conceal themselves, will expire upon the Thirtieth Day of this Instant September; And whereas it is judged expedient for His Majesty's Service, That the Bounties and Rewards thereby given, should be continued to be paid for some Time longer; — His Majesty doth therefore, by and with the Advice of His Privy Council, hereby Order, That the Bounties of Three Pounds for every Able Seaman, and of Thirty Shillings for every Ordinary Seaman, not above the Age of Fifty, nor under the Age of Twenty Years; and cf Thirty Shillings for every Able-bodied Land man, not above the Age of Thirty-five, no. under the Age of Twenty Years, be continued to be paid to such Seamen and Landmen respectively, who shall, on or before the Eighteenth Day of November next, enter themselves in the Royal Navy, in the Manner directed by His Majesty's Proclamation of the Fourth Day of January 1757: And likewise, That the Rewards of Two Pounds for every Able, and Twenty Shillings for every Ordinary Seaman, be continued to be paid to any Persons who shall, on or before the faid Eighteenth Day of November next, discover any Seaman or Seamen who shall conceal themselves, so as such Seaman or Seamen be taken for His Majesty's Service. Whereof all Persons concerned are to take Notice, and govern themselves accordingly.

The following Address of the Gentlemen Freeholders of the County of Renfrew, having been transmitted by William Mure, Esq; their Representative in Parliament, to the Right Hon. Mr. Secretary Pitt, has by him been presented to His Majesty: Which Address His Majesty was pleased to receive very graciously.

To the King's most Excellent Majesty, The humble Address of the Gentlemen Freeholders of the County of Renfrew, affembled at their Michaelmas Head-Court.

WE your Majesty's most dutiful and loyal Subjects, the Gentlemen Freeholders of the County of Renfrew, beg Leave to congratulate your Majesty on the late Successful Events of the War; which have so happily changed, not only the Condition of this Nation, but the State of Europe. These great and important Events we attribute, acknowledging at the same Time the Hand of Heaven, to the Vigour and Magnanimity of your Majesty's Councils, giving Birth to Enterprizes, which, in every Part of the World, have renewed the Lustre, and advanced the Glory of the British Arms.

With the most grateful Jos we behold the Prosperity of your Reign. The Commerce of these Realms flourishes as in the most profound Peace, whilst the Trade of the Enemy languishes in Ruin; and their Ships of War, unable to protect their distant Settlements and Fortresses, nay to defend the Coast and Towns of France, appear, only to be taken or destroyed.

Permit us, gracious Sir, to observe that even those Attempts which have been unsuccessful, have not been inglorious; as the fignal Bravery displayed by your Troops, when opprest by the Number or Situation of their Foes, affords the most encouraging Hope of Victory, in Circum-ftances more favourable to their Valour. We have the Pleasure of knowing, that we now express the sincere and universal Sentiments of your Majesty's Subjects in this Part of the Kingdom; and we rejoice at the Revival in the Minds of all Men, of that just Confidence in the national Spirit and Strength, so natural to a Free People,

when conscious of being well govern'd. May this well placed Trust in the wise Councils and Administration of their Sovereign, continue to animate your People, till the Efforts of your Majesty's Arms compel the Enemy to sue for Peace; and submit to such Terms as may establish the just Rights, and secure the Tranquillity of Britain.

Florence, Sept. 30. A Shebeck, belonging to Rear Admiral Broderick's Fleet, was, on the 22d Instant, at Night, in a violent Storm, drove on Shore on the Rock called the Melora, and there wrecked; but the Crew, confishing of 80 Men, were all faved.

Admiralty-Office, August 8, 1758. Y Lords Commissioners of the Admiralty, having received authentick Information, that a Dutch Ship named the City of Rotterdam, whereof Warner Pieterson was Master, laden with different Kinds of Merchandize; and also with the Baggage, confishing of very valuable Effects, of the Marquis de Pignatellij, Minister from the Court of Spain to the Court of Denmark, and having likewise on Board his Household Steward, Confectioner, and Cook, and also the Coachman of the Danish Ambassador residing at Paris; and being bound from Rouen to Rotterdam, was, in the Course of her said Voyage, on the 30th Day of June last, boarded three several Times, by the Crews, or Parts of the Crews, of three different English Ships or Vessels, pretending to be Privateers; and that some of the Crew of one of the faid English Vessels, (which had two Masts) went on Board the faid Dutch Ship, about Six o'Clock in the Morning of the faid Day, and after fearching her, took and unlawfully carried away with them two Oars, one Boat Hook, and a Dutch Cheese: And that about Nine o'Clock the same Morning, Ten of the Crew of another of the faid English Vessels, (being a Cutter, or one Mast Sloop) went armed with Cutlasses, Pistols and Hatchets, on Board the said Dutch Ship, and after examining the Papers, they by Violence forced open the Hatchways, and went into the faid Ship's Hold, and there broke open two Trunks belonging to the faid Marquis de Pignatellij, wherein were rich Cloths, and laced Liveries, which they took and carried away, to their own Ship: And that about Two o'Clock in the Afternoon of the same Day, the Commander, who was a young Man, and wore a Gold laced Hat, together with some of the Crew of another of the said English Vessels, (being a Cutter, or fingle Mast Sloop, mounted with four Guns) came armed as aforesaid, on Board the said Dutch Ship, and after examining the Ship's Papers, and those of the Passengers, pretended the same were False and Counterfeit, and then went into the said Ship's Hold, and began to plunder the Effects there; and that whilst they were so doing, the Crew of the

aforesaid English Vessel, which Boarded the said Dutch Ship about Nine o'Clock that Morning, returned again, and joined those who were then in the said Ship's Hold, and that then both the said Crews in Conjunction, committed very great Outrages, by breaking open all the said Marquis de Pignatellij's Cases, and Trunks, and taking and carrying away all the valuable Effects, which were in fix of the said Cases and Trunks, and destroying or damaging the Rest of those Effects; and then falling upon his the said Minister's Officers, and beating them in a very cruel and shameful Manner, and stripping them of their Cloths, and carrying the same off, together with their Letters of Credit, and a Bill of Exchange.

Their Lordships therefore, in order to discover and bring to Justice, the Persons guilty of the Piratical Offences above mentioned, are pleased to promise a Reward of FIVE HUNDRED POUNDS, without any Deduction, unto, or amongst such Person or Persons as shall, within three Months from this Time, discover any two or more of the Offenders concerned in committing the Piracies abovementioned, so as such Offenders shall be apprehended and duly convicted thereof: Which Reward shall be paid by Samuel Seddon, Esq. Solicitor of the Admiralty, immediately after the Conviction of such Offenders.

And as a further Encouragement, any of the faid Offenders, (other than, and except, the respective Commander or Commanders of any of the abovementioned English Ships or Vessels) who shall discover and prosecute to Conviction, any two or more of the said Offenders, shall be likewise entitled to His Majesty's most Gracious Pardon.

And as a further Encouragement, any of the faid Offenders, (other than and except the respective Commander or Commanders of any such Piratical Ships or Vessels) who shall discover, and prosecute to Conviction, any two or more of the said Offenders, shall likewise be intitled to His Majesty's most Gracious Pardon.
