And in regard the Committing of such Offences as aforefaid are greatly encouraged by divers Per-fens as Accessaries thereto, who knowingly assist, maintain, councel, or advise the Committing of such Acts of Piracy, and also by Perfons who receive Goods so piratically taken, and entertain and conceal Offenders, knowing them to have committed Such Robberies

Their Lordships therefore, in order to detect or bring to Justice the Persons guilty of such last mentioned Offences, are pleased to promise a Reward of FIVE HUNDRED POUNDS, unto or amongst such Person or Persons as shall, within Three Months from this Time, discover any one or more of the Offenders guilty of any such Offences last mentioned, so as such Offender or Offenders shall be apprehended and duly convicted thereof. Which faid respective Rewards before mentioned, shall be paid, clear of all Deductions whatfoever, by Samuel Seddon, Efq; Solicitor of the Admiralty, immediately after the Conviction of such Offenders.

And as a further Encouragement, any of the faid Offenders, fother than and except the respective Commander or Commanders of any fuch Piratical Ships or Vessels) who shall discover any one or more of the faid Offenders, shall, on the Conviction of such Of-

fender or Offenders so discovered, be intitled to His Majesty's most Gracious Pardon.

And their Lordships do also promise to grant, upon Request, to every Person, being a Seaman, (who by making any fuch Discovery or Discoveries, as aforefaid, shall be insitted to either to the Whole, or to any Part or Parts of any of the above-mentioned Rewards) an absolute Protection, to prevent his being impressed into His Majesty's Sea Service, during this present War with France.
